## **Transaction Summary**

The transaction closed on Dec 12 2019 and matures in Sep 2033. The pool's current aggregate principal balance is \$1148.5 million compared to \$1152.3 million at close.

The largest loan of the pool (6.5%) is secured by Century Plaza Towers - Pooled located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included Bank of America (6.23%) and Manatt Phelps (4.85%). The second largest loan of the pool (5.4%) is secured by 180 Water - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Citibank (25.38%) and 180 Water Donuts LLC (5.45%). The third largest loan of the pool (11.1%) is secured by 180 Water - Non-Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included Citibank (25.38%) and 180 Water Donuts LLC (5.45%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.53% and 13 months as of 12/15/2020, respectively. There are a total of 44 loans and 67 properties in the portfolio. The appraisal LTV was approximately 57.3% compared to the Original loan to value (LTV), which was approximately 57.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.97x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 96%.





## Occupancy Distribution (%)




## Local Distribution




#### NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 13% with a weighted average NOI debt yield of 8.7%. NOI debt yield ranged from 2% to 13%. There were 1 assets (3% of total balance) with NOI debt yield between 2% and 4%, 4 assets (16% of total balance) with NOI debt yield between 4% and 6%, 13 assets (16% of total balance) with NOI debt yield between 6% and 8%, 13 assets (32% of total balance) with NOI debt yield between 8% and 10%, 8 assets (20% of total balance) with NOI debt yield between 10% and 12% and 5 assets (13% of total balance) with NOI debt yield between 12% and 14%.

There were 33 assets (60.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (2.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 3 assets (17.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (12.8% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (6.7% of total balance) with NCF DSCR between 2.5x and 3.0x. 



DSCRs ranged from 0.0x to 3.5x.There are 33 assets (60.7% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.7% of total balance) with DSCR between 1.0x and 1.5x, 3 assets (17.1% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (12.8% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (5.4% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.0x.

There are 4 assets (23.9% of total balance) that have maturity dates between 2024/7 and 2024/12, 2 assets (5.2% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (1.5% of total balance) that have maturity dates between 2029/1 and 2029/6, 36 assets (66.5% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (2.8% of total balance) that have maturity dates between 2033/7 and 2033/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
