Transaction Summary

The transaction closed on Dec 22 2016 and matures in Nov 2036. The pool's current aggregate principal balance is \$588.4 million compared to \$607.3 million at close.

The largest loan of the pool (10.2%) is secured by Novo Nordisk located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 78%. The largest tenant was Novo Nordisk, Inc. (77.97%). The second largest loan of the pool (10.2%) is secured by Rentar Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included City of New York (32.93%) and Amazon.com (19.06%). The third largest loan of the pool (9.4%) is secured by Gurnee Mills located in Lake County-Kenosha County, IL-WI metropolitan area. Occupancy at the subject was 79%. The major tenants included Bass Pro Shops (8.15%) and Macy's (7.72%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.38% and 51 months as of 12/15/2020, respectively. There are a total of 33 loans and 54 properties in the portfolio. The appraisal LTV was approximately 60.2% compared to the Original loan to value (LTV), which was approximately 59.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.






Local Distribution





Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from 4% to 21%. There were 1 assets (0% of total balance) with NOI debt yield between 4% and 6%, 2 assets (11% of total balance) with NOI debt yield between 6% and 8%, 16 assets (57% of total balance) with NOI debt yield between 8% and 10%, 5 assets (18% of total balance) with NOI debt yield between 10% and 12%, 1 assets (2% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 3 assets (6% of total balance) with NOI debt yield between 18% and 20%, 2 assets (2% of total balance) with NOI debt yield between 20% and 22%

There were 1 assets (0.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (35.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 6 assets (18.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (31.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (13.4% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 0.5x to 4.0x.There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (26.7% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (25.1% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (31.8% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (4.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (10.2% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.1% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
