## **Transaction Summary**

The transaction closed on Mar 20 2015 and matures in Mar 2025. The pool's current aggregate principal balance is \$1086.4 million compared to \$1144.5 million at close.

The largest loan of the pool (10.1%) is secured by Soho-Tribeca Grand Hotel Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 83%. The second largest loan of the pool (9.2%) is secured by 500 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included W.W. Norton & Co. (3.28%) and Kleinberg Kaplan Wolff & Coh (2.80%). The third largest loan of the pool (7.3%) is secured by Courtyard Midtown East located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.28% and 72 months as of 12/15/2020, respectively. There are a total of 74 loans and 88 properties in the portfolio. The appraisal LTV was approximately 65.3% compared to the Original loan to value (LTV), which was approximately 60.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.






#### Local Distribution





Most recent net operating income debt yield ranged from 2% to 25% with a weighted average NOI debt yield of 11.0%. NOI debt yield ranged from 2% to 25%. There were 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 5 assets (13% of total balance) with NOI debt yield between 6% and 8%, 14 assets (32% of total balance) with NOI debt yield between 8% and 10%, 14 assets (26% of total balance) with NOI debt yield between 10% and 12%, 18 assets (16% of total balance) with NOI debt yield between 12% and 14%, 10 assets (5% of total balance) with NOI debt yield between 14% and 16%, 3 assets (2% of total balance) with NOI debt yield between 16% and 18%, 4 assets (2% of total balance) with NOI debt yield between 18% and 20%, 4 assets (2% of total balance) with NOI debt yield between 22% and 24%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%

There were 1 assets (0.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (3.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (17.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 31 assets (46.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 15 assets (12.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (17.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (1.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with NCF DSCR between 3.5x and 4.0x. 



# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
