Transaction Summary

The transaction closed on Mar 20 2015 and matures in Mar 2025. The pool's current aggregate principal balance is \$1086.4 million compared to \$1144.5 million at close.

The largest loan of the pool (10.1%) is secured by Soho-Tribeca Grand Hotel Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 83%. The second largest loan of the pool (9.2%) is secured by 500 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included W.W. Norton & Co. (3.28%) and Kleinberg Kaplan Wolff & Coh (2.80%). The third largest loan of the pool (7.3%) is secured by Courtyard Midtown East located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.28% and 72 months as of 12/15/2020, respectively. There are a total of 74 loans and 88 properties in the portfolio. The appraisal LTV was approximately 65.3% compared to the Original loan to value (LTV), which was approximately 60.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

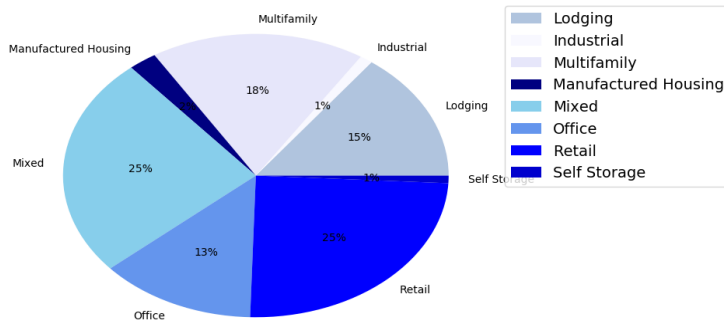

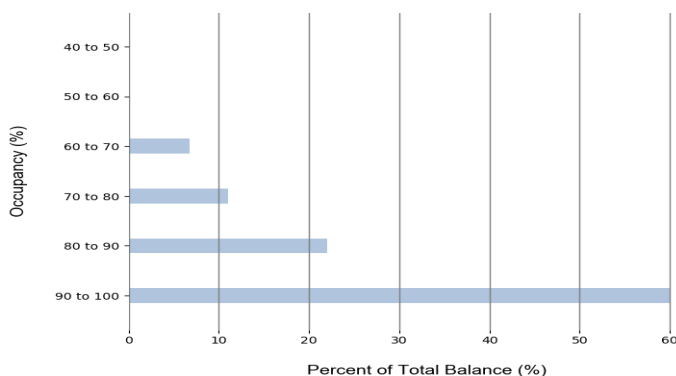

Occupancy Distribution (%)

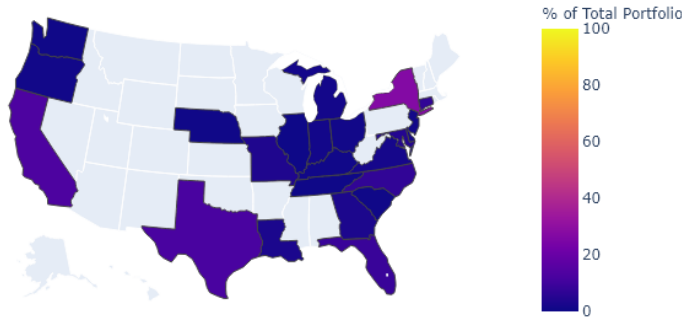

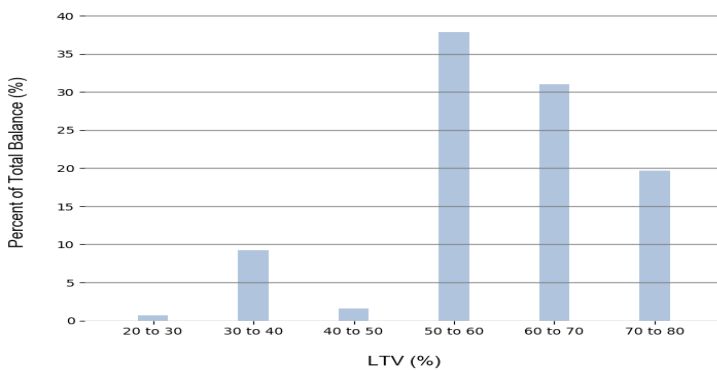
Local Distribution



Among assets in the portfolio, there are 4 properties (27% of total balance) located in New York, 18 properties (13% of total balance) in California, 14 properties (12% of total balance) in Texas, 18 properties (9% of total balance) in Florida, 1 property (7% of total balance) in Connecticut, 13 properties (7% of total balance) in North Carolina, 2 properties (4% of total balance) in Maryland and 2 properties (3% of total balance) in Missouri. 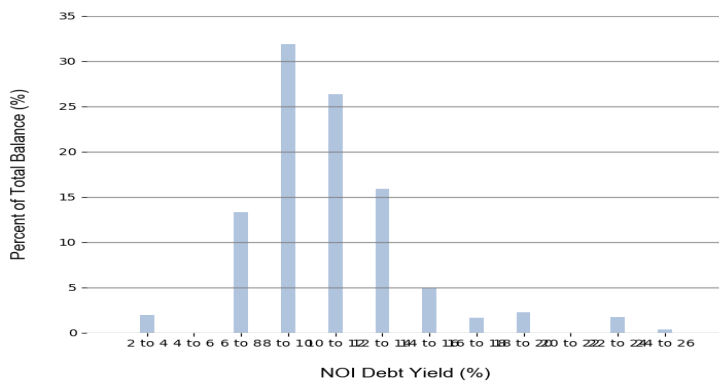

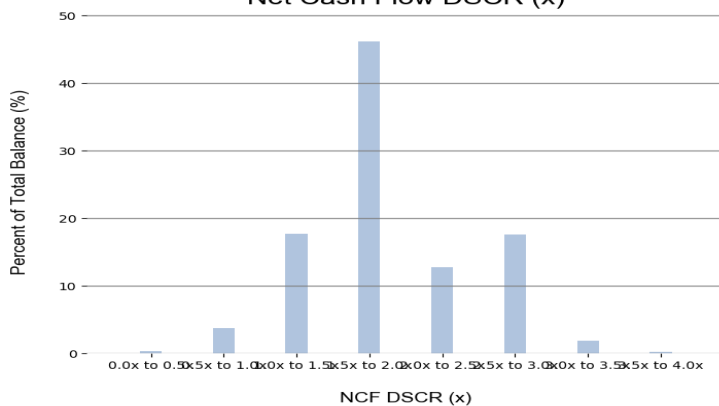
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

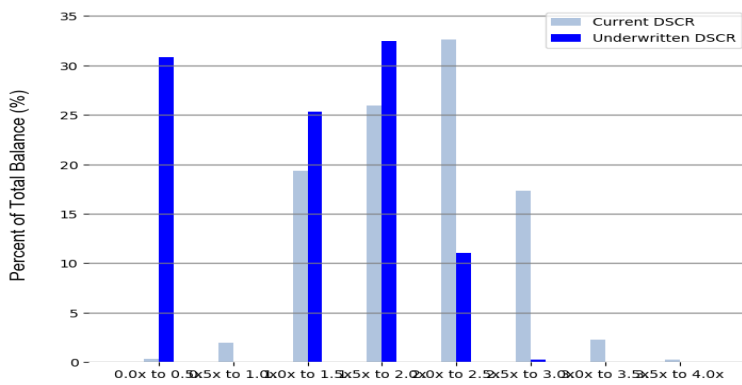

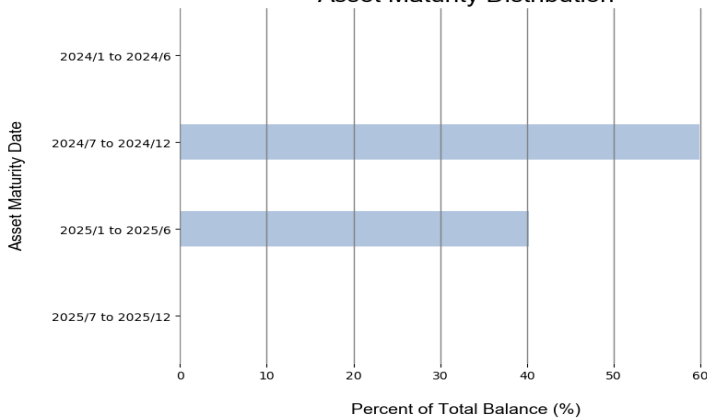
DSCR Distribution (x)

There are 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.0% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (19.3% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (25.9% of total balance) with DSCR between 1.5x and 2.0x, 22 assets (32.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (17.3% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (2.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
