Transaction Summary

The transaction closed on May 20 2015 and matures in May 2045. The pool's current aggregate principal balance is \$1255.2 million compared to \$1339.5 million at close.

The largest loan of the pool (7.6%) is secured by Westfield Wheaton located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 94%. The major tenants included Target (13.81%) and JC Penney (13.26%). The second largest loan of the pool (7.2%) is secured by 9200 & 9220 Sunset located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included S&F Management Company (8.35%) and SPOTIFY (6.37%). The third largest loan of the pool (5.2%) is secured by Soho-Tribeca Grand Hotel Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 79%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.20% and 69 months as of 12/15/2020, respectively. There are a total of 110 loans and 149 properties in the portfolio. The appraisal LTV was approximately 65.2% compared to the Original loan to value (LTV), which was approximately 66.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from 2% to 23%. There were 2 assets (4% of total balance) with NOI debt yield between 2% and 4%, 2 assets (1% of total balance) with NOI debt yield between 4% and 6%, 11 assets (14% of total balance) with NOI debt yield between 6% and 8%, 20 assets (21% of total balance) with NOI debt yield between 8% and 10%, 22 assets (26% of total balance) with NOI debt yield between 10% and 12%, 23 assets (14% of total balance) with NOI debt yield between 12% and 14%, 16 assets (10% of total balance) with NOI debt yield between 14% and 16%, 7 assets (6% of total balance) with NOI debt yield between 16% and 18%, 3 assets (3% of total balance) with NOI debt yield between 18% and 20%, 2 assets (0% of total balance) with NOI debt yield between 20% and 22% and 2 assets (0% of total balance) with NOI debt yield between 22% and 24%.

There were 3 assets (4.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 6 assets (2.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 26 assets (23.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 42 assets (32.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 17 assets (21.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (11.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (1.1% of total balance) with NCF DSCR between 3.5x and 4.0x. 



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
