Transaction Summary

The transaction closed on Aug 18 2015 and matures in Apr 2040. The pool's current aggregate principal balance is \$1214.1 million compared to \$1279.4 million at close.

The largest loan of the pool (9.4%) is secured by Charles River Plaza North located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The largest tenant was General Hospital corporation (100.00%). The second largest loan of the pool (8.2%) is secured by The Mall of New Hampshire located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Best Buy (10.54%) and Old Navy (4.68%). The third largest loan of the pool (8.0%) is secured by Westfield Wheaton located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 94%. The major tenants included Target (16.45%) and JC Penney (15.79%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.39% and 66 months as of 12/15/2020, respectively. There are a total of 84 loans and 114 properties in the portfolio. The appraisal LTV was approximately 63.5% compared to the Original loan to value (LTV), which was approximately 62.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, 1.81% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration





Occupancy Distribution (%)





Among assets in the portfolio, there are 18 properties (17% of total balance) located in California, 1 property (9% of total balance) in Massachusetts, 11 properties (9% of total balance) in Texas, 2 properties (9% of total balance) in Maryland, 1 property (8% of total balance) in New Hampshire, 6 properties (8% of total balance) in New York, 9 properties (7% of total balance) in Florida, 4 properties (5% of total balance) in Arizona and 1 property (3% of total balance) in Connecticut. Other properties are located in the state of Connecticut, New Jersey, Georgia, Illinois, Alabama, Ohio, Pennsylvania, Michigan, North Carolina, Wisconsin, Mississippi, Tennessee, Nevada, Oklahoma, Louisiana, Arkansas, Virginia, Kansas, South Carolina, North Dakota and Colorado.





Most recent net operating income debt yield





EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
