Transaction Summary

The transaction closed on Sep 29 2017 and matures in Sep 2037. The pool's current aggregate principal balance is \$2886.9 million compared to \$2916.1 million at close.

The largest loan of the pool (2.8%) is secured by Park Center Phase I located in metropolitan area. Occupancy at the subject was 100%. The major tenants included State Farm Insurance Company (96.42%) and Del Frisco's Double Eagle Stea (1.71%). The second largest loan of the pool (2.3%) is secured by Westin Building Exchange located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 98%. The major tenants included WBX Colocation (19.14%) and Sprint Communications Co. LP (2.93%). The third largest loan of the pool (7.8%) is secured by Two Independence Square located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included Nasa (98.57%) and BRIDGE END FOODS (1.20%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.97% and 57 months as of 03/15/2022, respectively. There are a total of 31 loans and 67 properties in the portfolio. The appraisal LTV was approximately 56.6% compared to the Original loan to value (LTV), which was approximately 55.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.20x. As of 03/15/2022, 25.69% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)





Local Distribution






Among assets in the portfolio, there are 3 properties (55% of total balance) located in New York, 2 properties (9% of total balance) in Washington DC, 3 properties (7% of total balance) in Tennessee, 3 properties (7% of total balance) in Illinois, 2 properties (6% of total balance) in New Jersey and 4 properties (4% of total balance) in California. 



There were 2 assets (2.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (10.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (14.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 4 assets (1.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (55.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (7.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (3.6% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (1.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.3% of total balance) with NCF DSCR between 9.0x and 9.5x. 
DSCR (Current / Underwritten)



DSCRs ranged from 0.0x to 9.5x. There are 2 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (10.6% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (9.0% of total balance) with DSCR between 1.0x and 1.5x, 8 assets (6.7% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (55.4% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (8.5% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.6% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.2% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.3% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.3% of total balance) with DSCR between 9.0x and 9.5x. There are 1 assets (19.0% of total balance) that have maturity dates between 2022/1 and 2022/6, 5 assets (722.7% of total balance) that have maturity dates between 2022/7 and 2022/12, 2 assets (98.8% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (2.7% of total balance) that have maturity dates between 2026/7 and 2026/12, 8 assets (1732.7% of total balance) that have maturity dates between 2027/1 and 2027/6, 13 assets (288.2% of total balance) that have maturity dates between 2027/7 and 2027/12 and 1 assets (22.8% of total balance) that have maturity dates between 2037/7 and 2037/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
