Transaction Summary

The transaction closed on Apr 18 2018 and matures in Jan 2038. The pool's current aggregate principal balance is \$1722.4 million compared to \$1739.2 million at close.

The largest loan of the pool (3.7%) is secured by GNL Portfolio located in Newark, NJ-PA-15.17% Nassau County-Suffolk County, NY-10.21% Detroit-Dearborn-Livonia, MI-7.89% metropolitan area. Occupancy at the subject was 100%. The major tenants included Lippert Cmpnts. (20.57%) and Nissan (17.63%). The second largest loan of the pool (3.4%) is secured by Hilton Clearwater Beach Resort & Spa located in metropolitan area. Occupancy at the subject was 77%. The third largest loan of the pool (20.9%) is secured by One State Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 88%. The major tenants included SSTATE OF NEW YORK OGS (31.36%) and AMBAC ASSURANCE CORP. (12.25%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.48% and 34 months as of 10/15/2020, respectively. There are a total of 56 loans and 118 properties in the portfolio. The appraisal LTV was approximately 414.6% compared to the Original loan to value (LTV), which was approximately 58.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.56x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

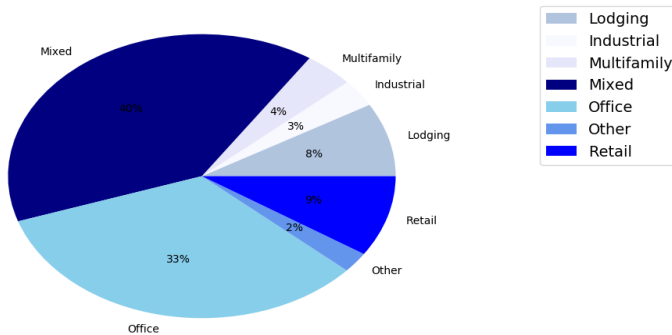

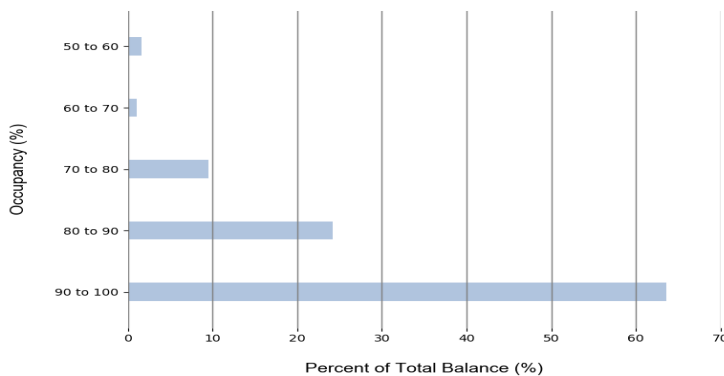

Occupancy Distribution (%)

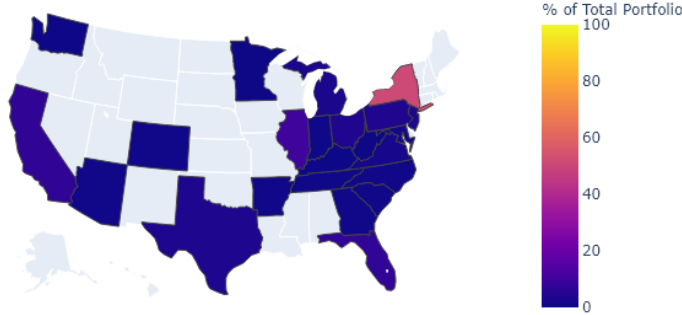

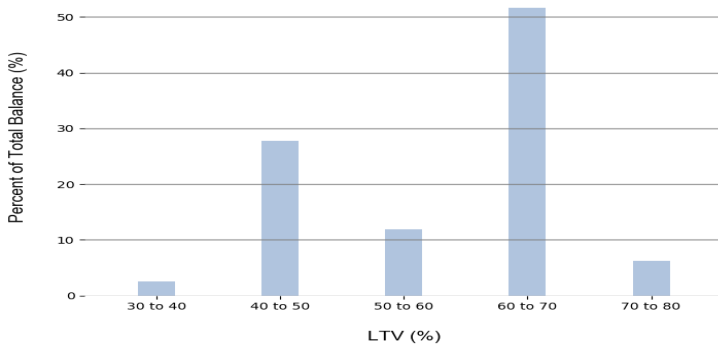
Local Distribution



Among assets in the portfolio, there are 7 properties (51% of total balance) located in New York, 5 properties (10% of total balance) in Illinois, 7 properties (7% of total balance) in Florida, 30 properties (7% of total balance) in California, 12 properties (4% of total balance) in Ohio, 7 properties (4% of total balance) in Pennsylvania and 14 properties (3% of total balance) in Texas. 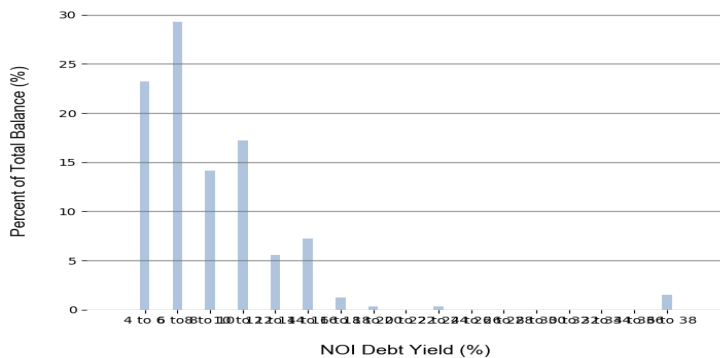

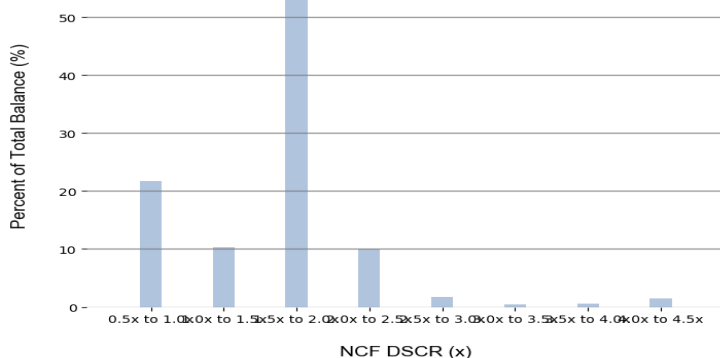
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

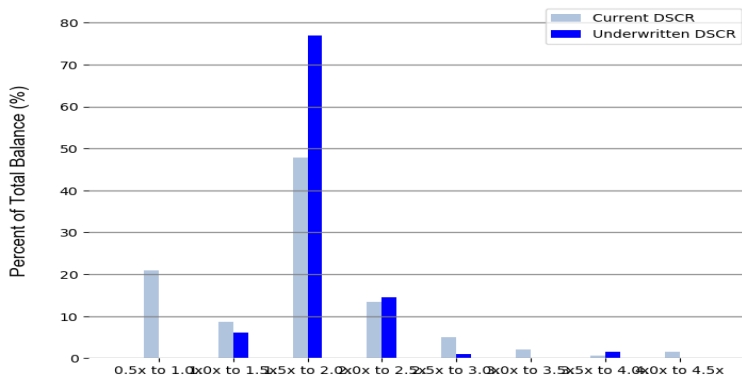

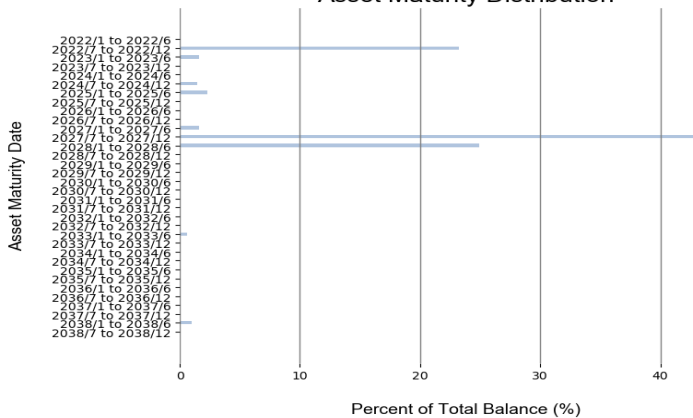
DSCR Distribution (x)

There are 1 assets (20.9% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (8.7% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (47.8% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (13.4% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (4.9% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (2.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.5% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
