## Transaction Summary

The transaction closed on Apr 18 2018 and matures in Jan 2038. The pool's current aggregate principal balance is \$1688.4 million compared to \$1724.4 million at close.

The largest loan of the pool (3.3%) is secured by GNL Portfolio located in Newark, NJ-PA-15.17% Nassau County-Suffolk County, NY-10.21% Detroit-Dearborn-Livonia, MI-7.89% metropolitan area. Occupancy at the subject was 100%. The major tenants included Lippert Cmpnts. (20.57%) and Nissan (17.63%). The second largest loan of the pool (3.3%) is secured by Hilton Clearwater Beach Resort & Spa located in metropolitan area. Occupancy at the subject was 56%. The third largest loan of the pool (21.3%) is secured by One State Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 84%. The major tenants included STATE OF NEW YORK OGS (31.36%) and SOURCEMEDIA INC. (9.38%).

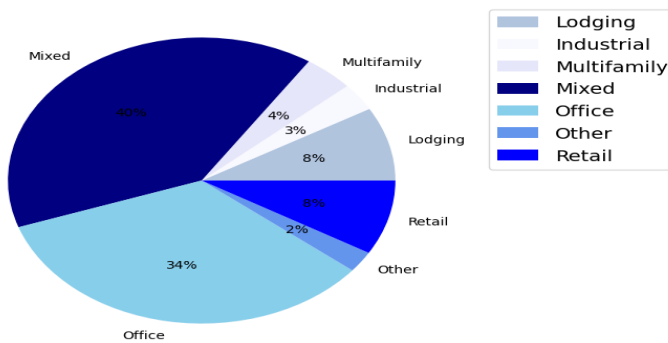
The weighted average coupon (WAC) and the weighted average age (WALA) were 4.47% and 51 months as of 03/15/2022, respectively. There are a total of 55 loans and 117 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 58.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.38x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

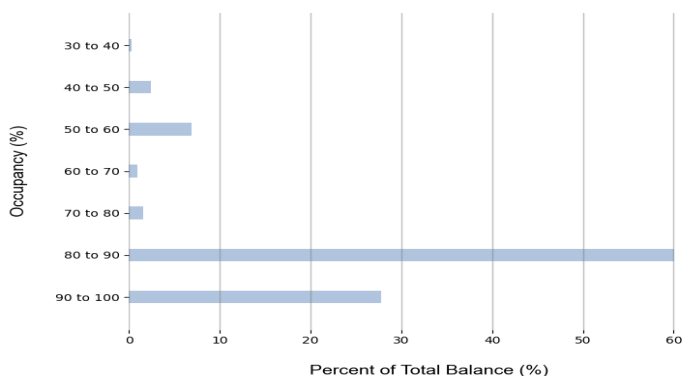

### Occupancy Distribution (%)

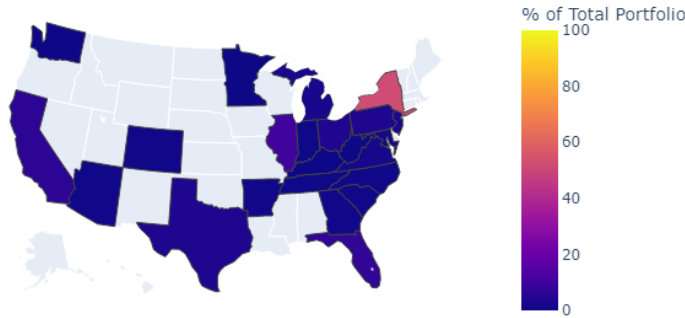

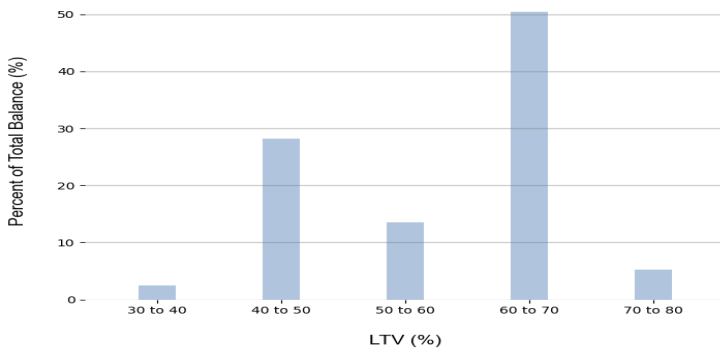
Local Distribution



Among assets in the portfolio, there are 7 properties (52% of total balance) located in New York, 5 properties (10% of total balance) in Illinois, 7 properties (7% of total balance) in Florida, 29 properties (6% of total balance) in California, 12 properties (4% of total balance) in Ohio, 7 properties (4% of total balance) in Pennsylvania and 14 properties (3% of total balance) in Texas. Other properties are located in the state of Michigan, Virginia, Maryland, Washington DC, Colorado, Georgia, Arizona, South Carolina, North Carolina, Arkansas, Indiana, Tennessee, Washington, West Virginia, Minnesota and Kentucky.

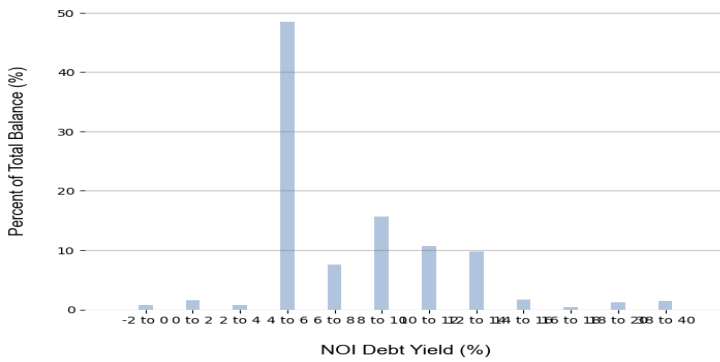

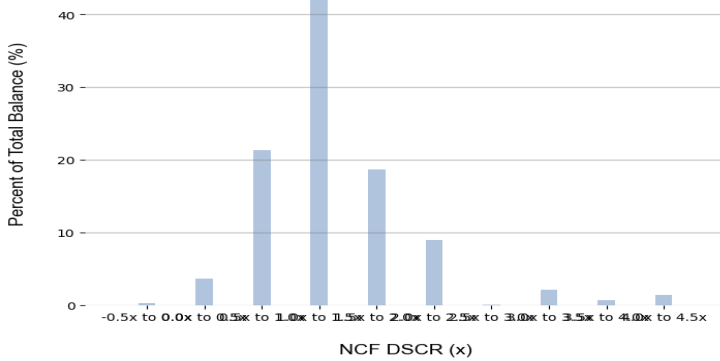
NOI Debt Yield (%)

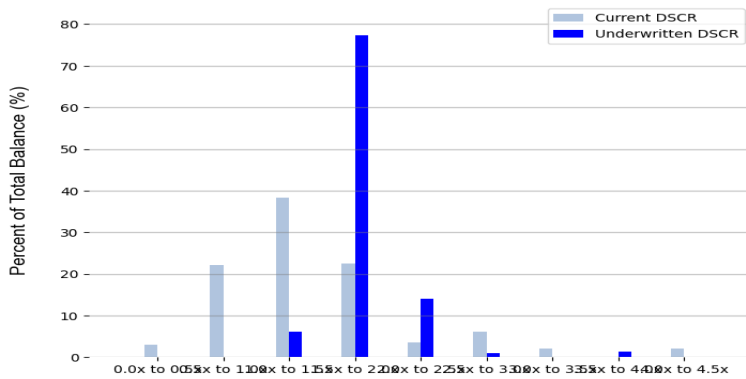

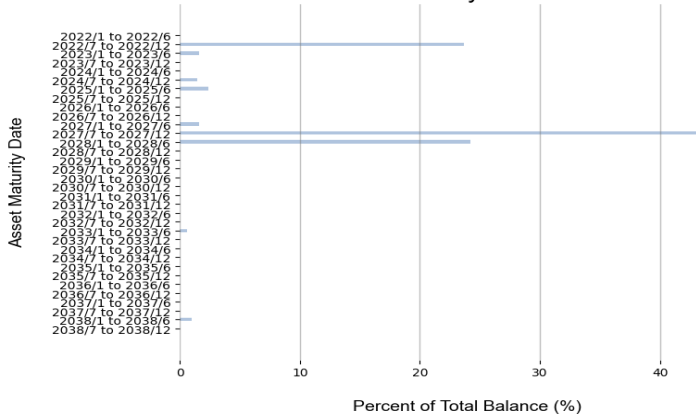
DSCR Distribution (x)



DSCRs ranged from 0.0x to 4.5x. There are 5 assets (3.1% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (22.2% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (38.3% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (22.5% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (3.6% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.1% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.1% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (2.1% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (400.0% of total balance) that have maturity dates between 2022/7 and 2022/12, 2 assets (27.5% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (24.1% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (40.0% of total balance) that have maturity dates between 2025/1 and 2025/6, 3 assets (27.2% of total balance) that have maturity dates between 2027/1 and 2027/6, 16 assets (733.8% of total balance) that have maturity dates between 2027/7 and 2027/12, 29 assets (408.8% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (9.6% of total balance) that have maturity dates between 2033/1 and 2033/6 and 1 assets (17.3% of total balance) that have maturity dates between 2038/1 and 2038/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

### **3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:**

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### **4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:**

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
