## **Transaction Summary**

The transaction closed on Apr 18 2018 and matures in Jan 2038. The pool's current aggregate principal balance is \$1661.7 million compared to \$1698.4 million at close.

The largest loan of the pool (3.3%) is secured by GNL Portfolio located in Newark, NJ-PA-15.17% Nassau County-Suffolk County, NY-10.21% Detroit-Dearborn-Livonia, MI-7.89% metropolitan area. Occupancy at the subject was 100%. The major tenants included Lippert Cmpnts. (20.57%) and Nissan (17.63%). The second largest loan of the pool (3.4%) is secured by Hilton Clearwater Beach Resort & Spa located in metropolitan area. Occupancy at the subject was 56%. The third largest loan of the pool (21.7%) is secured by One State Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 84%. The major tenants included STATE OF NEW YORK OGS (31.36%) and SOURCEMEDIA INC. (9.38%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.48% and 52 months as of 04/15/2022, respectively. There are a total of 54 loans and 116 properties in the portfolio. The appraisal LTV was approximately 58.5% compared to the Original loan to value (LTV), which was approximately 58.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.38x. As of 04/15/2022, 24.07% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.





#### Occupancy Distribution (%)




#### Local Distribution



Among assets in the portfolio, there are 6 properties (51% of total balance) located in New York, 5 properties (10% of total balance) in Illinois, 7 properties (7% of total balance) in Florida, 29 properties (6% of total balance) in California, 12 properties (4% of total balance) in Ohio, 7 properties (4% of total balance) in Pennsylvania and 14 properties (3% of total balance) in Texas. 







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
