## **Transaction Summary**

The transaction closed on Aug 22 2018 and matures in Aug 2028. The pool's current aggregate principal balance is \$664.8 million compared to \$673.3 million at close.

The largest loan of the pool (9.6%) is secured by 20 Times Square - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 11%. The largest tenant was THE HERSHEY COMPANY (52.53%). The second largest loan of the pool (9.1%) is secured by Hilton Clearwater Beach Resort & Spa located in metropolitan area. Occupancy at the subject was 77%. The third largest loan of the pool (7.5%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 94%. The major tenants included J. C. Penney Co. (15.90%) and AMC Theatres (6.50%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.78% and 30 months as of 12/15/2020, respectively. There are a total of 41 loans and 116 properties in the portfolio. The appraisal LTV was approximately 57.0% compared to the Original loan to value (LTV), which was approximately 55.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.18x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 11.7%. NOI debt yield ranged from 4% to 27%. There were 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 1 assets (0% of total balance) with NOI debt yield between 6% and 8%, 15 assets (23% of total balance) with NOI debt yield between 8% and 10%, 12 assets (44% of total balance) with NOI debt yield between 10% and 12%, 3 assets (6% of total balance) with NOI debt yield between 12% and 14%, 3 assets (16% of total balance) with NOI debt yield between 14% and 16%, 3 assets (5% of total balance) with NOI debt yield between 16% and 18%, 2 assets (2% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

There were 2 assets (6.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (2.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 5 assets (6.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (40.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (22.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (4.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (7.1% of total balance) with NCF DSCR between 3.5x and 1 assets (9.6% of total balance) with NCF DSCR between 3.5x and 4.0x. 



There are 2 assets (6.5% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.1% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (3.1% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (28.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (23.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (19.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.3% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (10.4% of total balance) with DSCR between 3.5x and 4.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
