Transaction Summary

The transaction closed on Mar 06 2019 and matures in Jan 2031. The pool's current aggregate principal balance is \$826.6 million compared to \$829.8 million at close.

The largest loan of the pool (9.7%) is secured by Darden Headquarters located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Darden (100.00%). The second largest loan of the pool (6.8%) is secured by Embassy Suites Portland Washington Square located in metropolitan area. Occupancy at the subject was 74%. The third largest loan of the pool (6.0%) is secured by SITE JV Portfolio - Trust located in Newark, NJ-PA-5.19% metropolitan area. Occupancy at the subject was 95%. The major tenants included Lowe's (7.64%) and Kohl's (6.95%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 25 months as of 12/15/2020, respectively. There are a total of 36 loans and 83 properties in the portfolio. The appraisal LTV was approximately 59.5% compared to the Original loan to value (LTV), which was approximately 58.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.04x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 6% to 21%. There were 8 assets (27% of total balance) with NOI debt yield between 6% and 8%, 6 assets (17% of total balance) with NOI debt yield between 8% and 10%, 8 assets (21% of total balance) with NOI debt yield between 10% and 12%, 7 assets (11% of total balance) with NOI debt yield between 12% and 14%, 5 assets (16% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (6% of total balance) with NOI debt yield between 20% and 22%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 8 assets (13.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (43.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (24.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (8.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (4.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (6.0% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 2.0x.







DSCRs ranged from 1.0x to 4.5x.There are 5 assets (8.3% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (45.1% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (12.9% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (23.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (4.1% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (6.0% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.2x.

There are 1 assets (1.3% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (6.0% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (0.4% of total balance) that have maturity dates between 2027/7 and 2027/12, 2 assets (2.7% of total balance) that have maturity dates between 2028/1 and 2028/6, 18 assets (50.1% of total balance) that have maturity dates between 2028/7 and 2028/12, 12 assets (29.7% of total balance) that have maturity dates between 2029/1 and 2028/12, 12 assets (29.7% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (9.7% of total balance) that have maturity dates between 2031/1 and 2031/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
