Transaction Summary

The transaction closed on Mar 06 2019 and matures in Jan 2031. The pool's current aggregate principal balance is \$812.0 million compared to \$818.8 million at close.

The largest loan of the pool (9.9%) is secured by Darden Headquarters located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Darden (100.00%). The second largest loan of the pool (6.9%) is secured by Embassy Suites Portland Washington Square located in metropolitan area. Occupancy at the subject was 25%. The third largest loan of the pool (6.2%) is secured by SITE JV Portfolio - Trust located in Newark, NJ-PA-5.19% metropolitan area. Occupancy at the subject was 81%. The major tenants included Lowe's (7.64%) and Kohl's (6.95%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 41 months as of 04/15/2022, respectively. There are a total of 35 loans and 74 properties in the portfolio. The appraisal LTV was approximately 59.4% compared to the Original loan to value (LTV), which was approximately 58.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.67x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 80%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 21% with a weighted average NOI debt yield of 9.1%. NOI debt yield ranged from 0% to 21%. There were 1 assets (7% of total balance) with NOI debt yield between 0% and 2%, 1 assets (5% of total balance) with NOI debt yield between 2% and 4%, 2 assets (4% of total balance) with NOI debt yield between 4% and 6%, 8 assets (24% of total balance) with NOI debt yield between 6% and 8%, 9 assets (30% of total balance) with NOI debt yield between 8% and 10%, 4 assets (9% of total balance) with NOI debt yield between 10% and 12%, 4 assets (6% of total balance) with NOI debt yield between 12% and 14%, 2 assets (5% of total balance) with NOI debt yield between 14% and 16%, 2 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (6% of total balance) with NOI debt yield between 18% and 20% and 1 assets (1% of total balance) with NOI debt yield between 20% and 22%.

There were 2 assets (12.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (22.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (39.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 1 assets (2.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (8.9% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (10.3% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.7x.







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
