Transaction Summary

The transaction closed on Jun 27 2019 and matures in Jun 2029. The pool's current aggregate principal balance is \$783.1 million compared to \$788.0 million at close.

The largest loan of the pool (6.4%) is secured by 3 Columbus Circle - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Young & Rubicam, Inc. (49.80%) and Emerge 212 3CC LLC (7.60%). The second largest loan of the pool (6.2%) is secured by GNL Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included (27.37%) and Wolverine World Wide Inc. (19.18%). The third largest loan of the pool (5.3%) is secured by Embassy Suites Seattle Bellevue located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 77%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.84% and 20 months as of 12/15/2020, respectively. There are a total of 47 loans and 96 properties in the portfolio. The appraisal LTV was approximately 61.9% compared to the Original loan to value (LTV), which was approximately 61.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration






Local Distribution



DSCRs ranged from 0.0x to 4.5x.There are 1 assets (2.2% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.8% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (10.3% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (38.4% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (33.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (9.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.0x.

There are 2 assets (5.0% of total balance) that have maturity dates between 2028/7 and 2028/12 and 45 assets (95.0% of total balance) that have maturity dates between 2029/1 and 2029/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
