Transaction Summary

The transaction closed on Jun 27 2019 and matures in Jun 2029. The pool's current aggregate principal balance is \$778.2 million compared to \$788.0 million at close.

The largest loan of the pool (6.4%) is secured by 3 Columbus Circle - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Young & Rubicam, Inc. (49.80%) and Emerge 212 3CC LLC (7.60%). The second largest loan of the pool (6.3%) is secured by GNL Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Rubbermaid Incorporated (27.37%) and Wolverine World Wide Inc. (19.18%). The third largest loan of the pool (5.3%) is secured by Embassy Suites Seattle Bellevue located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 27%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.83% and 36 months as of 04/15/2022, respectively. There are a total of 47 loans and 96 properties in the portfolio. The appraisal LTV was approximately 61.8% compared to the Original loan to value (LTV), which was approximately 61.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.21x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 77%.





Occupancy Distribution (%)






Local Distribution







There are 1 assets (3.9% of total balance) with DSCR between -3.0x and -2.5x, 1 assets (5.3% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (16.1% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (3.0% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (17.0% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (21.8% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (16.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (14.8% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
