Transaction Summary

The transaction closed on Dec 12 2019 and matures in Nov 2034. The pool's current aggregate principal balance is \$685.6 million compared to \$689.3 million at close.

The largest loan of the pool (7.6%) is secured by The Met Apartments located in metropolitan area. Occupancy at the subject was 92%. The second largest loan of the pool (6.1%) is secured by Palm Beach Estates located in metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (5.6%) is secured by Towne Center East located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Home Depot (66.83%) and Petsmart (17.16%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.97% and 13 months as of 12/15/2020, respectively. There are a total of 55 loans and 80 properties in the portfolio. The appraisal LTV was approximately 63.6% compared to the Original loan to value (LTV), which was approximately 64.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.36x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)






Local Distribution





Most recent net operating income debt yield ranged from 2% to 33% with a weighted average NOI debt yield of 9.9%. NOI debt yield ranged from 2% to 33%. There were 35 assets (68.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (2.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 6 assets (7.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 3 assets (8.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (7.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (1.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.2% of total balance) with NCF DSCR between 4.0x and 4.5x, 1 assets (1.3% of total balance) with NCF DSCR between 5.0x and 5.5x and 1 assets (1.0% of total balance) with NCF DSCR between 10.5x and 11.0x. 



There are 35 assets (68.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.2% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (6.6% of total balance) with DSCR between 1.0x and 1.5x, 4 assets (8.9% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (7.4% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (1.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.2% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (1.3% of total balance) with DSCR between 5.5x and 6.0x and 1 assets (1.0% of total balance) with DSCR between 11.0x and 11.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
