Transaction Summary

The transaction closed on Mar 30 2020 and matures in Mar 2035. The pool's current aggregate principal balance is \$827.0 million compared to \$829.5 million at close.

The largest loan of the pool (8.2%) is secured by KPMG Plaza at Hall Arts located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 96%. The major tenants included KPMG LLC (44.94%) and Jackson Walker (23.44%). The second largest loan of the pool (8.0%) is secured by Peachtree Office Towers - Trust located in metropolitan area. Occupancy at the subject was 85%. The major tenants included State Board - Workers Comp (11.50%) and Richard Bowers & Co (6.10%). The third largest loan of the pool (7.3%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 99%. The major tenants included Outreach Corporation (20.88%) and Aptevo Research & Development LLC (11.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.65% and 12 months as of 12/15/2020, respectively. There are a total of 30 loans and 62 properties in the portfolio. The appraisal LTV was approximately 57.8% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

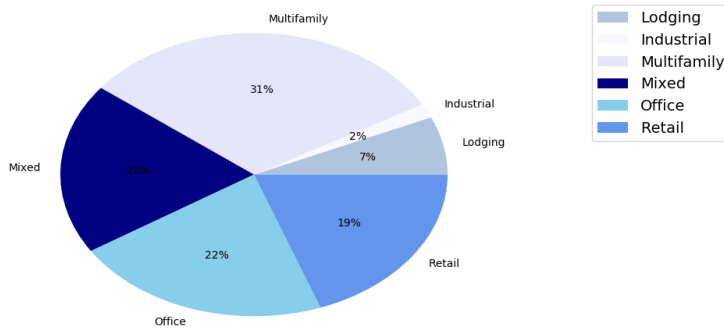

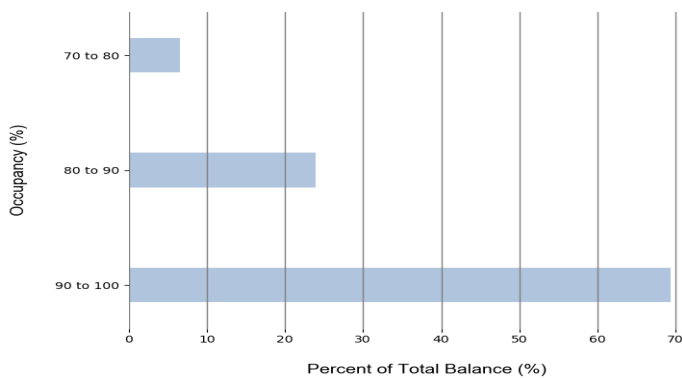

Occupancy Distribution (%)

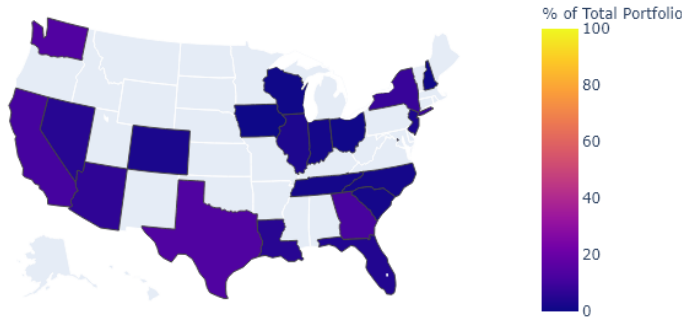

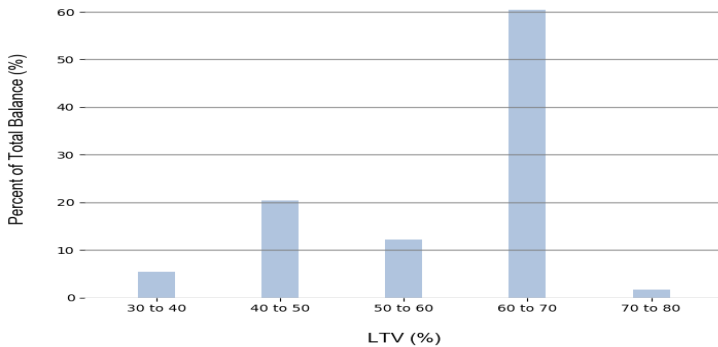
Local Distribution

LTV Distribution (%)



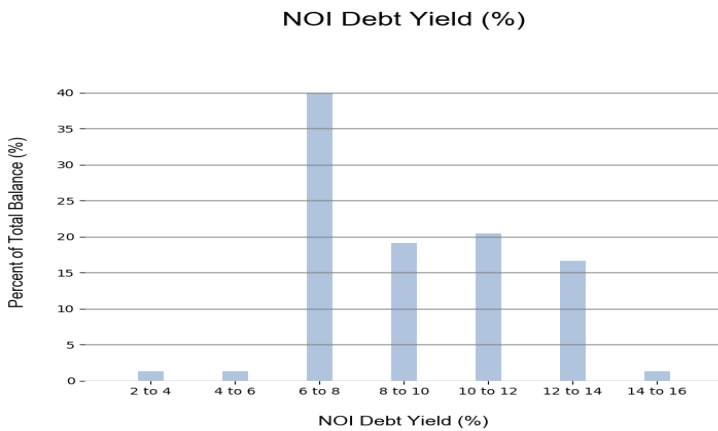

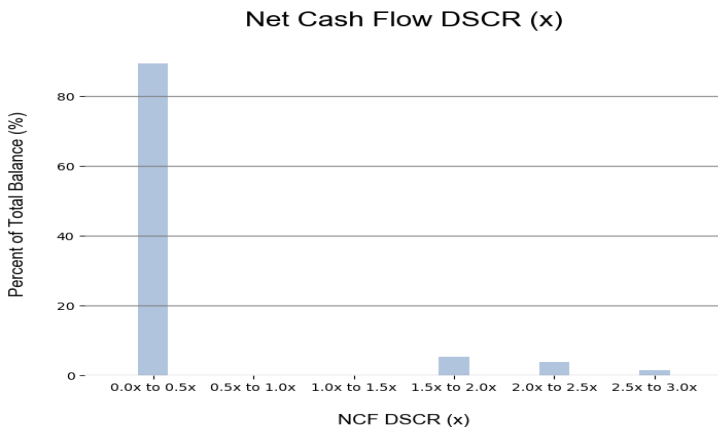

Most recent net operating income debt yield ranged from 2% to 15% with a weighted average NOI debt yield of 9.2%. NOI debt yield ranged from 2% to 15%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 13 assets (40% of total balance) with NOI debt yield between 6% and 8%, 5 assets (19% of total balance) with NOI debt yield between 8% and 10%, 5 assets (20% of total balance) with NOI debt yield between 10% and 12%, 4 assets (17% of total balance) with NOI debt yield between 12% and 14% and 1 assets (1% of total balance) with NOI debt yield between 14% and 16%.

NCF DSCR ranged from 0.0x to 3.0x. There were 26 assets (89.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (5.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 2 assets (3.8% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (1.4% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 2.0x.

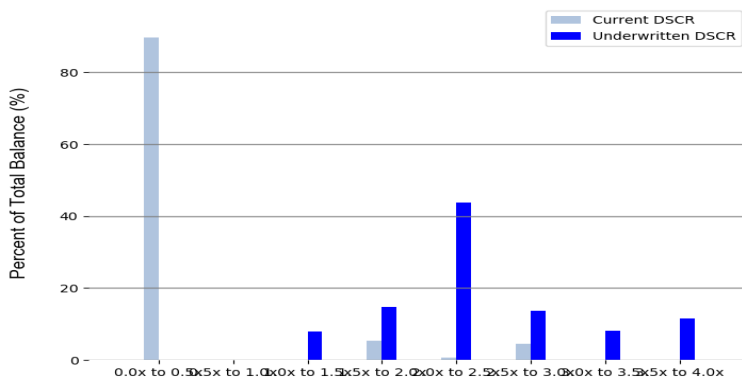

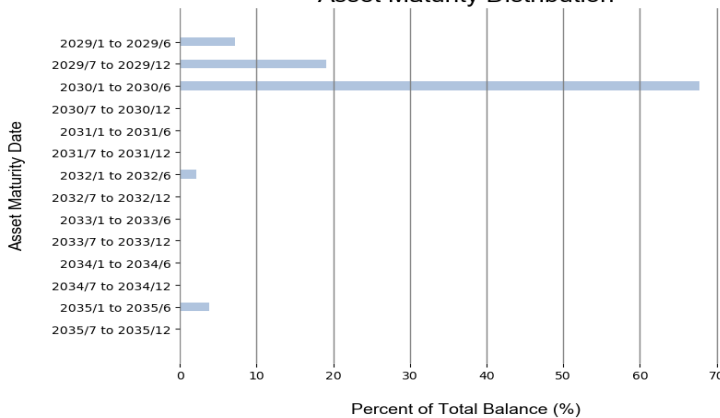
DSCR Distribution (x)



DSCRs ranged from 0.0x to 3.0x. There are 26 assets (89.5% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (5.3% of total balance) with DSCR between 1.5x and 2.0x, 1 assets (0.7% of total balance) with DSCR between 2.0x and 2.5x and 2 assets (4.6% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.2x.

There are 1 assets (7.3% of total balance) that have maturity dates between 2029/1 and 2029/6, 4 assets (19.0% of total balance) that have maturity dates between 2029/7 and 2029/12, 23 assets (67.7% of total balance) that have maturity dates between 2030/1 and 2030/6, 1 assets (2.2% of total balance) that have maturity dates between 2032/1 and 2032/6 and 1 assets (3.8% of total balance) that have maturity dates between 2035/1 and 2035/6.

Sensitivity Analysis

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
