Transaction Summary

The transaction closed on Mar 30 2020 and matures in Mar 2035. The pool's current aggregate principal balance is \$823.3 million compared to \$829.5 million at close.

The largest loan of the pool (8.3%) is secured by KPMG Plaza at Hall Arts located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 96%. The major tenants included KPMG LLC (44.94%) and Jackson Walker (23.44%). The second largest loan of the pool (8.0%) is secured by Peachtree Office Towers - Trust located in metropolitan area. Occupancy at the subject was 82%. The major tenants included State Board - Workers Comp (11.50%) and Richard Bowers & Co (6.10%). The third largest loan of the pool (7.3%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 85%. The major tenants included Outreach Corporation (20.88%) and AptevoResearch&Development LLC (11.84%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.65% and 27 months as of 03/15/2022, respectively. There are a total of 30 loans and 62 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.95x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 25% with a weighted average NOI debt yield of 8.6%. NOI debt yield ranged from 0% to 25%. There were 1 assets (5% of total balance) with NOI debt yield between 0% and 2%, 3 assets (8% of total balance) with NOI debt yield between 4% and 6%, 11 assets (37% of total balance) with NOI debt yield between 6% and 8%, 9 assets (30% of total balance) with NOI debt yield between 8% and 10%, 2 assets (11% of total balance) with NOI debt yield between 10% and 12%, 3 assets (4% of total balance) with NOI debt yield between 12% and 14%, 1 assets (4% of total balance) with NOI debt yield between 24% and 1200.





DSCRs ranged from 0.0x to 3.5x.There are 1 assets (5.2% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (16.5% of total balance) with DSCR between 1.0x and 1.5x, 7 assets (23.3% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (25.8% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (19.2% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (9.9% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (60.0% of total balance) that have maturity dates between 2029/1 and 2029/6, 4 assets (156.6% of total balance) that have maturity dates between 2029/7 and 2029/12, 23 assets (558.5% of total balance) that have maturity dates between 2030/1 and 2030/6, 1 assets (18.0% of total balance) that have maturity dates between 2032/1 and 2032/6 and 1 assets (30.3% of total balance) that have maturity dates between 2035/1 and 2035/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
