Transaction Summary

The transaction closed on Dec 09 2013 and matures in Nov 2033. The pool's current aggregate principal balance is \$578.3 million compared to \$652.6 million at close.

The largest loan of the pool (11.7%) is secured by The Outlet Shoppes at Atlanta located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Saks Fifth Avenue (6.68%) and Nike Factory Store (3.69%). The second largest loan of the pool (12.3%) is secured by Miracle Mile Shops located in metropolitan area. Occupancy at the subject was 90%. The major tenants included V Theater (8.56%) and Victoria's Secret (4.65%). The third largest loan of the pool (8.6%) is secured by One Union Square located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Bulgari (38.31%) and 180 Geary Street HQ LLC (23.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.12% and 102 months as of 04/10/2022, respectively. There are a total of 54 loans and 59 properties in the portfolio. The appraisal LTV was approximately 58.1% compared to the Original loan to value (LTV), which was approximately 63.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.57x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.

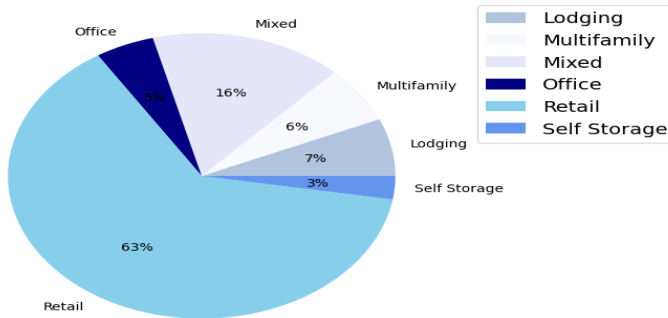

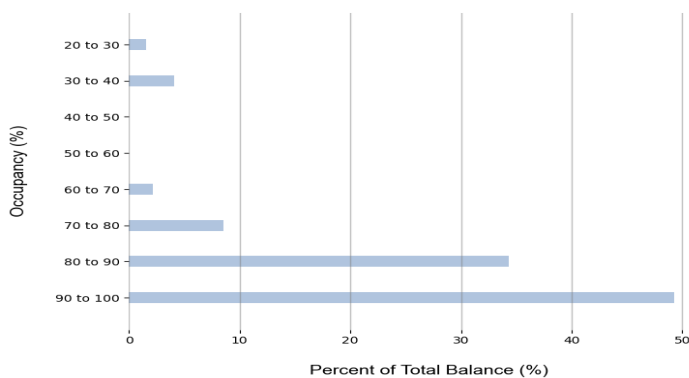

Occupancy Distribution (%)

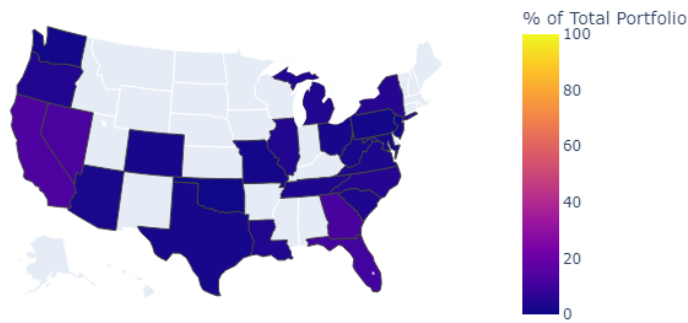

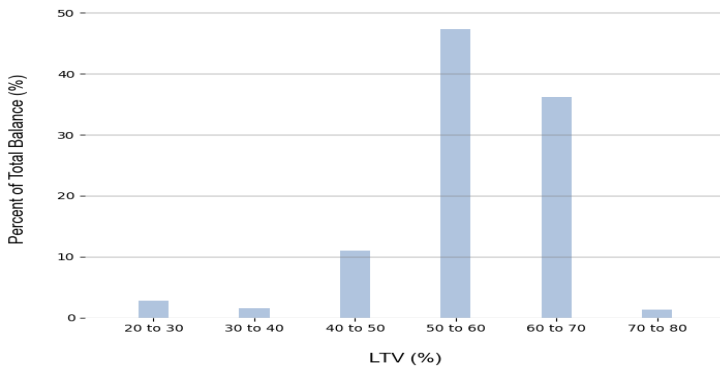
Local Distribution

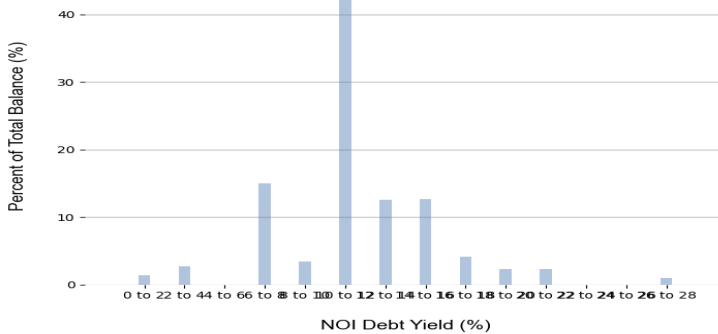

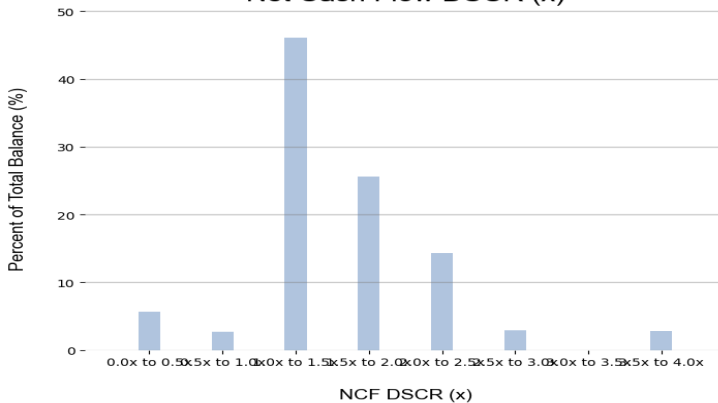
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

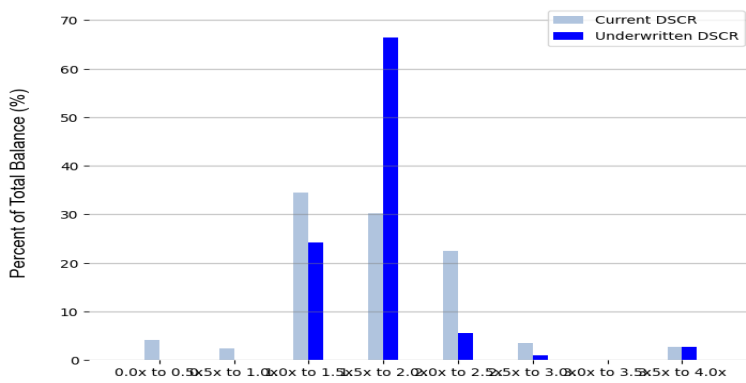

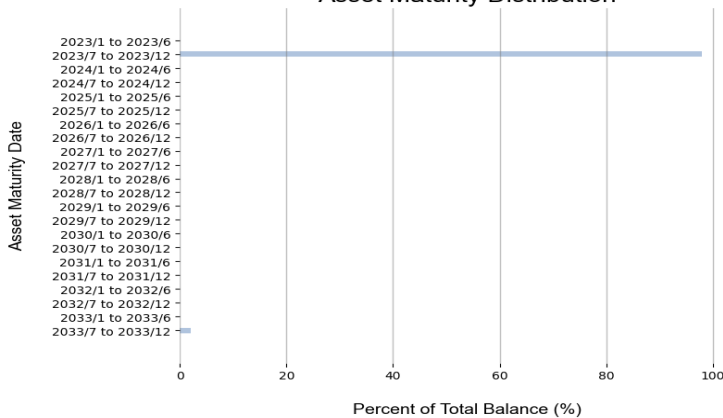
DSCR Distribution (x)

There are 2 assets (4.1% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (34.6% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (30.2% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (22.5% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (3.5% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (2.8% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
