Transaction Summary

The transaction closed on Aug 30 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$593.2 million compared to \$609.5 million at close.

The largest loan of the pool (10.1%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included VERTEX PHARMACEUTICAL (49.43%) and Bright Horizons Centers (1.13%). The second largest loan of the pool (10.1%) is secured by Opry Mills located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Bass Pro Shops (11.13%) and Regal Cinemas (8.55%). The third largest loan of the pool (10.1%) is secured by Crocker Park Phase One & Two located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Dick's Clothing and Sporting Goods (12.19%) and Fitness & Sports Clubs LLC (6.50%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 51 months as of 10/10/2020, respectively. There are a total of 44 loans and 70 properties in the portfolio. The appraisal LTV was approximately 57.9% compared to the Original loan to value (LTV), which was approximately 58.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.33x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

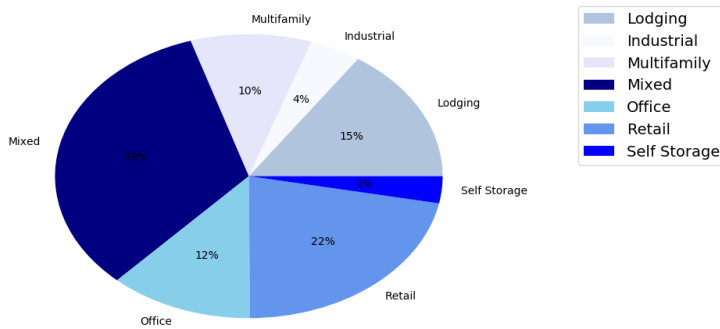

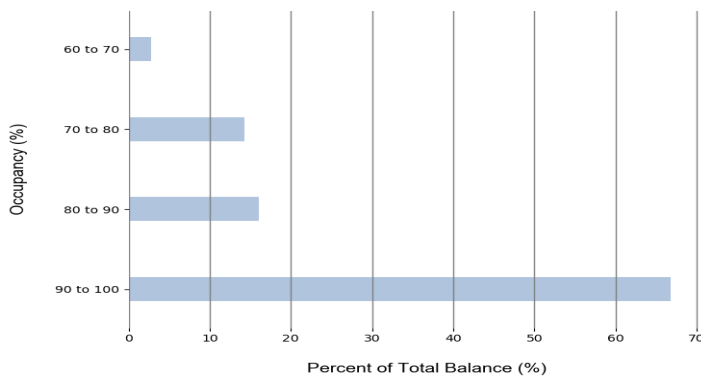

Occupancy Distribution (%)

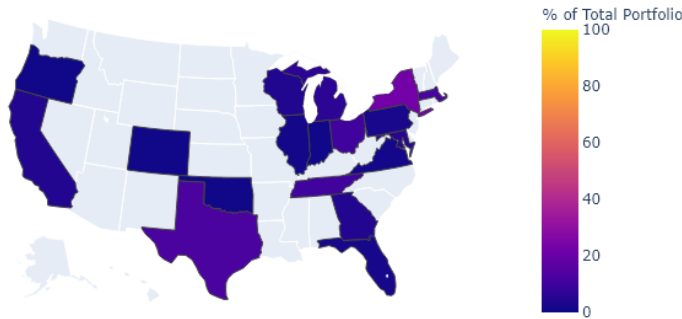

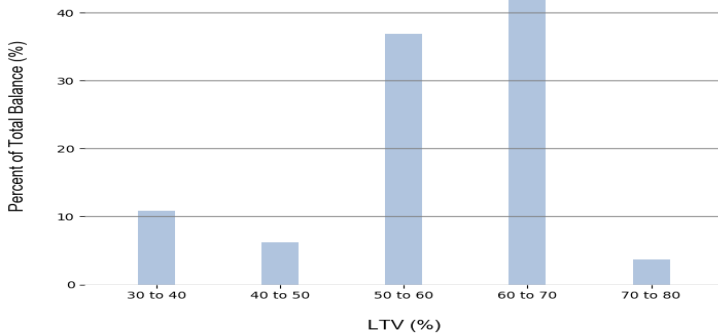
Local Distribution

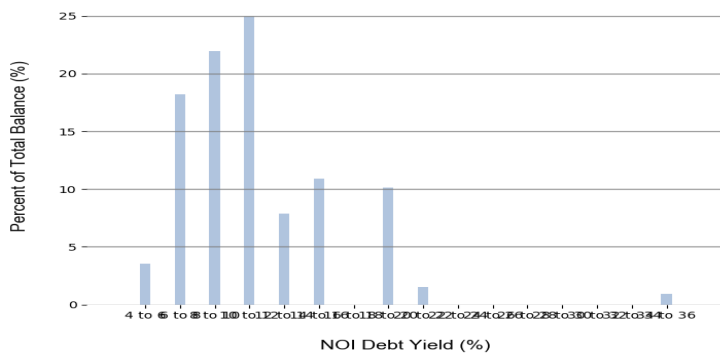

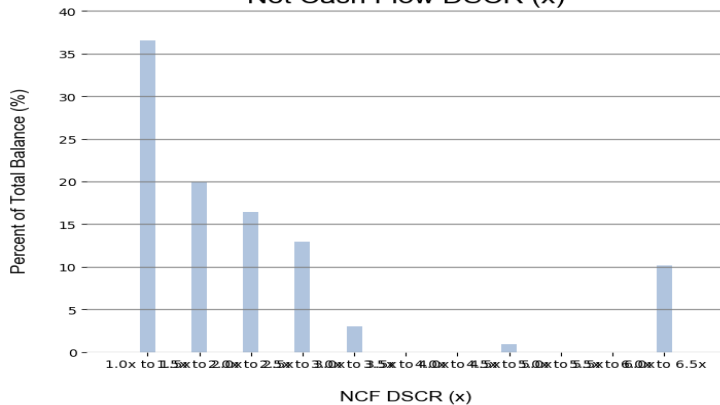
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

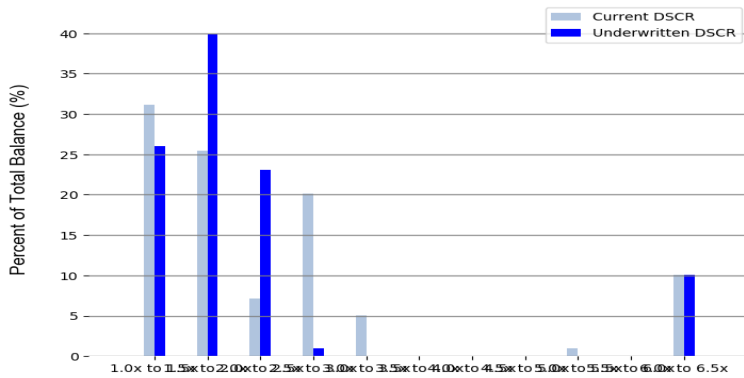


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 6.0x. There were 17 assets (36.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 16 assets (20.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (16.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (12.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (3.0% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.9% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (10.1% of total balance) with NCF DSCR between 6.0x and 6.5x. The most recent weighted average NCF DSCR was 2.3x.

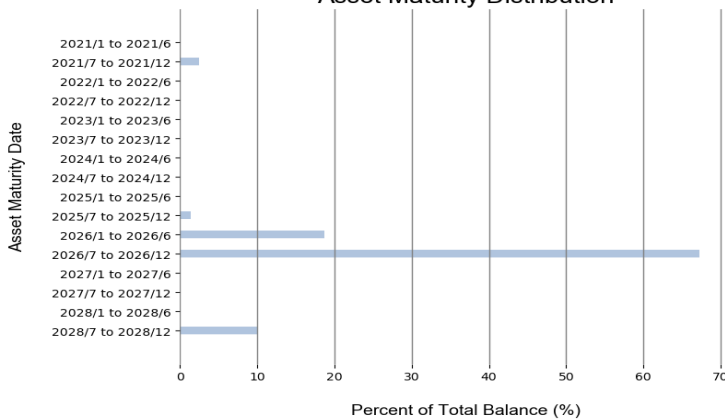
DSCR Distribution (x)



DSCRs ranged from 1.0x to 6.5x. There are 13 assets (31.1% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (25.5% of total balance) with DSCR between 1.5x and 2.0x, 2 assets (7.2% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (20.1% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (5.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.9% of total balance) with DSCR between 5.0x and 5.5x and 1 assets (10.1% of total balance) with DSCR between 6.0x and 6.5x. The most recent weighted average DSCR is 2.5x.

There are 1 assets (2.5% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (1.5% of total balance) that have maturity dates between 2025/7 and 2025/12, 10 assets (18.7% of total balance) that have maturity dates between 2026/1 and 2026/6, 31 assets (67.2% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (10.1% of total balance) that have maturity dates between 2028/7 and 2028/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
