## Transaction Summary

The transaction closed on Apr 13 2016 and matures in Apr 2026. The pool's current aggregate principal balance is \$712.8 million compared to \$731.1 million at close.

The largest loan of the pool (8.8%) is secured by Empire Mall located in metropolitan area. Occupancy at the subject was 78%. The major tenants included JC Penney (11.94%) and Macy's (8.96%). The second largest loan of the pool (7.7%) is secured by Marriott Midwest Portfolio located in Detroit-Dearborn-Livonia, MI-26.75% Warren-Troy-Farmington Hills, MI-8.99% metropolitan area. Occupancy at the subject was 75%. The third largest loan of the pool (7.4%) is secured by Nyack College NYC located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was NYACK COLLEGE (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.91% and 56 months as of 10/15/2020, respectively. There are a total of 36 loans and 79 properties in the portfolio. The appraisal LTV was approximately 58.6% compared to the Original loan to value (LTV), which was approximately 57.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.94x. As of 10/15/2020, 7.72% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

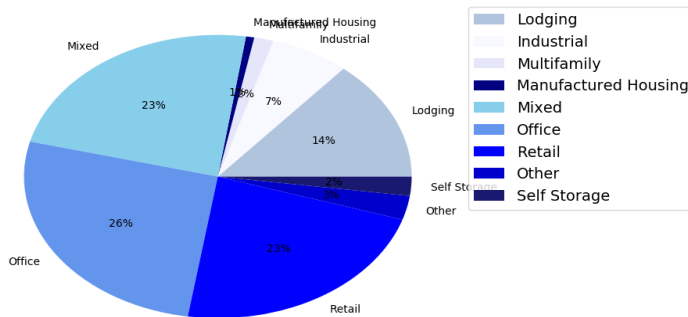

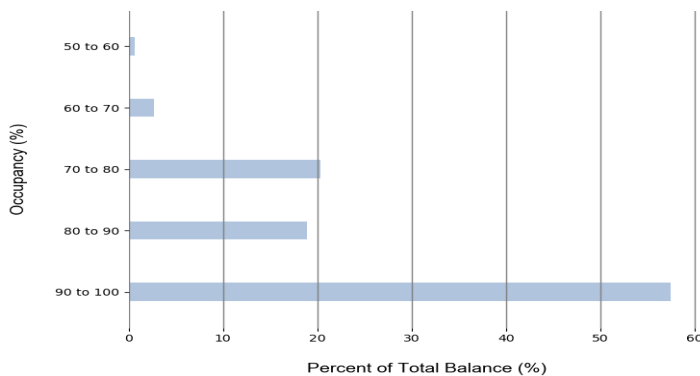

Occupancy Distribution (%)

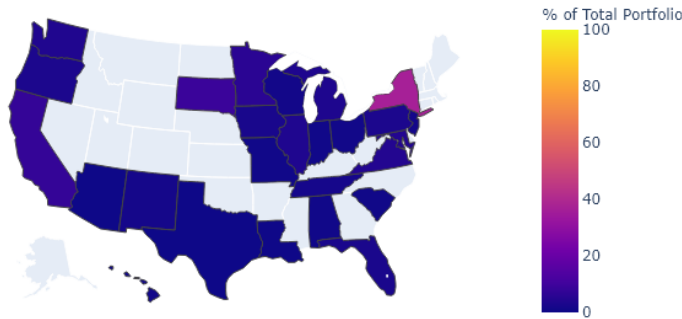

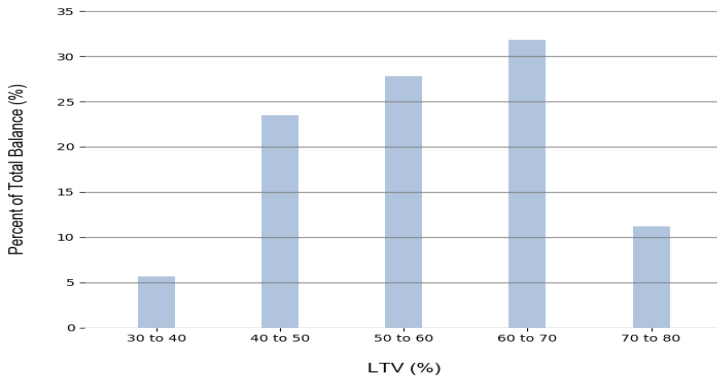
Local Distribution

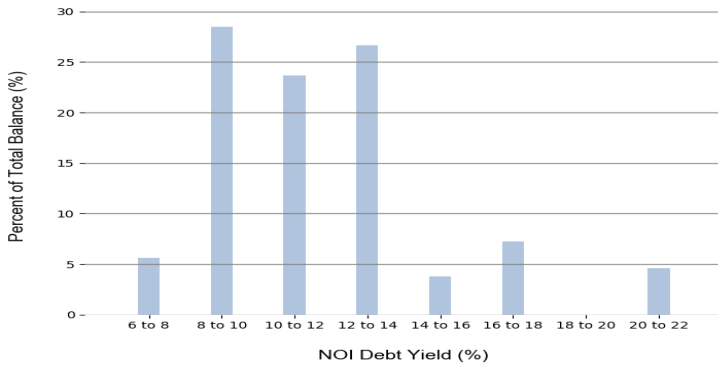

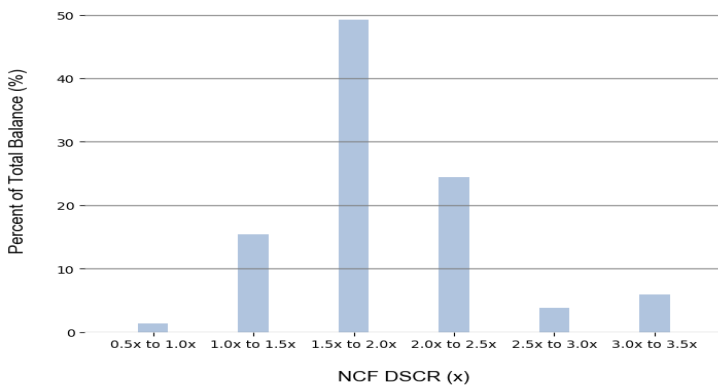
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

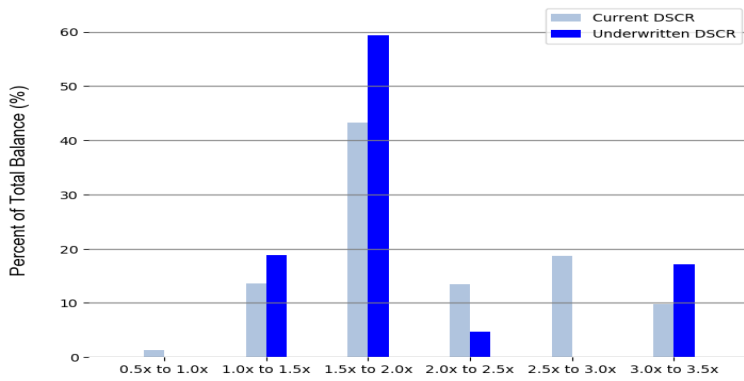


NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (1.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (15.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 16 assets (49.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (24.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (3.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (6.0% of total balance) with NCF DSCR between 3.0x and 3.5x. 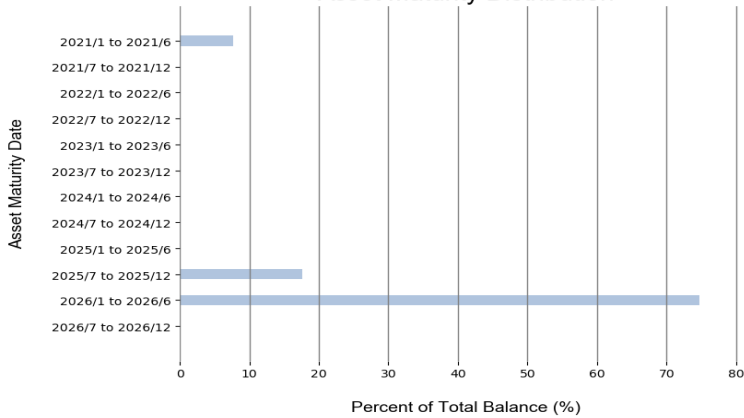
**DSCR Distribution (x)**

There are 1 assets (1.3% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (13.5% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (43.3% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (13.5% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (18.6% of total balance) with DSCR between 2.5x and 3.0x and 3 assets (9.7% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.1x.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
