Transaction Summary

The transaction closed on Jul 29 2016 and matures in Jul 2026. The pool's current aggregate principal balance is \$697.9 million compared to \$721.3 million at close.

The largest loan of the pool (10.0%) is secured by Opry Mills located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Bass Pro Shops (11.13%) and Regal Cinemas (8.55%). The second largest loan of the pool (8.5%) is secured by Hyatt Regency Huntington Beach Resort & Spa located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 78%. The third largest loan of the pool (5.5%) is secured by Esplanade I located in metropolitan area. Occupancy at the subject was 86%. The major tenants included United States Government (12.33%) and Hillshire Brands/Tyson Foods (11.97%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.75% and 54 months as of 12/10/2020, respectively. There are a total of 45 loans and 64 properties in the portfolio. The appraisal LTV was approximately 64.0% compared to the Original loan to value (LTV), which was approximately 62.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.88x. As of 12/10/2020, 7.95% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.

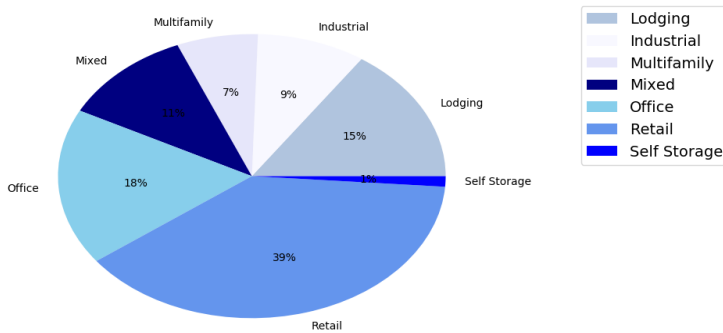

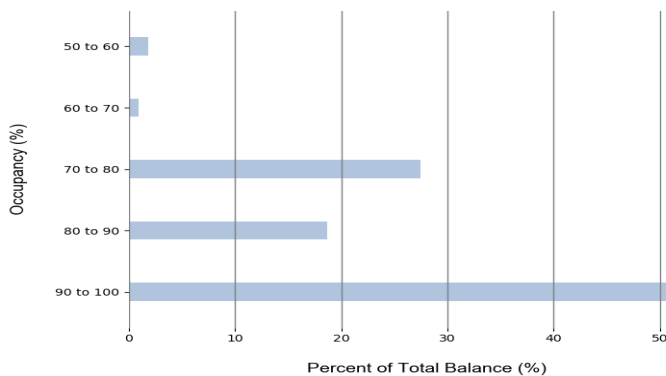

Occupancy Distribution (%)

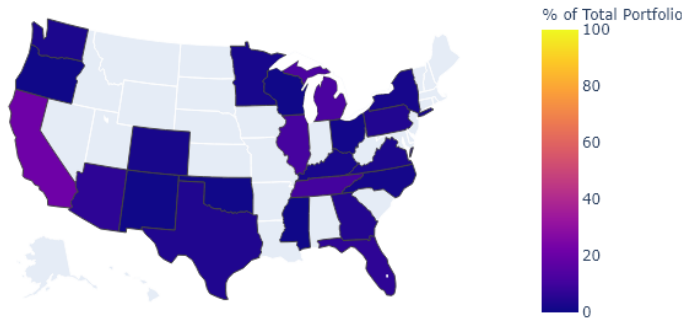

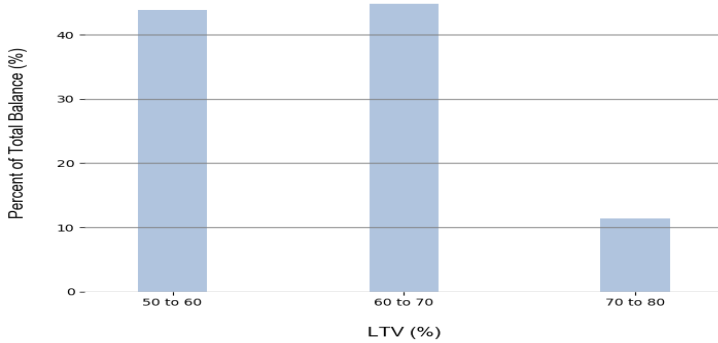
Local Distribution

LTV Distribution (%)



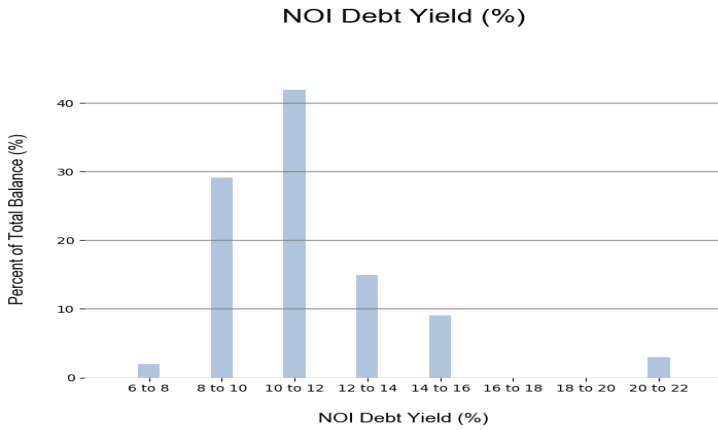

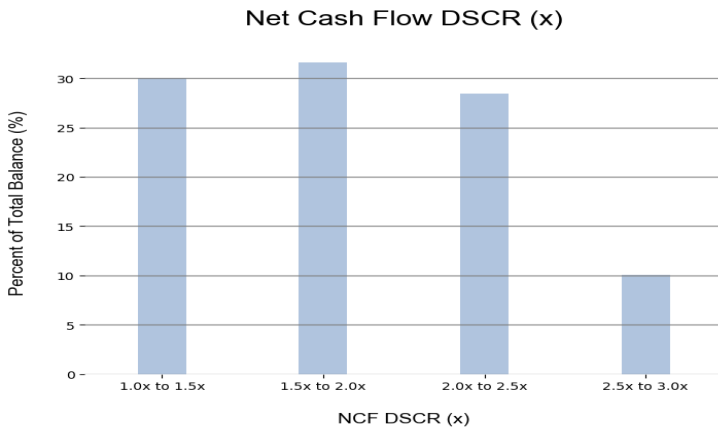

Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 6% to 21%. There were 1 assets (2% of total balance) with NOI debt yield between 6% and 8%, 13 assets (29% of total balance) with NOI debt yield between 8% and 10%, 18 assets (42% of total balance) with NOI debt yield between 10% and 12%, 9 assets (15% of total balance) with NOI debt yield between 12% and 14%, 2 assets (9% of total balance) with NOI debt yield between 14% and 16%, 2 assets (3% of total balance) with NOI debt yield between 20% and 22%

NCF DSCR

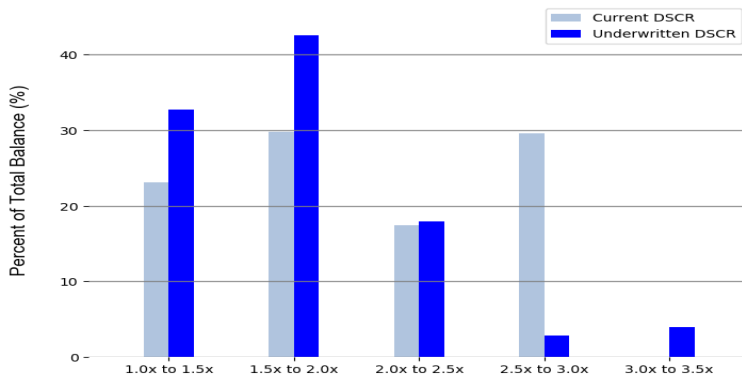


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 3.0x. There were 15 assets (29.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (31.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (28.4% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (10.0% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.9x.

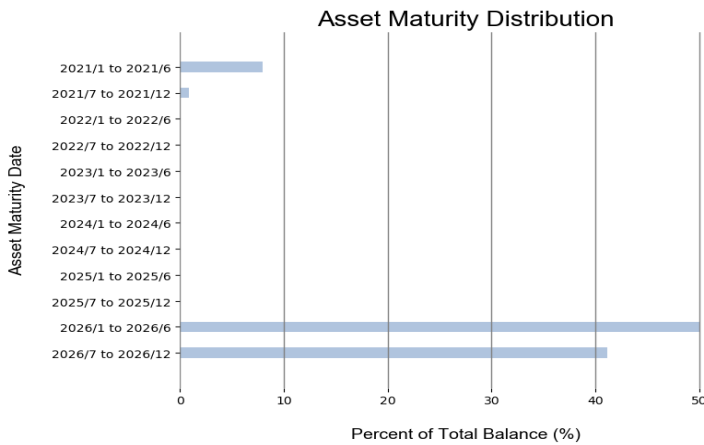

DSCRs ranged from 1.0x to 3.0x. There are 11 assets (23.1% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (29.8% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (17.5% of total balance) with DSCR between 2.0x and 2.5x and 6 assets (29.6% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.0x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
