Transaction Summary

The transaction closed on Oct 18 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$886.4 million compared to \$918.3 million at close.

The largest loan of the pool (7.3%) is secured by Hyatt Regency Jersey City located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The second largest loan of the pool (6.8%) is secured by Plaza America I & II located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 91%. The major tenants included SOFTWARE AG USA (14.04%) and NVR, Inc. (11.71%). The third largest loan of the pool (5.8%) is secured by One Bethesda Center located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 97%. The major tenants included BOSTON CONSULTING GROUP (37.82%) and PALEY ROTHMAN GOLDSTEIN (16.70%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.33% and 52 months as of 12/10/2020, respectively. There are a total of 49 loans and 90 properties in the portfolio. The appraisal LTV was approximately 58.8% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.15x. As of 12/10/2020, 2.16% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

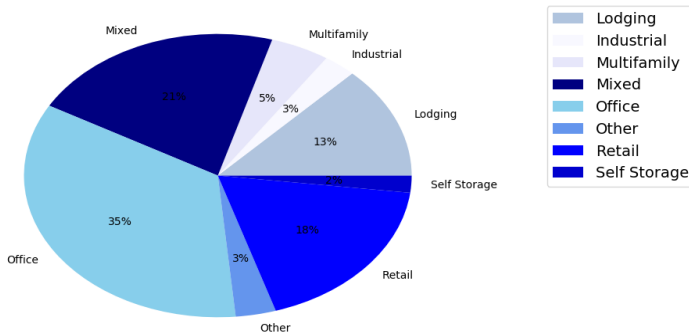

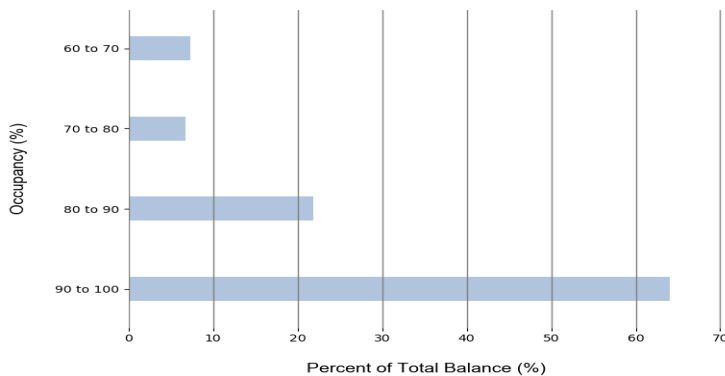

Occupancy Distribution (%)

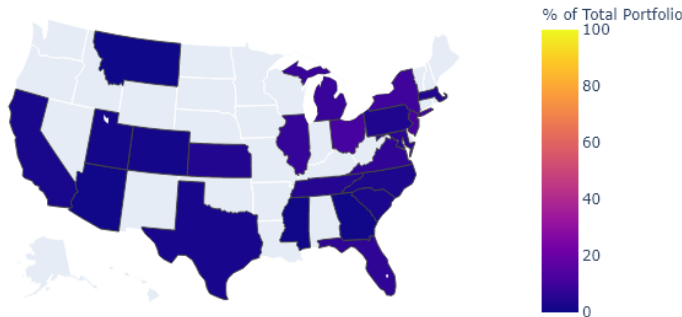

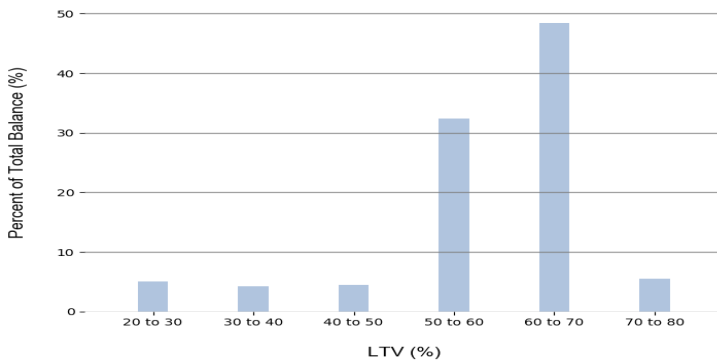
Local Distribution

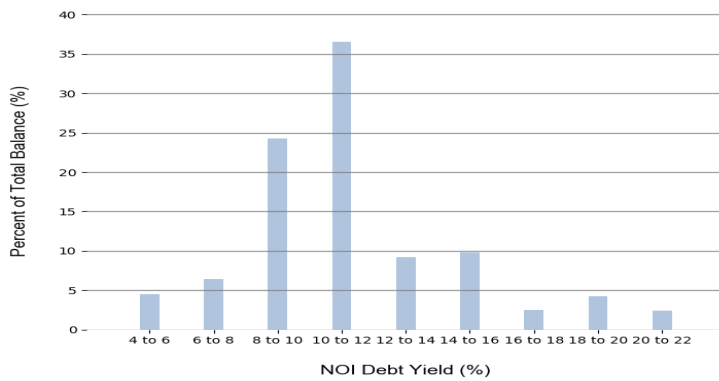

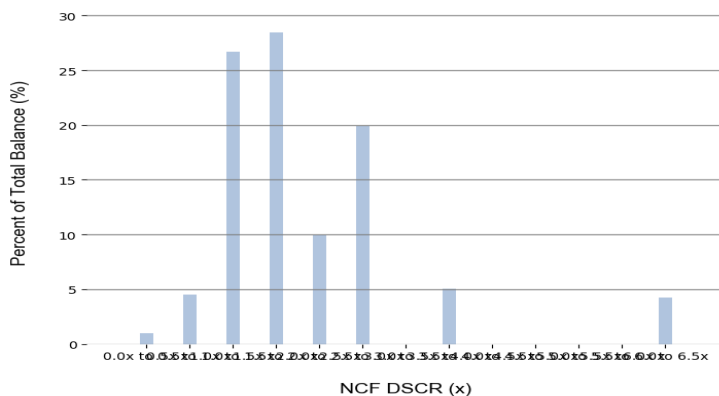
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 21%. There were 1 assets (5% of total balance) with NOI debt yield between 4% and 6%, 3 assets (6% of total balance) with NOI debt yield between 6% and 8%, 16 assets (24% of total balance) with NOI debt yield between 8% and 10%, 15 assets (37% of total balance) with NOI debt yield between 10% and 12%, 6 assets (9% of total balance) with NOI debt yield between 12% and 14%, 5 assets (10% of total balance) with NOI debt yield between 14% and 16%, 1 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (4% of total balance) with NOI debt yield between 18% and 20% and 1 assets (2% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

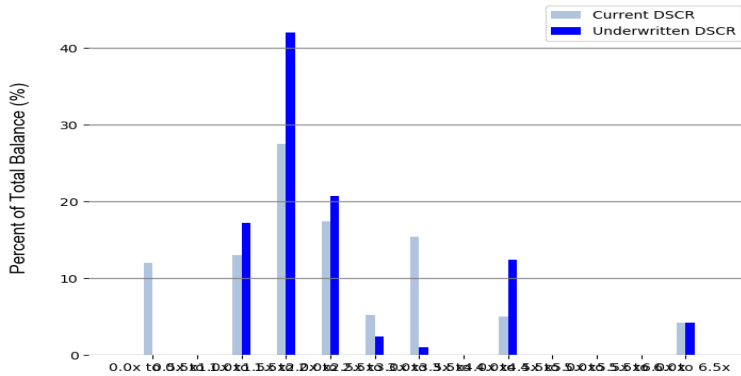


NCF DSCR ranged from 0.0x to 6.0x. There were 1 assets (1.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (4.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 19 assets (26.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (28.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (10.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 7 assets (20.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (5.1% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (4.2% of total balance) with NCF DSCR between 6.0x and 6.5x. 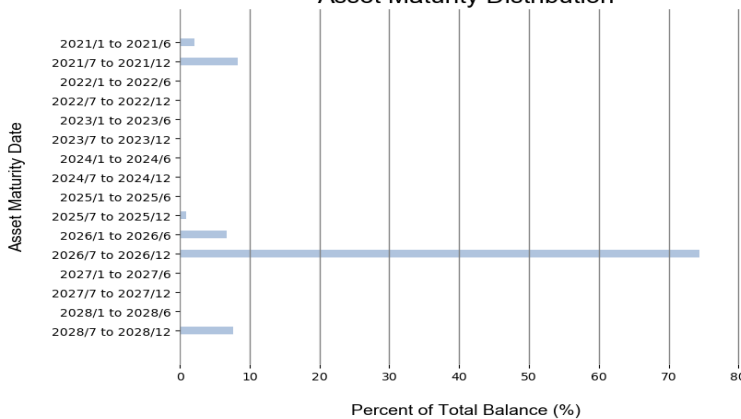
DSCR Distribution (x)



DSCRs ranged from 0.0x to 6.5x. There are 4 assets (12.1% of total balance) with DSCR between 0.0x and 0.5x, 11 assets (13.1% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (27.5% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (17.4% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (5.2% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (15.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.1% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.2% of total balance) with DSCR between 6.0x and 6.5x. There are 1 assets (2.2% of total balance) that have maturity dates between 2021/1 and 2021/6, 2 assets (8.3% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (0.9% of total balance) that have maturity dates between 2025/7 and 2025/12, 4 assets (6.7% of total balance) that have maturity dates between 2026/1 and 2026/6, 39 assets (74.4% of total balance) that have maturity dates between 2026/7 and 2026/12 and 2 assets (7.6% of total balance) that have maturity dates between 2028/7 and 2028/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
