Transaction Summary

The transaction closed on Apr 18 2017 and matures in Dec 2036. The pool's current aggregate principal balance is \$1011.1 million compared to \$1025.8 million at close.

The largest loan of the pool (7.4%) is secured by Mack-Cali Short Hills Office Portfolio located in Newark, NJ-PA-100.00% metropolitan area. Occupancy at the subject was 95%. The major tenants included DUN & BRADSTREET CORPOR (33.61%) and KPMG (11.64%). The second largest loan of the pool (6.1%) is secured by 50 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included UFT (17.56%) and UFT WELFARE FUND (8.54%). The third largest loan of the pool (4.8%) is secured by Key Center Cleveland located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Key Bank (18.23%) and Squire Patton Boggs US LLP (6.31%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.69% and 46 months as of 12/14/2020, respectively. There are a total of 46 loans and 58 properties in the portfolio. The appraisal LTV was approximately 65.8% compared to the Original loan to value (LTV), which was approximately 58.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.13x. As of 12/14/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

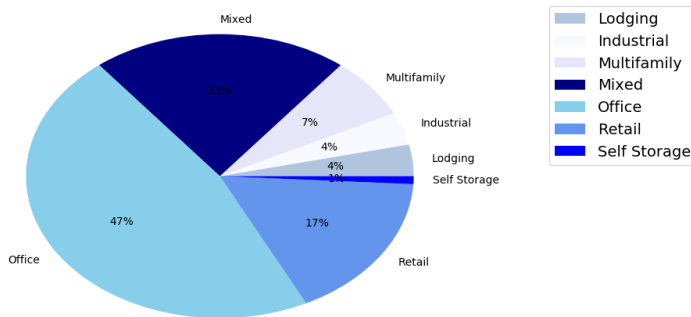

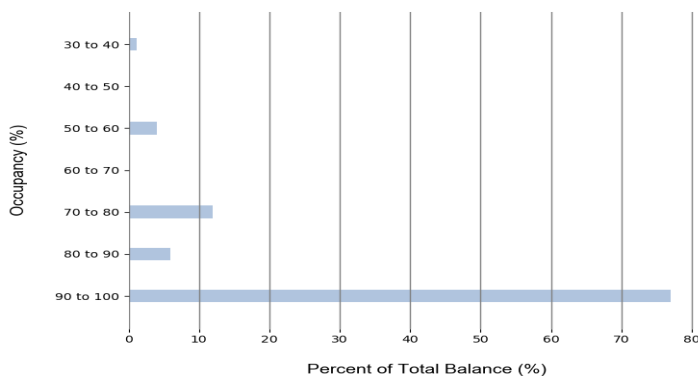

Occupancy Distribution (%)

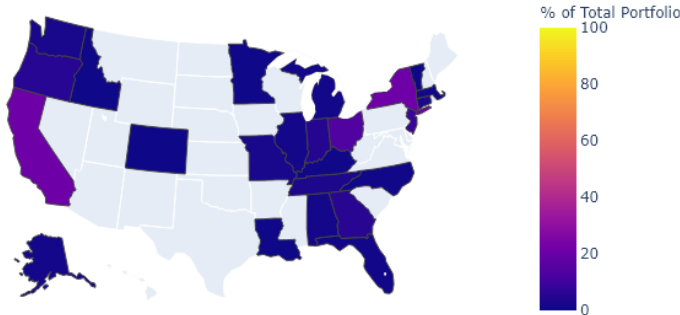

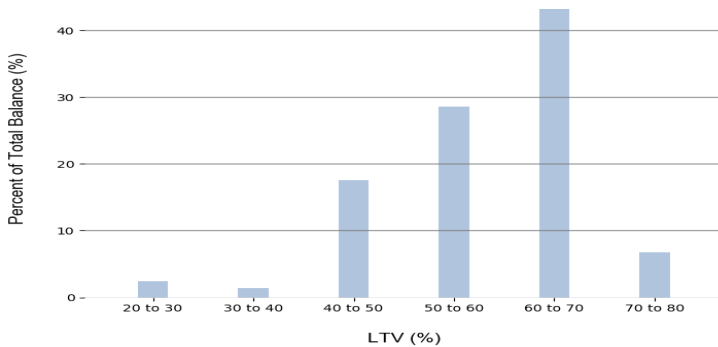
Local Distribution

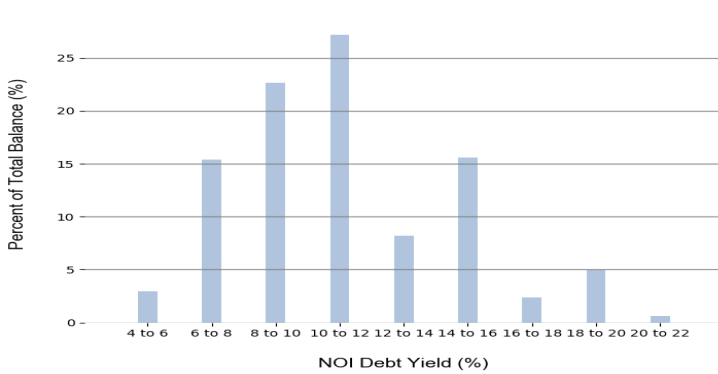

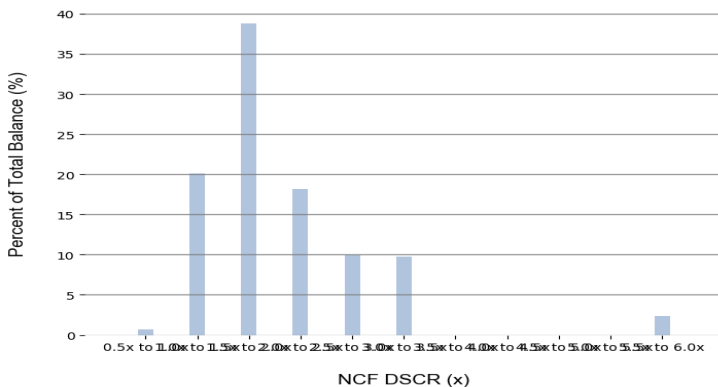
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 21%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 8 assets (15% of total balance) with NOI debt yield between 6% and 8%, 11 assets (23% of total balance) with NOI debt yield between 8% and 10%, 10 assets (27% of total balance) with NOI debt yield between 10% and 12%, 7 assets (8% of total balance) with NOI debt yield between 12% and 14%, 5 assets (16% of total balance) with NOI debt yield between 14% and 16%, 1 assets (2% of total balance) with NOI debt yield between 16% and 18%, 2 assets (5% of total balance) with NOI debt yield between 18% and 20% and 1 assets (1% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

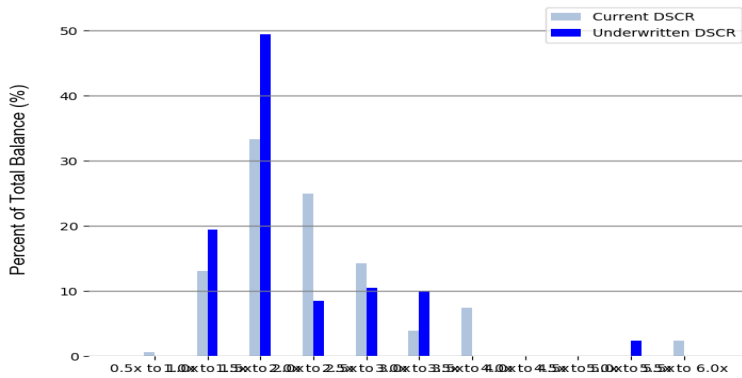


NCF DSCR ranged from 0.0x to 6.0x. There were 1 assets (0.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (20.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (38.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (18.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (10.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (9.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (2.4% of total balance) with NCF DSCR between 5.5x and 6.0x. 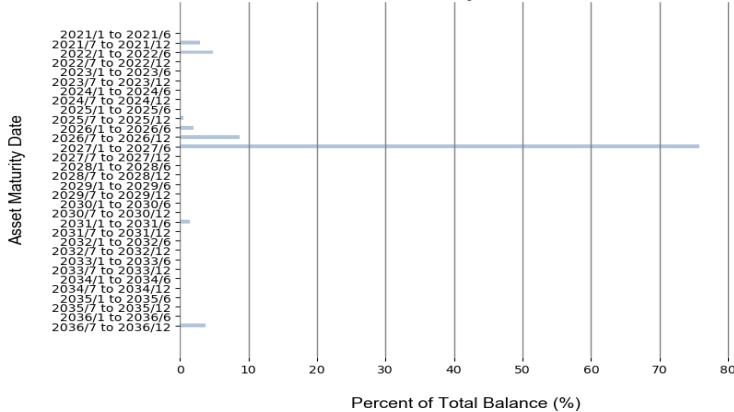
DSCR Distribution (x)



DSCRs ranged from 0.5x to 6.0x. There are 1 assets (0.7% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (13.1% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (33.4% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (25.0% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (14.2% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (3.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.4% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.2x.

There are 1 assets (2.9% of total balance) that have maturity dates between 2021/7 and 2021/12, 2 assets (4.9% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (0.5% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (2.0% of total balance) that have maturity dates between 2026/1 and 2026/6, 7 assets (8.7% of total balance) that have maturity dates between 2026/7 and 2026/12, 32 assets (75.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 1 assets (1.5% of total balance) that have maturity dates between 2031/1 and 2031/6 and 1 assets (3.8% of total balance) that have maturity dates between 2036/7 and 2036/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
