## Transaction Summary

The transaction closed on Jun 21 2018 and matures in Jun 2029. The pool's current aggregate principal balance is \$664.1 million compared to \$668.4 million at close.

The largest loan of the pool (9.8%) is secured by 636 11th Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was The Ogilvy Group Inc (99.18%). The second largest loan of the pool (9.0%) is secured by 65 Bay Street - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included CVS (0.00%) and CycleBar (0.00%). The third largest loan of the pool (8.9%) is secured by Flats at East Bank located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Punch Bowl Social (0.00%) and Thirsty Dog Brewery (0.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.74% and 32 months as of 12/10/2020, respectively. There are a total of 40 loans and 45 properties in the portfolio. The appraisal LTV was approximately 54.5% compared to the Original loan to value (LTV), which was approximately 54.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.29x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

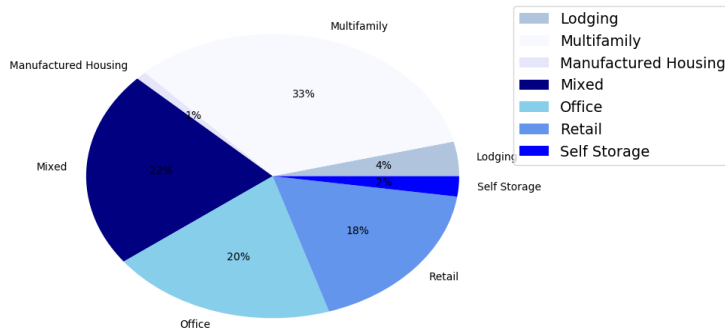

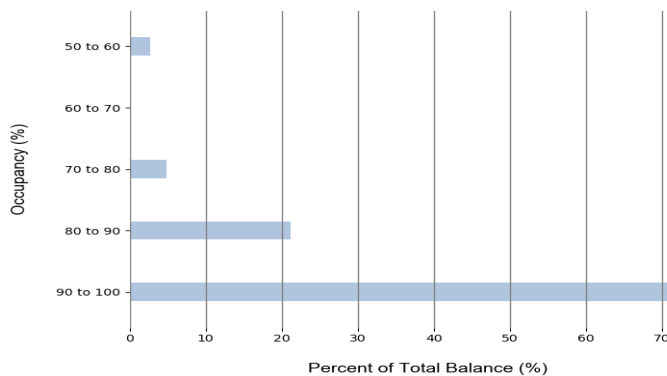

Occupancy Distribution (%)

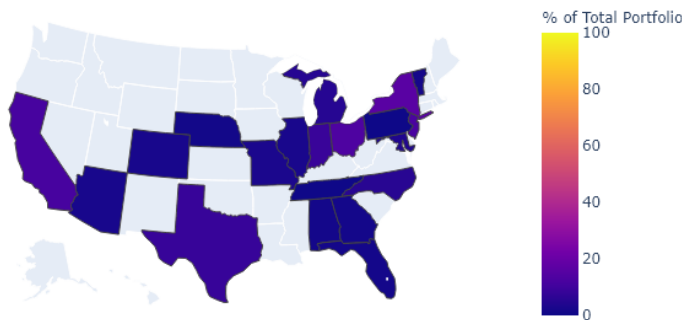

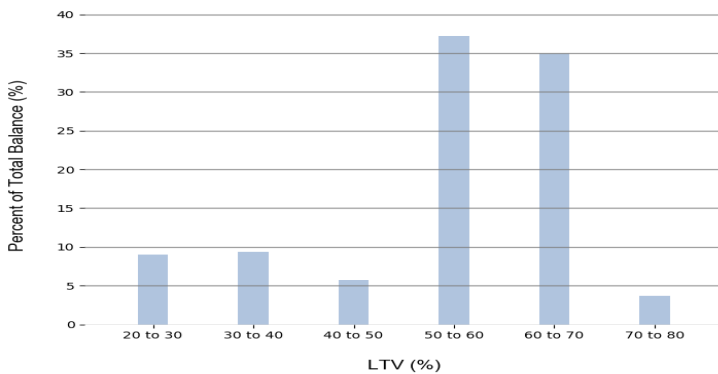
Local Distribution

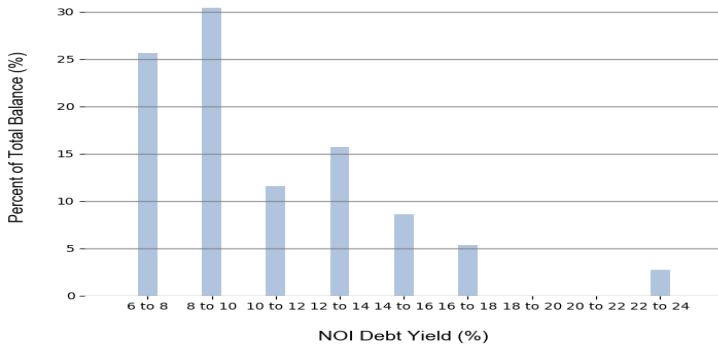

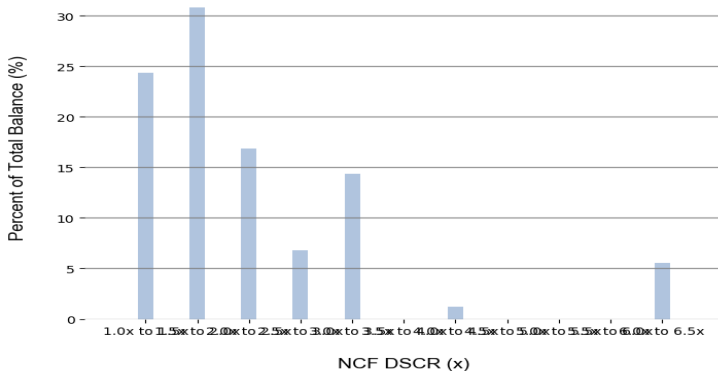
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 23% with a weighted average NOI debt yield of 10.9%. NOI debt yield ranged from 6% to 23%. There were 8 assets (26% of total balance) with NOI debt yield between 6% and 8%, 10 assets (30% of total balance) with NOI debt yield between 8% and 10%, 9 assets (12% of total balance) with NOI debt yield between 10% and 12%, 5 assets (16% of total balance) with NOI debt yield between 12% and 14%, 4 assets (9% of total balance) with NOI debt yield between 14% and 16%, 2 assets (5% of total balance) with NOI debt yield between 16% and 18%, 2 assets (3% of total balance) with NOI debt yield between 22% and 24%

Net Cash Flow DSCR (x)

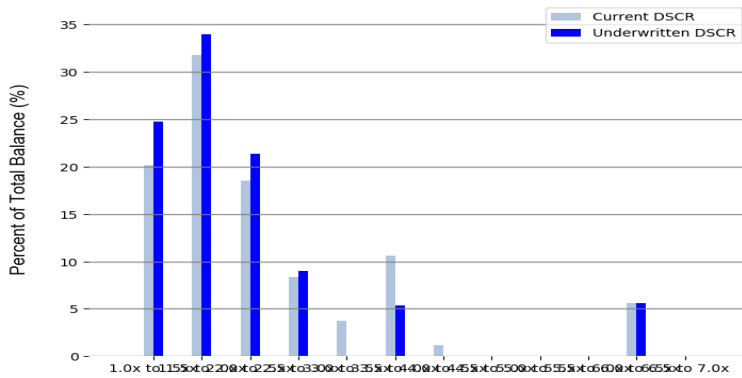


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 6.0x. There were 12 assets (24.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (30.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (16.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (6.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (14.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (1.2% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (5.6% of total balance) with NCF DSCR between 6.0x and 6.5x. The most recent weighted average NCF DSCR was 2.3x.

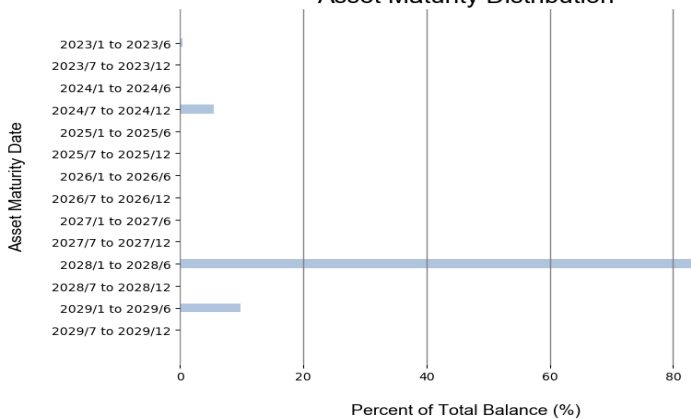
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 6.5x. There are 10 assets (20.2% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (31.8% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (18.6% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (8.3% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.8% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (10.6% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (1.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (5.6% of total balance) with DSCR between 6.0x and 6.5x. The most recent weighted average DSCR is 2.4x.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
