Transaction Summary

The transaction closed on Aug 11 2016 and matures in Aug 2036. The pool's current aggregate principal balance is \$866.1 million compared to \$894.1 million at close.

The largest loan of the pool (9.7%) is secured by Westfield San Francisco Centre - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 95%. The major tenants included San Francisco State University (15.79%) and Crunchyroll, Inc. (9.01%). The second largest loan of the pool (9.6%) is secured by Center 21 located in Oakland-Hayward-Berkeley, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included PANDORA MEDIA (26.86%) and Kaiser Foundation Health Plan (13.95%). The third largest loan of the pool (7.5%) is secured by Opry Mills located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Bass Pro Shops (11.13%) and Unknown (8.55%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 54 months as of 12/10/2020, respectively. There are a total of 32 loans and 55 properties in the portfolio. The appraisal LTV was approximately 53.3% compared to the Original loan to value (LTV), which was approximately 54.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.34x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

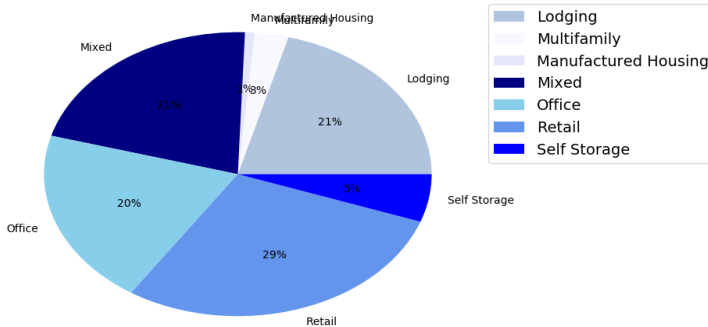

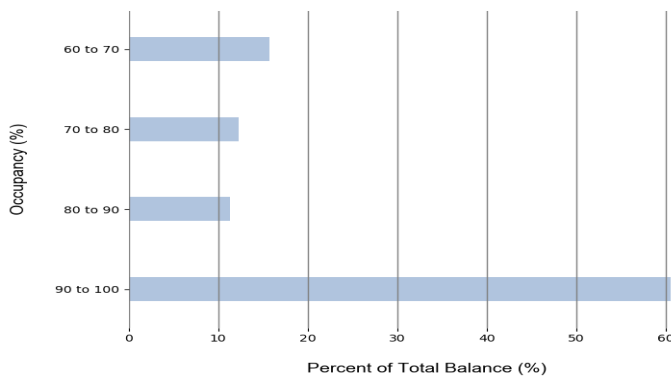

Occupancy Distribution (%)

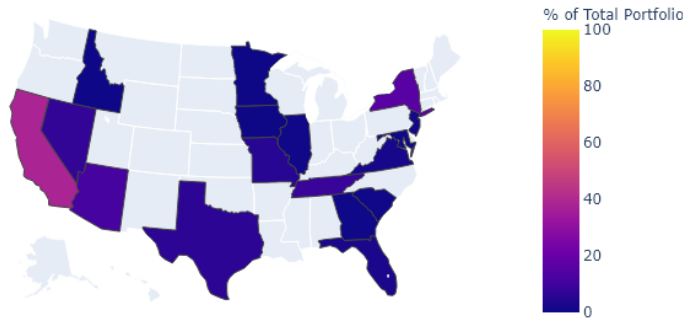

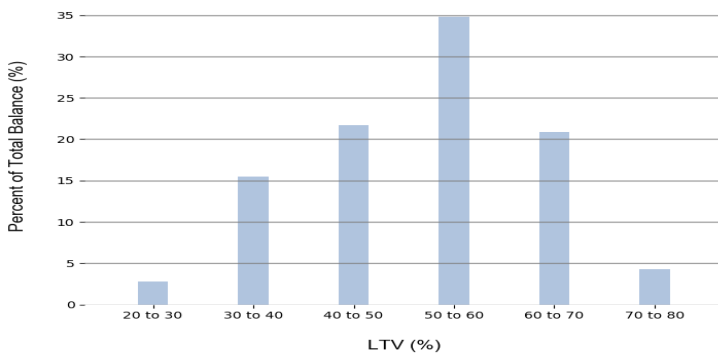
Local Distribution

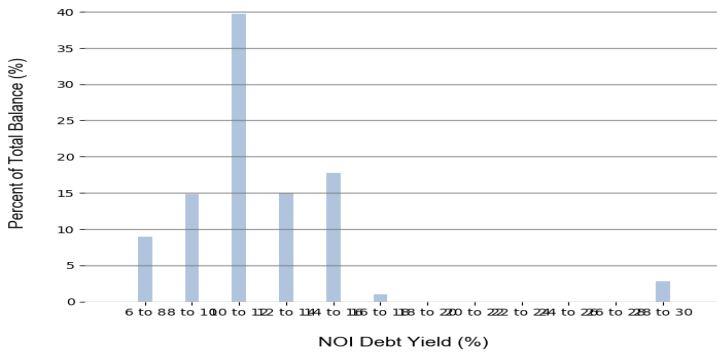

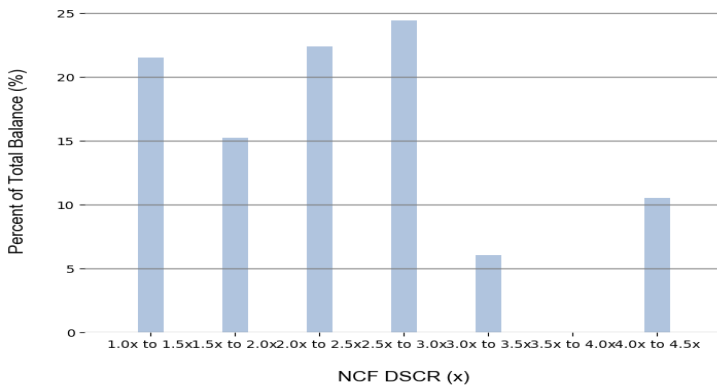
NOI Debt Yield (%)

There were 2 assets (9% of total balance) with NOI debt yield between 6% and 8%, 7 assets (15% of total balance) with NOI debt yield between 8% and 10%, 9 assets (40% of total balance) with NOI debt yield between 10% and 12%, 7 assets (15% of total balance) with NOI debt yield between 12% and 14%, 5 assets (18% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (3% of total balance) with NOI debt yield between 28% and 30%

Net Cash Flow DSCR (x)

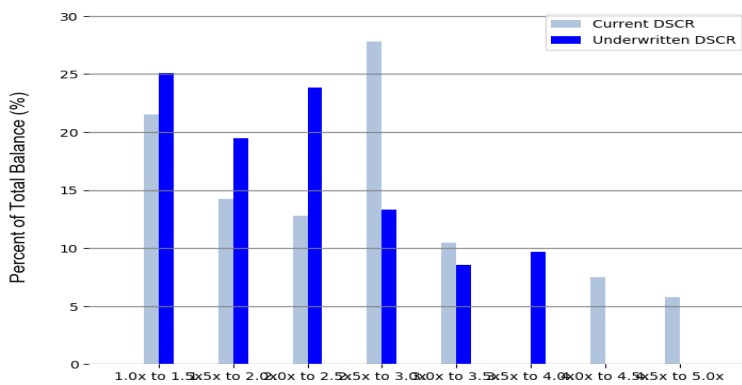


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 9 assets (21.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (15.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (22.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (24.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (6.0% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (10.5% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 2.3x.

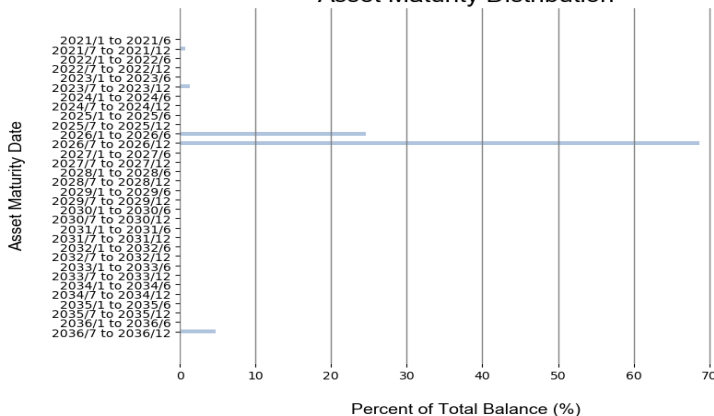
DSCR Distribution (x)



DSCRs ranged from 1.0x to 5.0x. There are 9 assets (21.5% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (14.2% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (12.8% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (27.8% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (10.5% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (7.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (5.8% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.5x.

There are 1 assets (0.7% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (1.3% of total balance) that have maturity dates between 2023/7 and 2023/12, 14 assets (24.6% of total balance) that have maturity dates between 2026/1 and 2026/6, 15 assets (68.7% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (4.7% of total balance) that have maturity dates between 2036/7 and 2036/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

Appendix I

Smoothing Calculation
