Transaction Summary

The transaction closed on Aug 11 2016 and matures in Aug 2036. The pool's current aggregate principal balance is \$849.4 million compared to \$887.5 million at close.

The largest loan of the pool (9.9%) is secured by Westfield San Francisco Centre - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 87%. The major tenants included San Francisco State University (15.79%) and Crunchyroll, Inc. (9.01%). The second largest loan of the pool (9.8%) is secured by Center 21 located in Oakland-Hayward-Berkeley, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included PANDORA MEDIA (26.86%) and Kaiser Foundation Health Plan (13.95%). The third largest loan of the pool (7.7%) is secured by Opry Mills located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Bass Pro Shops (11.13%) and Dave & Buster's (4.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 69 months as of 03/10/2022, respectively. There are a total of 31 loans and 54 properties in the portfolio. The appraisal LTV was approximately 53.3% compared to the Original loan to value (LTV), which was approximately 54.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.48x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 73%.








Local Distribution





Most recent net operating income debt yield ranged from -6% to 15% with a weighted average NOI debt yield of 8.0%. NOI debt yield ranged from -6% to 15%. There were 1 assets (1% of total balance) with NOI debt yield between -6% and -4%, 1 assets (4% of total balance) with NOI debt yield between -4% and -2%, 1 assets (2% of total balance) with NOI debt yield between -2% and 0%, 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 3 assets (8% of total balance) with NOI debt yield between 2% and 4%, 3 assets (6% of total balance) with NOI debt yield between 4% and 6%, 2 assets (17% of total balance) with NOI debt yield between 6% and 8%, 9 assets (18% of total balance) with NOI debt yield between 8% and 10%, 4 assets (21% of total balance) with NOI debt yield between 10% and 12%, 4 assets (14% of total balance) with NOI debt yield between 12% and 14% and 2 assets (6% of total balance) with NOI debt yield between 14% and 16%.

There were 2 assets (5.0% of total balance) with NCF DSCR between -1.0x and -0.5x, 1 assets (2.4% of total balance) with NCF DSCR between -0.5x and 0.0x, 5 assets (13.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (3.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (21.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 4 assets (7.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (23.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (12.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (5.9% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (4.6% of total balance) with NCF DSCR between 4.0x and 4.5x. 
DSCR (Current / Underwritten)

Current DSCR



DSCRs ranged from -1.0x to 4.5x. There are 1 assets (4.5% of total balance) with DSCR between -1.0x and -0.5x, 2 assets (2.9% of total balance) with DSCR between -0.5x and 0.0x, 3 assets (7.0% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (8.7% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (22.9% of total balance) with DSCR between 1.0x and 1.5x, 2 assets (3.1% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (25.9% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (9.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (5.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (5.9% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (4.6% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (11.3% of total balance) that have maturity dates between 2023/7 and 2023/12, 14 assets (210.3% of total balance) that have maturity dates between 2026/1 and 2026/6, 15 assets (588.6% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (39.2% of total balance) that have maturity dates between 2036/7 and 2036/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
