Transaction Summary

The transaction closed on Jun 29 2017 and matures in May 2029. The pool's current aggregate principal balance is \$1118.7 million compared to \$1132.5 million at close.

The largest loan of the pool (8.4%) is secured by 245 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, National Association (13.08%). The second largest loan of the pool (7.6%) is secured by Gateway Net Lease Portfolio - Trust located in Warren-Troy-Farmington Hills, MI-5.73% Dallas-Plano-Irving, TX-3.81% Detroit-Dearborn-Livonia, MI-3.77% Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-0.63% metropolitan area. Occupancy at the subject was 100%. The major tenants included FedEx (14.28%) and CARRIER (9.76%). The third largest loan of the pool (7.2%) is secured by Olympic Tower - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included NBA Properties, Inc. (36.54%) and Richemont North America, Inc. (24.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 41 months as of 10/10/2020, respectively. There are a total of 41 loans and 196 properties in the portfolio. The appraisal LTV was approximately 57.5% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.20x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

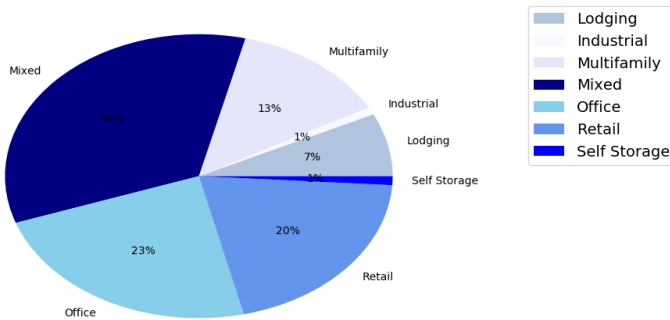

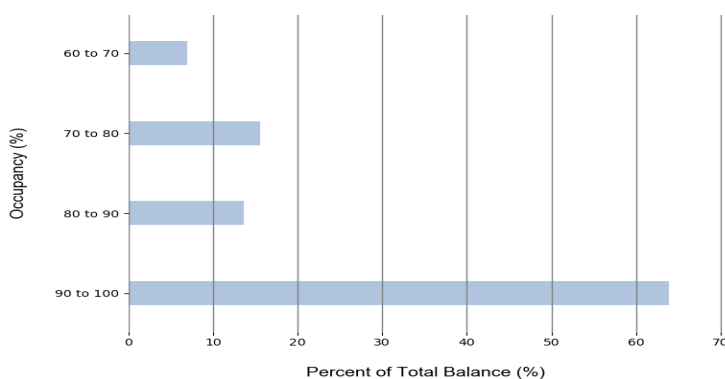

Occupancy Distribution (%)

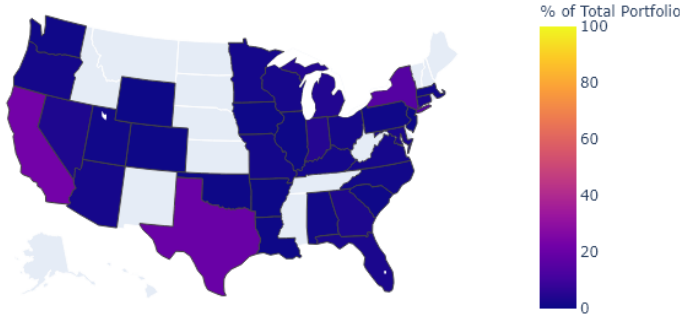

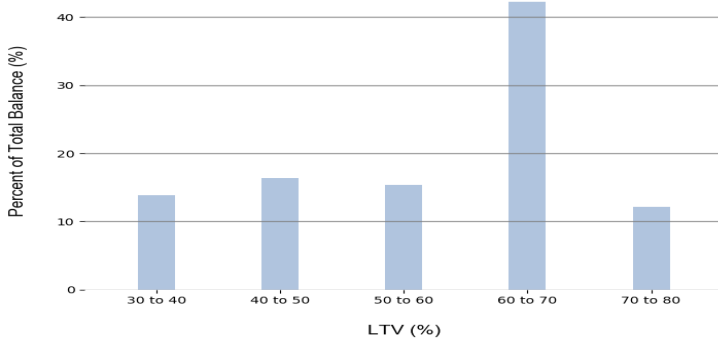
Local Distribution

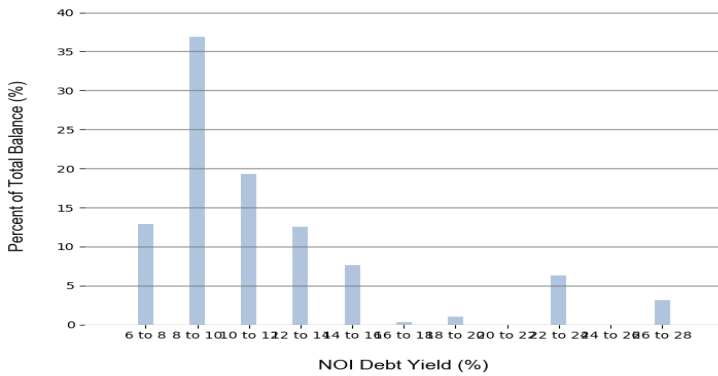

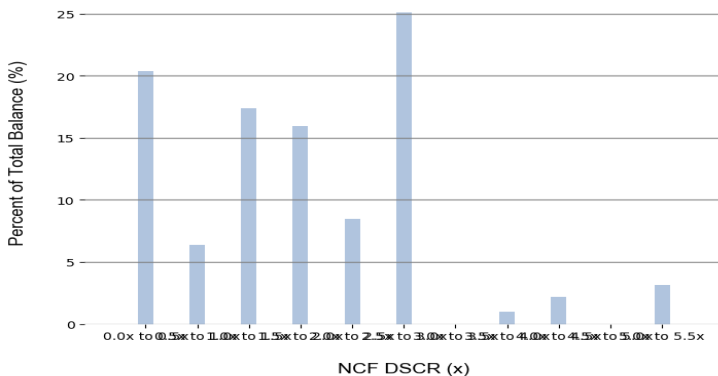
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

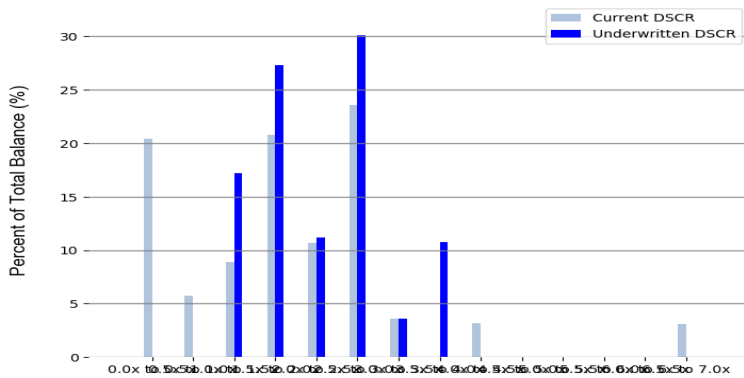

There were 4 assets (20.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (6.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (17.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 9 assets (15.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (8.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (25.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (2.2% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (3.1% of total balance) with NCF DSCR between 5.0x and 5.5x. 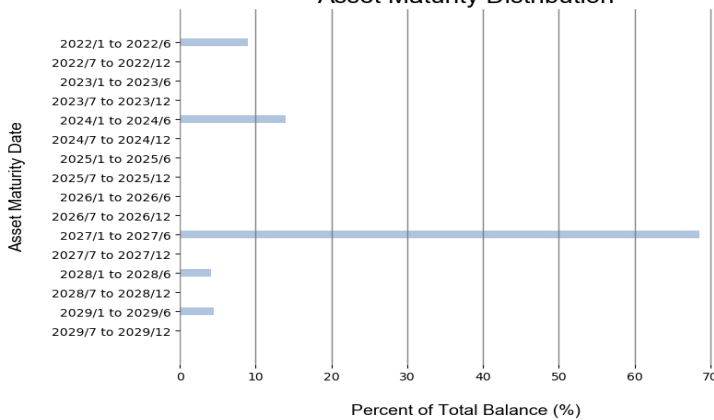
DSCR Distribution (x)



DSCRs ranged from 0.0x to 7.0x. There are 4 assets (20.4% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (5.8% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (8.9% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (20.8% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (10.7% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (23.6% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.6% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (3.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (3.1% of total balance) with DSCR between 6.5x and 7.0x. The most recent weighted average DSCR is 2.4x.

There are 5 assets (9.0% of total balance) that have maturity dates between 2022/1 and 2022/6, 3 assets (14.0% of total balance) that have maturity dates between 2024/1 and 2024/6, 31 assets (68.5% of total balance) that have maturity dates between 2027/1 and 2027/6, 1 assets (4.1% of total balance) that have maturity dates between 2028/1 and 2028/6 and 1 assets (4.5% of total balance) that have maturity dates between 2029/1 and 2029/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
