Transaction Summary

The transaction closed on Jun 29 2017 and matures in May 2029. The pool's current aggregate principal balance is \$1118.7 million compared to \$1132.5 million at close.

The largest loan of the pool (8.4%) is secured by 245 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Societe Generale (32.62%) and JPMorgan Chase Bank, National Association (13.08%). The second largest loan of the pool (7.6%) is secured by Gateway Net Lease Portfolio - Trust located in Warren-Troy-Farmington Hills, MI-5.73% Dallas-Plano-Irving, TX-3.81% Detroit-Dearborn-Livonia, MI-3.77% Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-0.63% metropolitan area. Occupancy at the subject was 100%. The major tenants included FedEx (14.28%) and CARRIER (9.76%). The third largest loan of the pool (7.2%) is secured by Olympic Tower - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included NBA Properties, Inc. (36.54%) and Richemont North America, Inc. (24.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 41 months as of 10/10/2020, respectively. There are a total of 41 loans and 196 properties in the portfolio. The appraisal LTV was approximately 57.5% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.20x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.








Local Distribution





Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 11.7%. NOI debt yield ranged from 6% to 27%. There were 5 assets (13% of total balance) with NOI debt yield between 6% and 8%, 16 assets (37% of total balance) with NOI debt yield between 8% and 10%, 9 assets (19% of total balance) with NOI debt yield between 10% and 12%, 5 assets (13% of total balance) with NOI debt yield between 12% and 14%, 1 assets (8% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 2 assets (6% of total balance) with NOI debt yield between 22% and 24%, 1 assets (3% of total balance) with NOI debt yield between 26% and 28%

There were 4 assets (20.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (6.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (17.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 9 assets (15.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (8.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (25.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (2.2% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (3.1% of total balance) with NCF DSCR between 5.0x and 5.5x. 



DSCRs ranged from 0.0x to 7.0x. There are 4 assets (20.4% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (5.8% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (8.9% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (20.8% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (10.7% of total balance) with DSCR between 2.0x and 2.5x. 6 assets (23.6% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.6% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (3.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (3.1% of total balance) with DSCR between 6.5x and 7.0x. The most recent weighted average DSCR is 2.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
