Transaction Summary

The transaction closed on Aug 28 2020 and matures in Mar 2032. The pool's current aggregate principal balance is \$630.7 million compared to \$630.9 million at close.

The largest loan of the pool (9.7%) is secured by Agellan Portfolio - Trust located in Fort Worth-Arlington, TX-4.15% Elgin, IL-2.99% metropolitan area. Occupancy at the subject was 90%. The major tenants included United Natural Foods, Inc. (7.60%) and General Motors (6.56%). The second largest loan of the pool (7.9%) is secured by MGM Grand & Mandalay Bay - Trust located in metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (7.9%) is secured by BX Industrial Portfolio - Trust located in Dallas-Plano-Irving, TX-5.93% Washington-Arlington-Alexandria, DC-VA-MD-WV-3.11% Lake County-Kenosha County, IL-WI-1.88% Newark, NJ-PA-1.54% metropolitan area. Occupancy at the subject was 87%. The major tenants included Amazon.com (6.26%) and DHL Airways (5.94%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.66% and 5 months as of 10/15/2020, respectively. There are a total of 31 loans and 146 properties in the portfolio. The appraisal LTV was approximately 48.8% compared to the Original loan to value (LTV), which was approximately 48.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.85x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





Occupancy Distribution (%)




Local Distribution



Most recent net operating income debt yield ranged from 0% to 31% with a weighted average NOI debt yield of 13.6%. NOI debt yield ranged from 0% to 31%. There were 2 assets (4% of total balance) with NOI debt yield between 0% and 2%, 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 6 assets (21% of total balance) with NOI debt yield between 6% and 8%, 10 assets (21% of total balance) with NOI debt yield between 8% and 10%, 4 assets (12% of total balance) with NOI debt yield between 10% and 12%, 4 assets (16% of total balance) with NOI debt yield between 12% and 14%, 1 assets (2% of total balance) with NOI debt yield between 14% and 16%, 1 assets (10% of total balance) with NOI debt yield between 16% and 18%, 1 assets (5% of total balance) with NOI debt yield between 20% and 22%, 1 assets (8% of total balance) with NOI debt yield between 30% and 32%

NCF DSCR ranged from 0.0x to 3.0x. There were 29 assets (90.5% of total balance) with NCF DSCR between 0.0x and 0.5x and 2 assets (9.5% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 2.9x.







DSCRs ranged from 0.0x to 3.0x. There are 30 assets (96.8% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (3.2% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.9x.

There are 3 assets (7.7% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (9.7% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (7.9% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (2.4% of total balance) that have maturity dates between 2027/1 and 2027/6, 1 assets (3.2% of total balance) that have maturity dates between 2028/7 and 2028/12, 2 assets (11.9% of total balance) that have maturity dates between 2029/7 and 2029/12, 11 assets (22.5% of total balance) that have maturity dates between 2030/1 and 2030/6, 10 assets (26.8% of total balance) that have maturity dates between 2030/7 and 2030/12 and 1 assets (7.9% of total balance) that have maturity dates between 2032/1 and 2032/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
