## **Transaction Summary**

The transaction closed on Feb 03 2014 and matures in Jan 2024. The pool's current aggregate principal balance is \$885.9 million compared to \$976.3 million at close.

The largest loan of the pool (11.8%) is secured by The Shops at Canal Place located in metropolitan area. Occupancy at the subject was 85%. The major tenants included Saks Fifth Avenue (49.35%) and WESTIN CONFERENCE CENTER (8.10%). The second largest loan of the pool (10.6%) is secured by CityScape - East Office/Retail located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Alliance Bank of Arizona - (17.68%) and United HealthCare (14.27%). The third largest loan of the pool (9.9%) is secured by The Crossroads located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Burlington Coat Factory (23.51%) and H&M (6.35%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 84 months as of 12/10/2020, respectively. There are a total of 66 loans and 126 properties in the portfolio. The appraisal LTV was approximately 79.4% compared to the Original loan to value (LTV), which was approximately 66.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.51x. As of 12/10/2020, 1.74% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.






### Local Distribution





Most recent net operating income debt yield ranged from 2% to 35% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 2% to 35%. 



DSCRs ranged from 0.5x to 5.0x.There are 3 assets (2.8% of total balance) with DSCR between 0.5x and 1.0x, 17 assets (56.0% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (17.2% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (14.2% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (8.6% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.1% of total balance) with DSCR between 4.5x and 5.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
