Transaction Summary

The transaction closed on Feb 03 2014 and matures in Jan 2024. The pool's current aggregate principal balance is \$677.7 million compared to \$764.0 million at close.

The largest loan of the pool (15.1%) is secured by The Shops at Canal Place located in metropolitan area. Occupancy at the subject was 97%. The major tenants included Saks Fifth Avenue (49.35%) and The Prytania at Canal Place (10.03%). The second largest loan of the pool (13.5%) is secured by CityScape - East Office/Retail located in metropolitan area. Occupancy at the subject was 85%. The major tenants included Alliance Bank of Arizona (25.39%) and United HealthCare (14.27%). The third largest loan of the pool (1.9%) is secured by Blue Doors Carolinas located in metropolitan area. Occupancy at the subject was 79%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.08% and 99 months as of 03/10/2022, respectively. There are a total of 62 loans and 122 properties in the portfolio. The appraisal LTV was approximately 59.6% compared to the Original loan to value (LTV), which was approximately 66.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.40x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

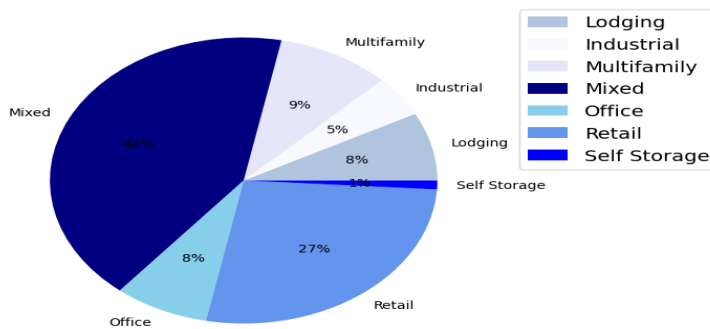

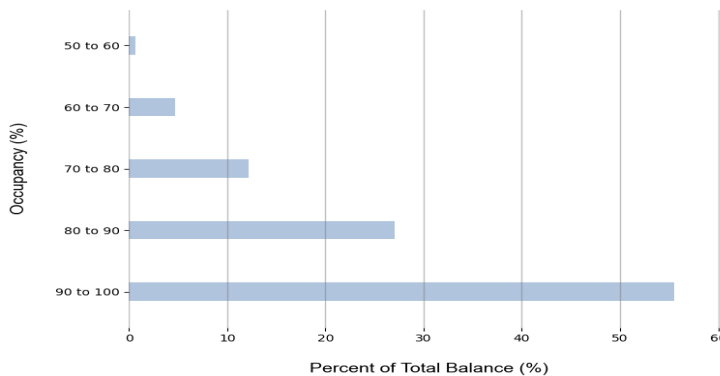

Occupancy Distribution (%)

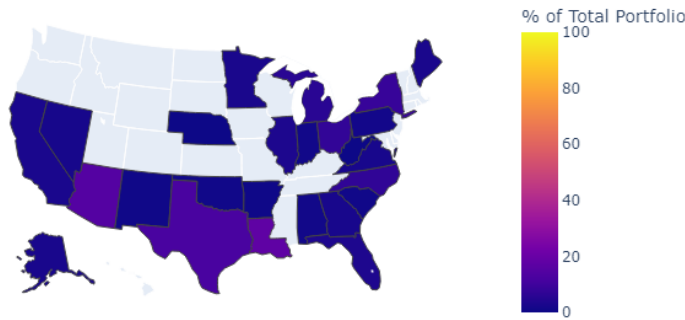

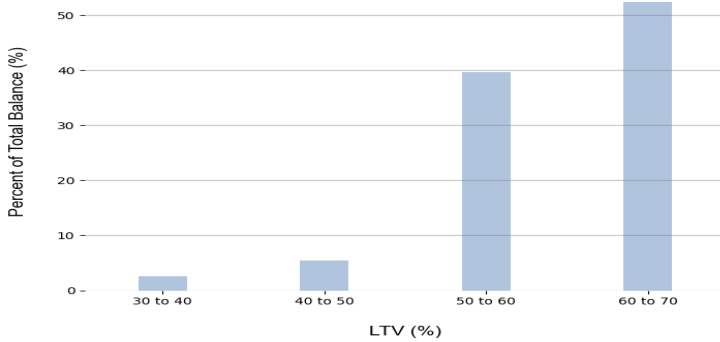
Local Distribution



Among assets in the portfolio, there are 8 properties (17% of total balance) located in Louisiana, 5 properties (15% of total balance) in Arizona, 27 properties (12% of total balance) in Texas, 9 properties (8% of total balance) in New York, 15 properties (7% of total balance) in Ohio, 7 properties (7% of total balance) in North Carolina and 9 properties (6% of total balance) in Michigan. Other properties are located in the state of Illinois, California, Minnesota, Maine, Alaska, Georgia, Virginia, Nevada, Pennsylvania, Alabama, Indiana, Oklahoma, South Carolina, New Mexico, Arkansas, West Virginia and Nebraska.

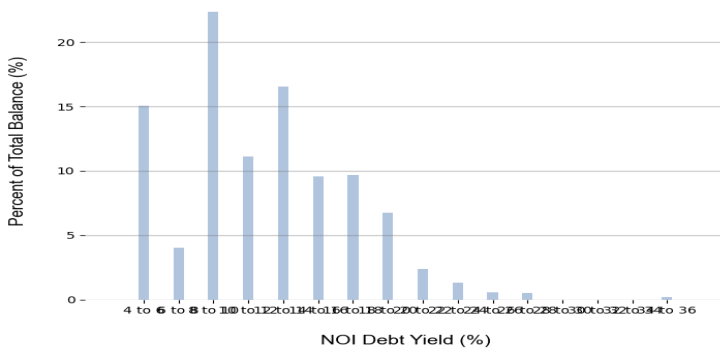

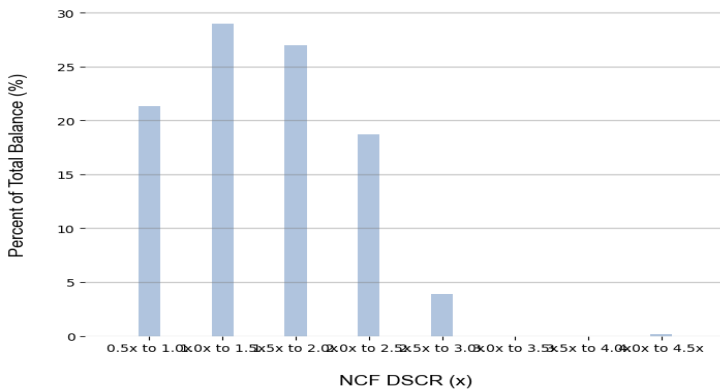
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 35% with a weighted average NOI debt yield of 11.9%. NOI debt yield ranged from 4% to 35%. 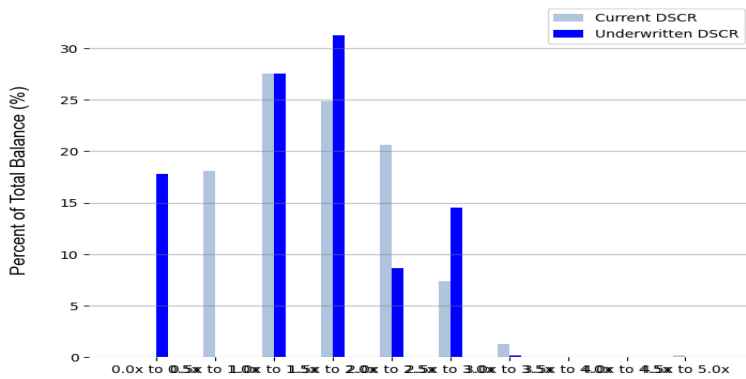
Net Cash Flow DSCR (x)

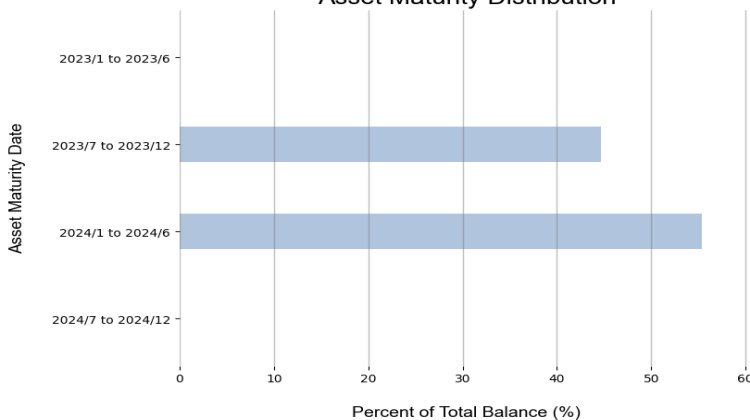
DSCR Distribution (x)



DSCRs ranged from 0.5x to 5.0x. There are 3 assets (18.1% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (27.6% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (24.9% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (20.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (7.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (1.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


