Transaction Summary

The transaction closed on Apr 15 2014 and matures in Apr 2024. The pool's current aggregate principal balance is \$655.5 million compared to \$739.1 million at close.

The largest loan of the pool (12.1%) is secured by Greene Town Center located in metropolitan area. Occupancy at the subject was 93%. The major tenants included LA Fitness (7.24%) and Nordstrom Rack (4.95%). The second largest loan of the pool (5.4%) is secured by Sheraton Suites Houston located in metropolitan area. Occupancy at the subject was 73%. The third largest loan of the pool (5.3%) is secured by Greenville Center located in Wilmington, DE-MD-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JANSSEN'S MARKET LLC (14.94%) and Wells Fargo Bank (10.27%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.02% and 97 months as of 03/10/2022, respectively. There are a total of 53 loans and 62 properties in the portfolio. The appraisal LTV was approximately 69.8% compared to the Original loan to value (LTV), which was approximately 67.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.44x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





Occupancy Distribution (%)






Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
