Transaction Summary

The transaction closed on Jun 24 2014 and matures in May 2029. The pool's current aggregate principal balance is \$817.2 million compared to \$865.9 million at close.

The largest loan of the pool (13.5%) is secured by Maine Mall located in metropolitan area. Occupancy at the subject was 76%. The major tenants included JC Penney (11.76%) and Best Buy (6.27%). The second largest loan of the pool (12.2%) is secured by Selig Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 96%. The major tenants included Amazon.com (17.64%) and Sound Transit (5.54%). The third largest loan of the pool (10.4%) is secured by EpiCentre located in metropolitan area. Occupancy at the subject was 78%. The major tenants included STUDIO MOVIE GRILL (10.73%) and Bowlero Charlotte LLC (8.83%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.72% and 79 months as of 12/10/2020, respectively. There are a total of 55 loans and 84 properties in the portfolio. The appraisal LTV was approximately 65.6% compared to the Original loan to value (LTV), which was approximately 66.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.80x. As of 12/10/2020, 18.67% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.

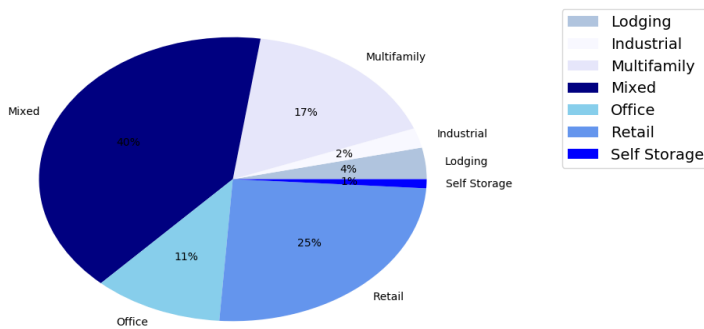

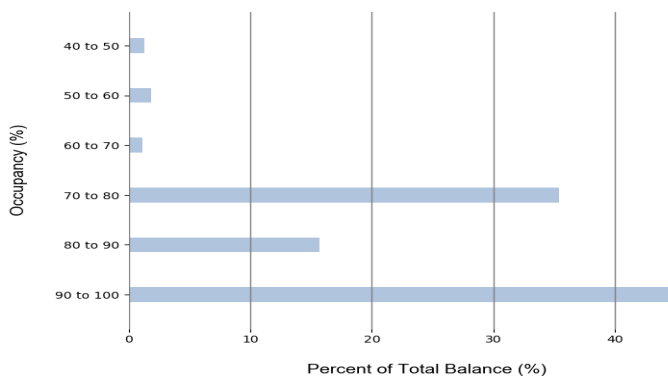

Occupancy Distribution (%)

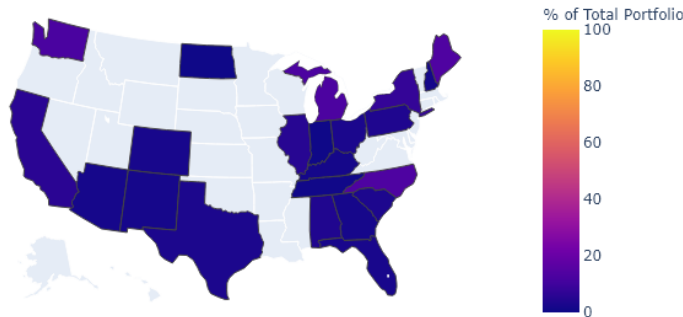

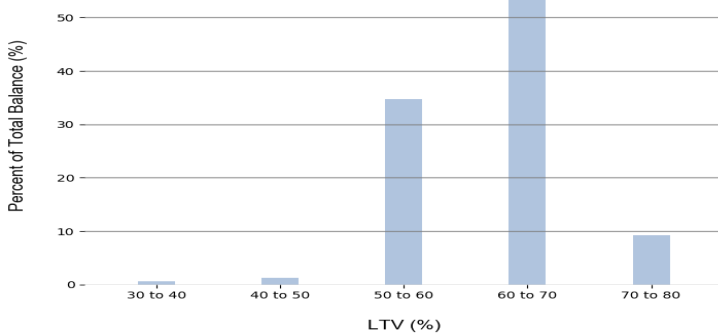
Local Distribution

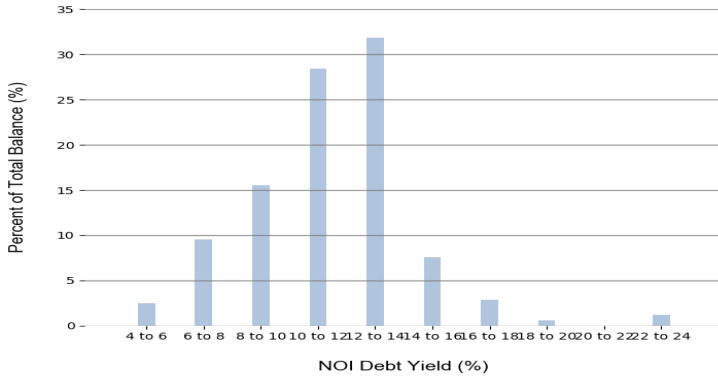

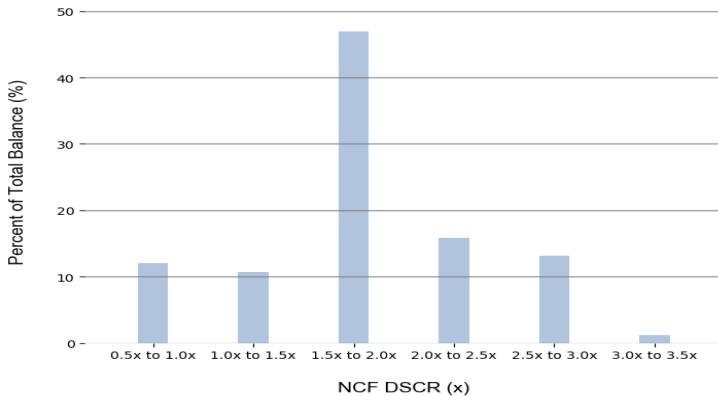
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

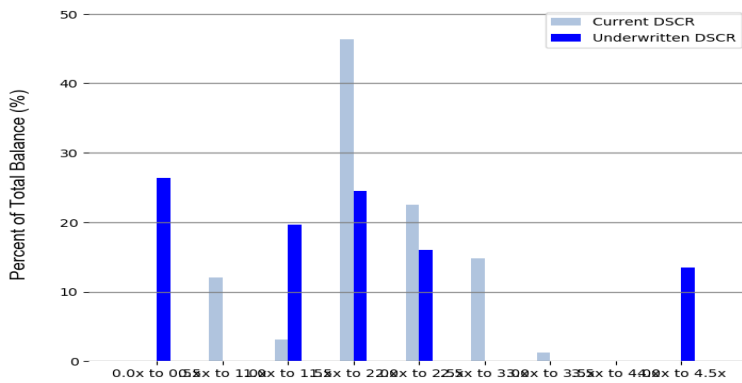

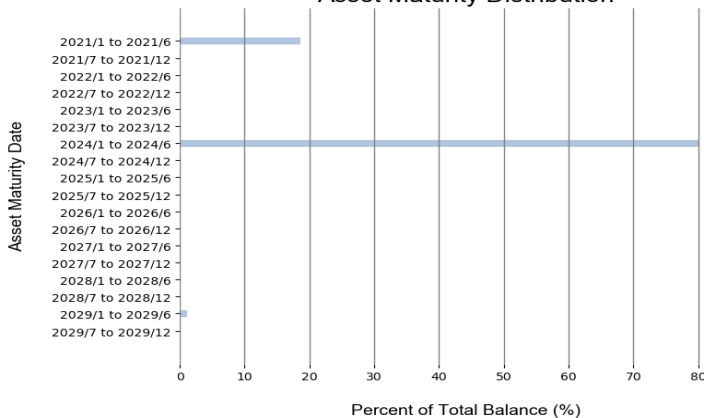
DSCR Distribution (x)



DSCRs ranged from 0.5x to 3.5x. There are 5 assets (12.0% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (3.1% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (46.3% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (22.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (14.8% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (1.2% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.9x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Appendix I

Smoothing Calculation
