Transaction Summary

The transaction closed on Jun 24 2014 and matures in May 2029. The pool's current aggregate principal balance is \$732.1 million compared to \$787.5 million at close.

The largest loan of the pool (15.0%) is secured by Maine Mall located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Jordan Furniture Gallery LLC (16.39%) and JC Penney (11.76%). The second largest loan of the pool (13.7%) is secured by Selig Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 84%. The major tenants included Amazon.com (17.65%) and Sound Transit (5.54%). The third largest loan of the pool (11.6%) is secured by EpiCentre located in metropolitan area. Occupancy at the subject was 38%. The major tenants included Bowlero Charlotte LLC (8.83%) and North Carolina CVS Pharmacy (4.50%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.71% and 94 months as of 03/10/2022, respectively. There are a total of 51 loans and 80 properties in the portfolio. The appraisal LTV was approximately 68.4% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.42x. As of 03/10/2022, 11.61% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 29% with a weighted average NOI debt yield of 10.1%. NOI debt yield ranged from 0% to 29%. There were 3 assets (14.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (2.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (27.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 21 assets (32.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (22.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (0.6% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.8% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.4x.







DSCRs ranged from 0.0x to 4.5x.There are 2 assets (12.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (3.3% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (20.9% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (34.4% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (25.4% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (2.4% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.8% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
