Transaction Summary

The transaction closed on Sep 29 2014 and matures in Sep 2044. The pool's current aggregate principal balance is \$957.3 million compared to \$1016.5 million at close.

The largest loan of the pool (14.4%) is secured by Stamford Plaza Portfolio located in metropolitan area. Occupancy at the subject was 67%. The major tenants included Merrill Lynch (5.33%) and BERKLEY FACULTATIVE REINSURANCE SERVICES (4.69%). The second largest loan of the pool (11.6%) is secured by Coastal Grand Mall located in metropolitan area. Occupancy at the subject was 98%. The major tenants included JC Penney (9.52%) and Dick's Clothing and Sporting Goods (4.76%). The third largest loan of the pool (9.1%) is secured by Beverly Connection located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 95%. The major tenants included City Target (28.88%) and Marshall's (9.90%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 74 months as of 10/10/2020, respectively. There are a total of 66 loans and 108 properties in the portfolio. The appraisal LTV was approximately 65.0% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.67x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 10.4%. NOI debt yield ranged from 2% to 19%. There were 2 assets (17% of total balance) with NOI debt yield between 2% and 4%, 4 assets (13% of total balance) with NOI debt yield between 6% and 8%, 10 assets (14% of total balance) with NOI debt yield between 8% and 10%, 17 assets (17% of total balance) with NOI debt yield between 10% and 12%, 15 assets (14% of total balance) with NOI debt yield between 12% and 14%, 12 assets (20% of total balance) with NOI debt yield between 14% and 16%, 3 assets (1% of total balance) with NOI debt yield between 16% and 18%, 3 assets (4% of total balance) with NOI debt yield between 18% and 20%

There were 1 assets (2.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (16.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 20 assets (17.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 26 assets (34.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (20.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (2.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (3.3% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (3.1% of total balance) with NCF DSCR between 4.0x and 4.5x. 



There are 1 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (16.3% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (8.1% of total balance) with DSCR between 1.0x and 1.5x, 33 assets (37.7% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (23.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (6.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.1% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.1% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
