Transaction Summary

The transaction closed on Sep 29 2014 and matures in Sep 2044. The pool's current aggregate principal balance is \$954.6 million compared to \$1016.5 million at close.

The largest loan of the pool (14.4%) is secured by Stamford Plaza Portfolio located in metropolitan area. Occupancy at the subject was 67%. The major tenants included Merrill Lynch (5.33%) and LOXO ONCOLOGY INC (4.69%). The second largest loan of the pool (11.6%) is secured by Coastal Grand Mall located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Dillard's (14.66%) and Sears (14.03%). The third largest loan of the pool (9.2%) is secured by Beverly Connection located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 95%. The major tenants included City Target (28.88%) and Marshall's (9.90%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 76 months as of 12/10/2020, respectively. There are a total of 66 loans and 108 properties in the portfolio. The appraisal LTV was approximately 65.2% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.67x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.

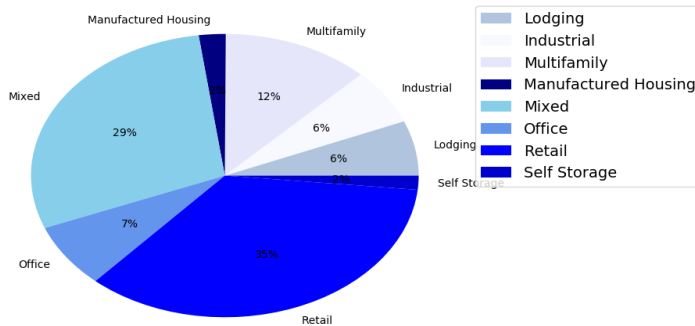

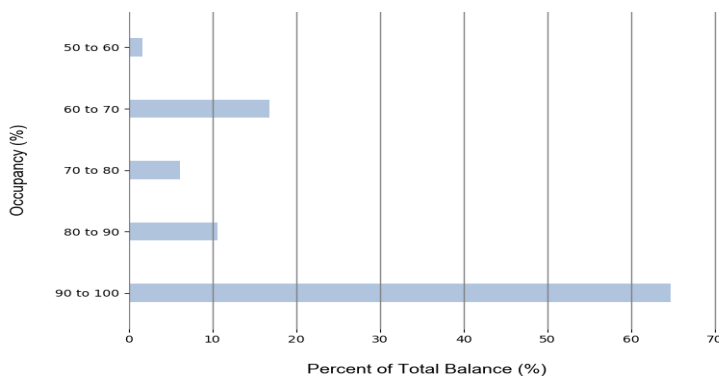

Occupancy Distribution (%)

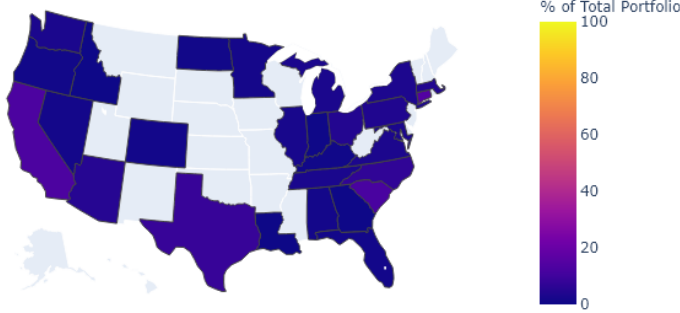

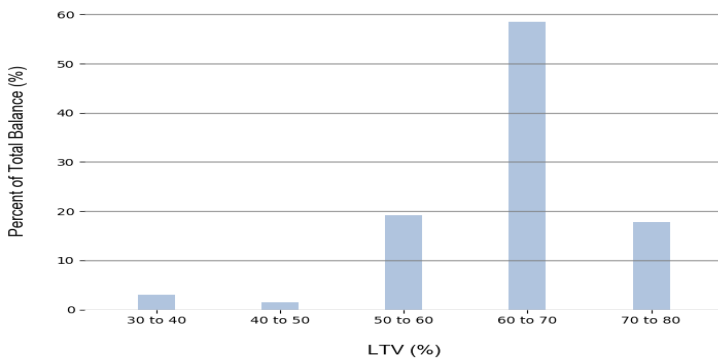
Local Distribution

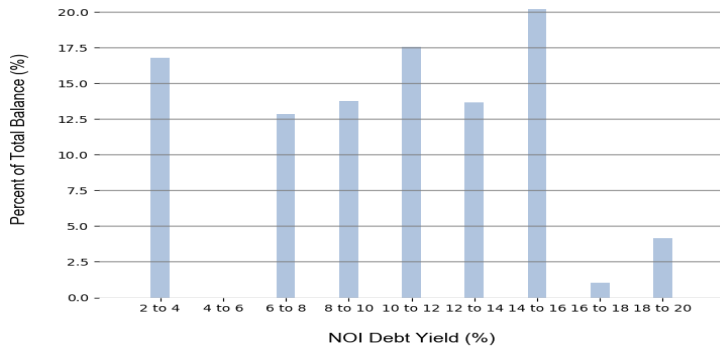

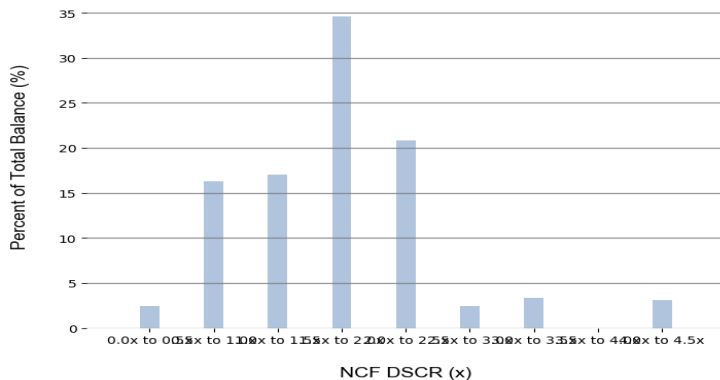
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

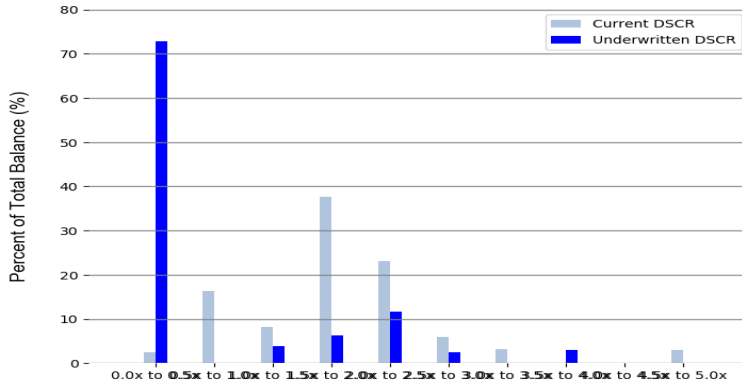

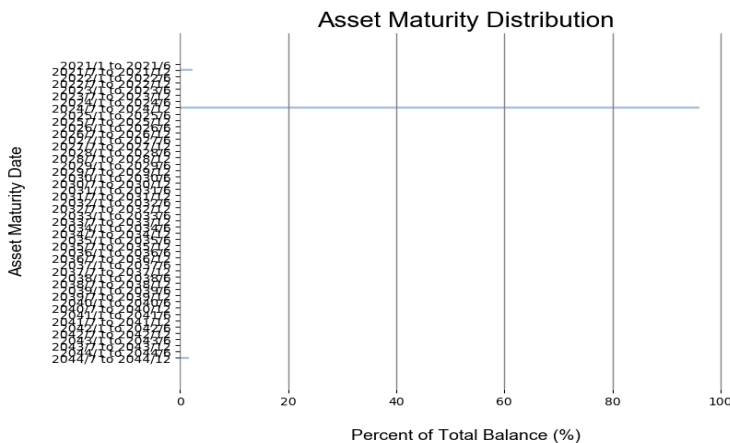

There are 1 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (16.3% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (8.1% of total balance) with DSCR between 1.0x and 1.5x, 33 assets (37.7% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (23.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (6.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.1% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.1% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
