## **Transaction Summary**

The transaction closed on Dec 08 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$1073.6 million compared to \$1138.5 million at close.

The largest loan of the pool (8.1%) is secured by Queen Ka'ahumanu Center located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Macy's (14.53%) and Macy's (14.02%). The second largest loan of the pool (7.5%) is secured by 1201 North Market Street located in Wilmington, DE-MD-NJ metropolitan area. Occupancy at the subject was 79%. The major tenants included Morris Nichols Arsht & Tunnell (18.45%) and Nuclear Insurance (8.68%). The third largest loan of the pool (7.3%) is secured by 5599 San Felipe located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Schlumberger Technologies (71.99%) and Weston Solutions Inc. (2.63%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.53% and 75 months as of 01/10/2021, respectively. There are a total of 81 loans and 120 properties in the portfolio. The appraisal LTV was approximately 66.8% compared to the Original loan to value (LTV), which was approximately 67.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.77x. As of 01/10/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





## Occupancy Distribution (%)






#### Local Distribution





Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 23%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 2 assets (9% of total balance) with NOI debt yield between 4% and 6%, 1 assets (0% of total balance) with NOI debt yield between 6% and 8%, 13 assets (32% of total balance) with NOI debt yield between 8% and 10%, 18 assets (19% of total balance) with NOI debt yield between 10% and 12%, 23 assets (25% of total balance) with NOI debt yield between 12% and 14%, 13 assets (6% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18%, 3 assets (3% of total balance) with NOI debt yield between 18% and 20%, 4 assets (2% of total balance) with NOI debt yield between 20% and 22% and 1 assets (0% of total balance) with NOI debt yield between 22% and 24%.

There were 1 assets (0.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (9.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (23.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (29.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 19 assets (25.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (9.5% of total balance) with NCF DSCR between 2.5x and 3.0x and 5 assets (2.3% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 1 assets (0.6% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (8.1% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (18.2% of total balance) with DSCR between 1.0x and 1.5x, 36 assets (33.0% of total balance) with DSCR between 1.5x and 2.0x, 19 assets (23.3% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (14.5% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (2.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.3% of total balance) with DSCR between 3.5x and 4.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
