## Transaction Summary

The transaction closed on May 29 2015 and matures in Apr 2045. The pool's current aggregate principal balance is \$1036.2 million compared to \$1097.3 million at close.

The largest loan of the pool (11.3%) is secured by Dallas Market Center located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 86%. The major tenants included GOETZ INC. (1.17%) and K.GRAVES & A. GRAVES INC dba C. MADDOX & COMPANY (0.90%). The second largest loan of the pool (11.9%) is secured by Selig Office Portfolio located in Seattle-Bellevue-Everett, WA-100.00% metropolitan area. Occupancy at the subject was 95%. The major tenants included WASHINGTON STATE FERRIES (5.30%) and EMERITUS CORPORATION (4.63%). The third largest loan of the pool (7.7%) is secured by Worthington Renaissance Fort Worth located in Fort Worth-Arlington, TX metropolitan area. Occupancy at the subject was 75%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.09% and 66 months as of 10/10/2020, respectively. There are a total of 82 loans and 106 properties in the portfolio. The appraisal LTV was approximately 63.0% compared to the Original loan to value (LTV), which was approximately 66.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.99x. As of 10/10/2020, 0.38% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

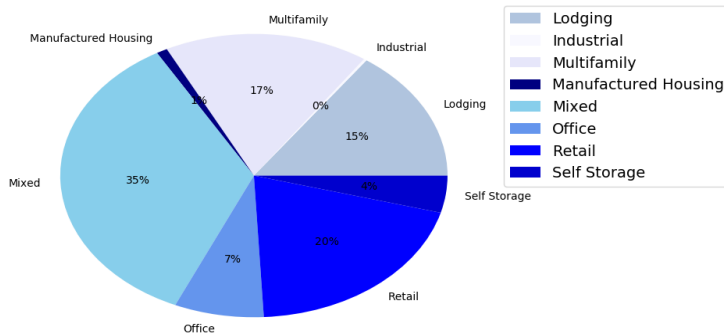

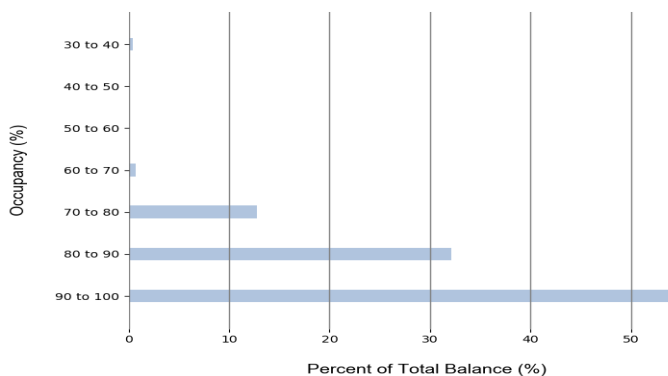

Occupancy Distribution (%)

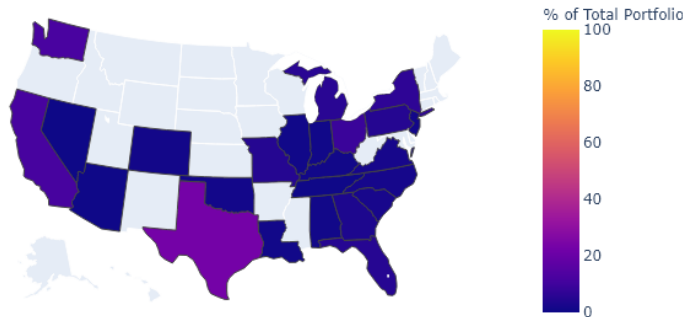

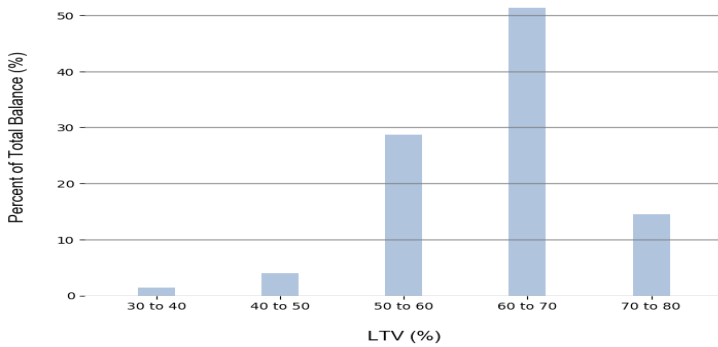
Local Distribution



Among assets in the portfolio, there are 10 properties (23% of total balance) located in Texas, 9 properties (12% of total balance) in Washington, 10 properties (11% of total balance) in California, 12 properties (9% of total balance) in Ohio, 6 properties (6% of total balance) in New York, 13 properties (5% of total balance) in Michigan, 8 properties (5% of total balance) in Florida and 4 properties (5% of total balance) in Pennsylvania. 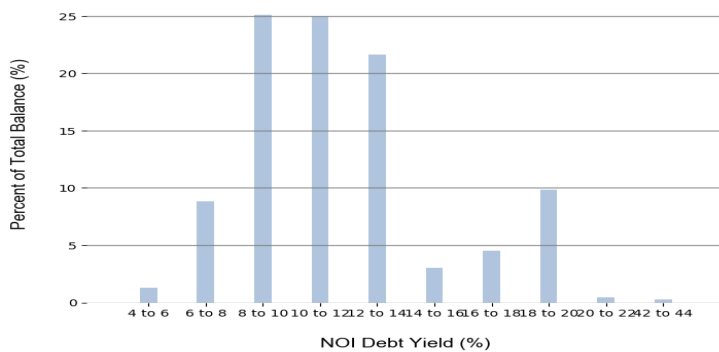

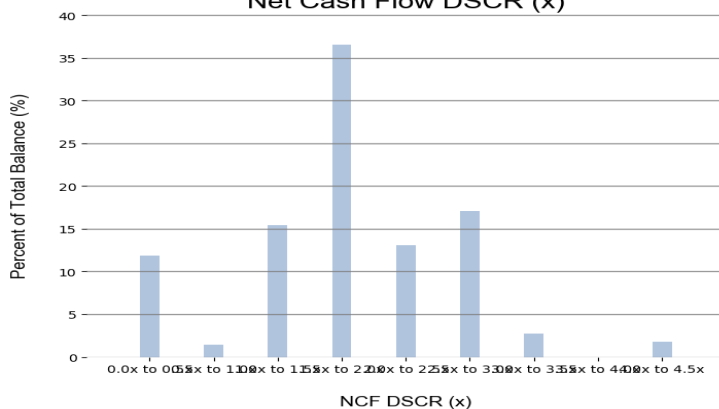
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 43% with a weighted average NOI debt yield of 11.9%. NOI debt yield ranged from 4% to 43%. There were 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 7 assets (9% of total balance) with NOI debt yield between 6% and 8%, 17 assets (25% of total balance) with NOI debt yield between 8% and 10%, 16 assets (25% of total balance) with NOI debt yield between 10% and 12%, 25 assets (22% of total balance) with NOI debt yield between 12% and 14%, 5 assets (3% of total balance) with NOI debt yield between 14% and 16%, 6 assets (5% of total balance) with NOI debt yield between 16% and 18%, 3 assets (10% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 20% and 22% and 1 assets (0% of total balance) with NOI debt yield between 42% and 44%.

Net Cash Flow DSCR (x)

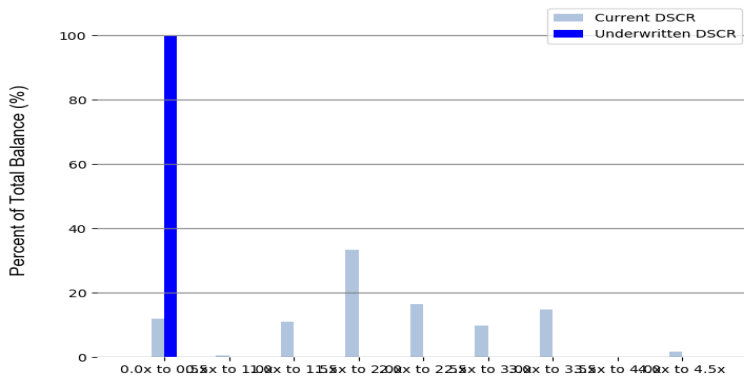

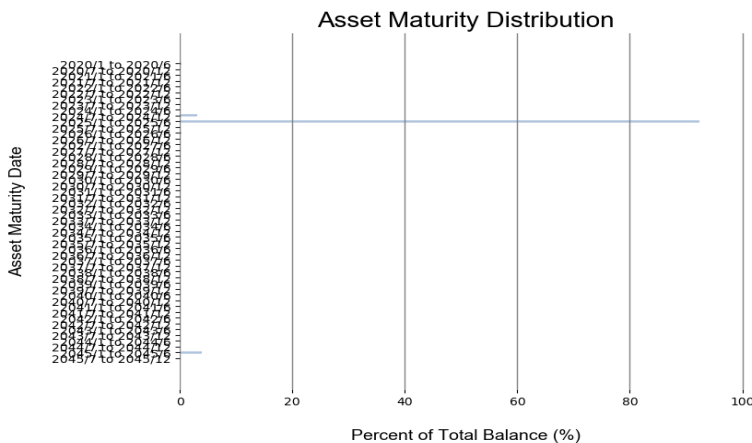

There are 1 assets (11.9% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.6% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (11.1% of total balance) with DSCR between 1.0x and 1.5x, 29 assets (33.5% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (16.5% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (9.8% of total balance) with DSCR between 2.5x and 3.0x, 11 assets (14.9% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (1.8% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (0.4% of total balance) that have maturity dates between 2020/1 and 2020/6, 1 assets (3.2% of total balance) that have maturity dates between 2024/7 and 2024/12, 77 assets (92.3% of total balance) that have maturity dates between 2025/1 and 2025/6, 1 assets (0.3% of total balance) that have maturity dates between 2026/1 and 2026/6 and 2 assets (3.9% of total balance) that have maturity dates between 2045/1 and 2045/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
