Transaction Summary

The transaction closed on Jul 31 2015 and matures in Jul 2025. The pool's current aggregate principal balance is \$874.8 million compared to \$962.0 million at close.

The largest loan of the pool (10.1%) is secured by Ascentia MHC Portfolio located in metropolitan area. Occupancy at the subject was 93%. The second largest loan of the pool (8.2%) is secured by Fig Garden Village located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Whole Foods Market (10.30%) and CVS (7.76%). The third largest loan of the pool (7.0%) is secured by Bassett Place located in metropolitan area. Occupancy at the subject was 96%. The major tenants included Target (19.63%) and Kohl's Department Store (13.90%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 81 months as of 04/10/2022, respectively. There are a total of 60 loans and 112 properties in the portfolio. The appraisal LTV was approximately 63.0% compared to the Original loan to value (LTV), which was approximately 66.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.21x. As of 04/10/2022, 0.93% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from -2% to 17% with a weighted average NOI debt yield of 9.2%. NOI debt yield ranged from -2% to 17%. There were 2 assets (8% of total balance) with NOI debt yield between -2% and 0%, 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 5 assets (5% of total balance) with NOI debt yield between 4% and 6%, 6 assets (8% of total balance) with NOI debt yield between 6% and 8%, 18 assets (36% of total balance) with NOI debt yield between 8% and 10%, 15 assets (14% of total balance) with NOI debt yield between 10% and 12%, 5 assets (18% of total balance) with NOI debt yield between 12% and 14%, 6 assets (6% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from -0.5x to 3.5x. There were 1 assets (0.9% of total balance) with NCF DSCR between -0.5x and 0.0x, 4 assets (11.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 7 assets (8.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 28 assets (44.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (20.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (4.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (8.6% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (1.3% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.2x.







DSCRs ranged from 0.0x to 4.0x.There are 4 assets (9.3% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (9.6% of total balance) with DSCR between 0.5x and 1.0x, 23 assets (31.7% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (25.0% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (12.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (10.6% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.3% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
