Transaction Summary

The transaction closed on Dec 01 2015 and matures in Nov 2025. The pool's current aggregate principal balance is \$779.9 million compared to \$820.8 million at close.

The largest loan of the pool (12.8%) is secured by 590 Madison Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 86%. The major tenants included IBM (11.70%) and Crowell & Moring (9.67%). The second largest loan of the pool (9.0%) is secured by South Plains Mall located in metropolitan area. Occupancy at the subject was 79%. The major tenants included Dillard's (22.50%) and JC Penney (17.73%). The third largest loan of the pool (7.9%) is secured by Westin Boston Waterfront located in Boston, MA metropolitan area. Occupancy at the subject was 19%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 78 months as of 04/10/2022, respectively. There are a total of 39 loans and 48 properties in the portfolio. The appraisal LTV was approximately 63.0% compared to the Original loan to value (LTV), which was approximately 57.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.78x. 

Type Concentration









EJR's Key Rating Features & Differences Compared With Other NRSROs
