## Transaction Summary

The transaction closed on Nov 30 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$1003.0 million compared to \$1028.9 million at close.

The largest loan of the pool (10.0%) is secured by AMA Plaza - Pooled located in metropolitan area. Occupancy at the subject was 99%. The major tenants included American Medical Association (25.86%) and Latham & Watkins (12.82%). The second largest loan of the pool (10.1%) is secured by AMA Plaza - Non-Pooled located in metropolitan area. Occupancy at the subject was 99%. The major tenants included American Medical Association (25.86%) and Latham & Watkins (12.82%). The third largest loan of the pool (7.5%) is secured by 540 West Madison - Pooled located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Bank of America (32.40%) and DRW Investments (11.77%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.80% and 50 months as of 12/10/2020, respectively. There are a total of 33 loans and 95 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 52.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 3.52x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

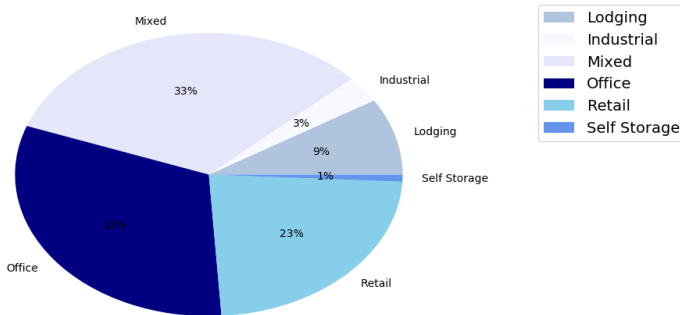

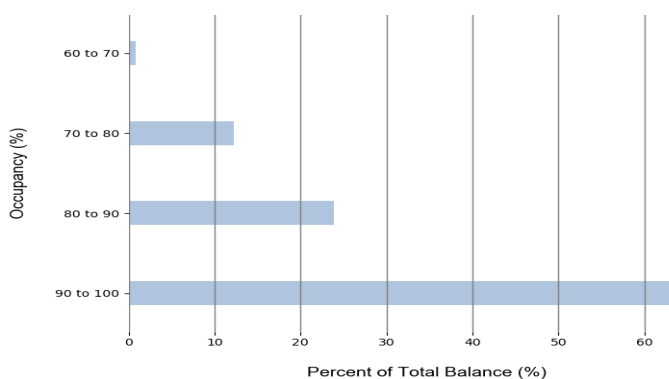

Occupancy Distribution (%)

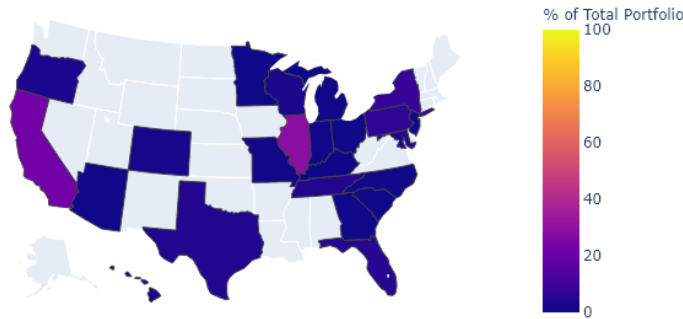

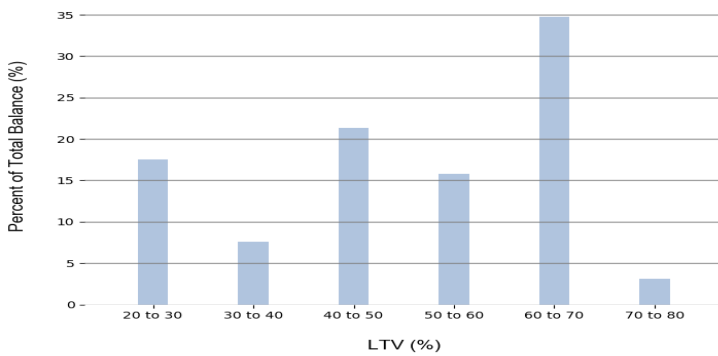
Local Distribution

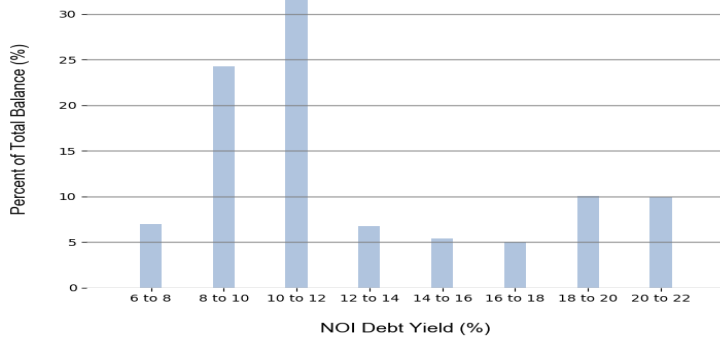

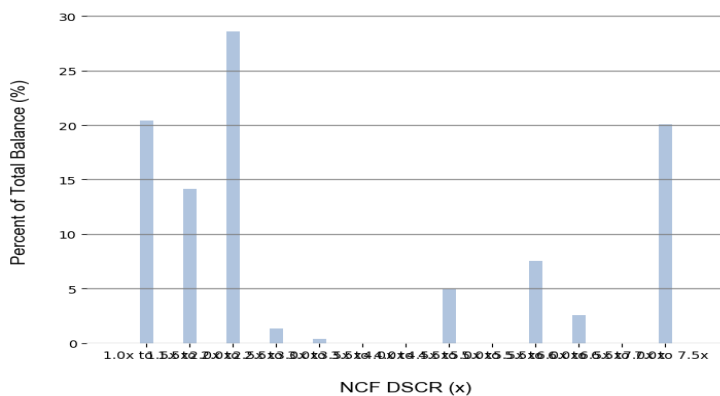
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 12.9%. NOI debt yield ranged from 6% to 21%. There were 1 assets (7% of total balance) with NOI debt yield between 6% and 8%, 11 assets (24% of total balance) with NOI debt yield between 8% and 10%, 11 assets (32% of total balance) with NOI debt yield between 10% and 12%, 2 assets (7% of total balance) with NOI debt yield between 12% and 14%, 4 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (5% of total balance) with NOI debt yield between 16% and 18%, 2 assets (10% of total balance) with NOI debt yield between 18% and 20% and 1 assets (10% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

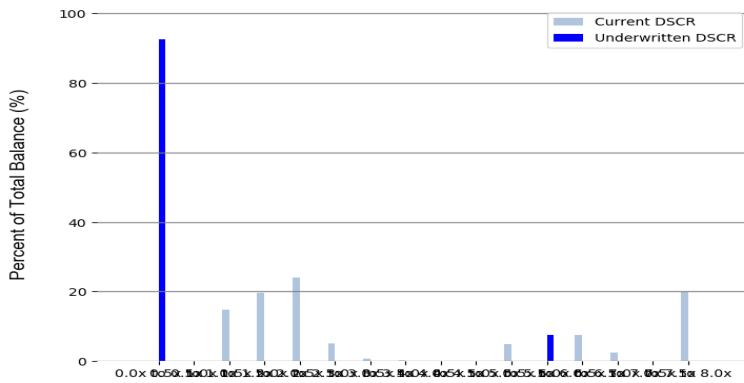


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 7.0x. There were 9 assets (20.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 5 assets (14.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (28.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (1.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (5.0% of total balance) with NCF DSCR between 4.5x and 5.0x, 1 assets (7.5% of total balance) with NCF DSCR between 5.5x and 6.0x, 1 assets (2.6% of total balance) with NCF DSCR between 6.0x and 6.5x and 2 assets (20.1% of total balance) with NCF DSCR between 7.0x and 7.5x. 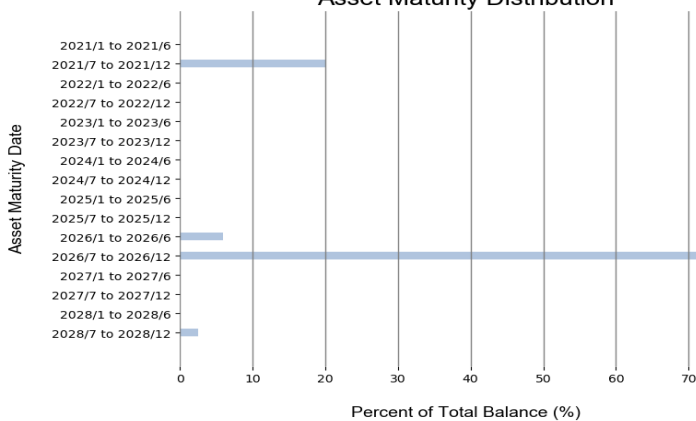
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 8.0x. There are 5 assets (14.9% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (19.7% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (24.2% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (5.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (5.0% of total balance) with DSCR between 5.0x and 5.5x, 1 assets (7.5% of total balance) with DSCR between 6.0x and 6.5x, 1 assets (2.6% of total balance) with DSCR between 6.5x and 7.0x and 2 assets (20.1% of total balance) with DSCR between 7.5x and 8.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
