Transaction Summary

The transaction closed on Nov 30 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$1003.0 million compared to \$1028.9 million at close.

The largest loan of the pool (10.0%) is secured by AMA Plaza - Pooled located in metropolitan area. Occupancy at the subject was 99%. The major tenants included American Medical Association (25.86%) and Latham & Watkins (12.82%). The second largest loan of the pool (10.1%) is secured by AMA Plaza - Non-Pooled located in metropolitan area. Occupancy at the subject was 99%. The major tenants included American Medical Association (25.86%) and Latham & Occupancy at the subject was 99%. The major tenants included American Medical Association (25.86%) and Latham & Watkins (12.82%). The third largest loan of the pool (7.5%) is secured by 540 West Madison - Pooled located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Bank of America (32.40%) and DRW Investments (11.77%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.80% and 50 months as of 12/10/2020, respectively. There are a total of 33 loans and 95 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 52.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 3.52x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.



Type Concentration













Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 12.9%. NOI debt yield ranged from 6% to 21%. 



EJR's Key Rating Features & Differences Compared With Other NRSROs
