## **Transaction Summary**

The transaction closed on Nov 30 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$777.1 million compared to \$813.3 million at close.

The largest loan of the pool (9.7%) is secured by 540 West Madison - Pooled located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Bank of America (32.40%) and DRW Investments (11.77%). The second largest loan of the pool (9.4%) is secured by U.S. Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-22.83% Detroit-Dearborn-Livonia, MI-4.59% Warren-Troy-Farmington Hills, MI-3.70% Fort Worth-Arlington, TX-1.89% Camden, NJ-1.63% metropolitan area. Occupancy at the subject was 99%. The major tenants included New WinCup Holdings Inc. (8.61%) and Tri-Seal OpCo LLC (6.95%). The third largest loan of the pool (9.0%) is secured by Quad at Whittier located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 88%. The major tenants included Burlington Coat Factory (20.17%) and Vallarta Supermarkets (9.23%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.98% and 66 months as of 04/10/2022, respectively. There are a total of 30 loans and 92 properties in the portfolio. The appraisal LTV was approximately 64.6% compared to the Original loan to value (LTV), which was approximately 56.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.41x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





## Occupancy Distribution (%)




#### Local Distribution









DSCRs ranged from 0.0x to 7.5x. There are 2 assets (6.0% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (11.2% of total balance) with DSCR between 0.5x and 1.0x, 2 assets (8.4% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (27.0% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (7.5% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (19.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.3% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (6.4% of total balance) with DSCR between 5.0x and 5.5x, 1 assets (9.7% of total balance) with DSCR between 6.0x and 6.5x and 1 assets (3.3% of total balance) with DSCR between 7.0x and 7.5x. The most recent weighted average DSCR is 2.6x.

There are 2 assets (57.5% of total balance) that have maturity dates between 2026/1 and 2026/6, 27 assets (694.0% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (25.6% of total balance) that have maturity dates between 2028/7 and 2028/12.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
