Transaction Summary

The transaction closed on Mar 21 2017 and matures in Mar 2027. The pool's current aggregate principal balance is \$1051.8 million compared to \$1062.6 million at close.

The largest loan of the pool (9.5%) is secured by 350 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 64%. The major tenants included Ziff Brothers Investments, L.L.C. (50.29%) and Manufacturers & Traders Trust Company (17.98%). The second largest loan of the pool (7.8%) is secured by Lafayette Centre located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 92%. The major tenants included COMMODITY FUTURE TRADING (36.43%) and MEDSTAR HEALTH (14.15%). The third largest loan of the pool (7.0%) is secured by U.S. Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-22.50% Warren-Troy-Farmington Hills, MI-4.61% Detroit-Dearborn-Livonia, MI-4.52% Fort Worth-Arlington, TX-1.87% Camden, NJ-1.61% metropolitan area. Occupancy at the subject was 100%. The major tenants included NEW WINCUP HOLDINGS INC (8.61%) and New WinCup Holdings Inc. (8.61%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.39% and 45 months as of 10/10/2020, respectively. There are a total of 32 loans and 72 properties in the portfolio. The appraisal LTV was approximately 56.2% compared to the Original loan to value (LTV), which was approximately 57.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.38x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

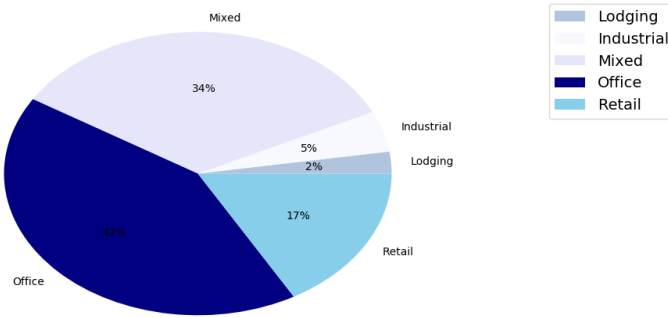

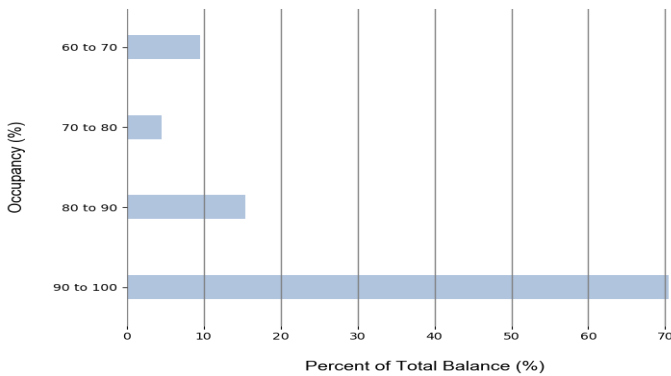

Occupancy Distribution (%)

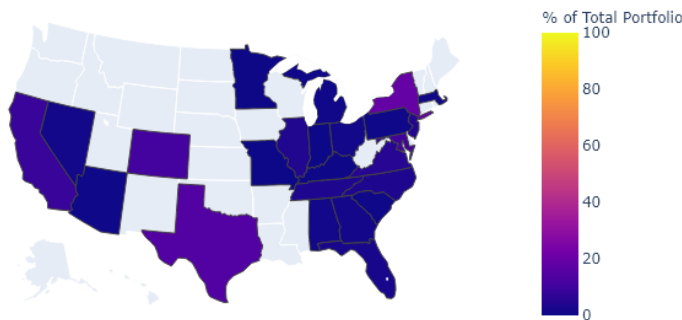

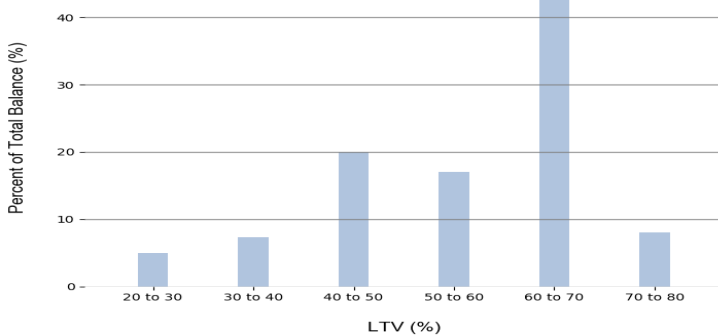
Local Distribution

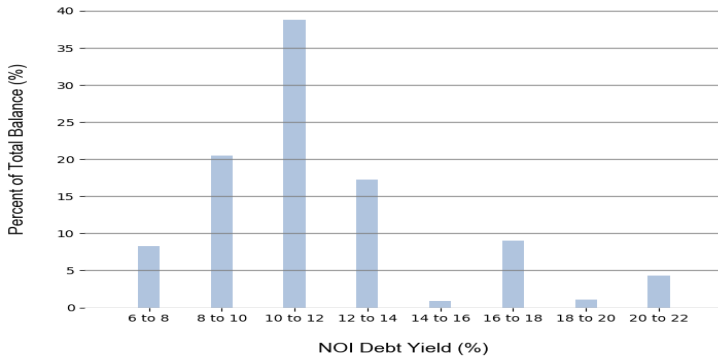

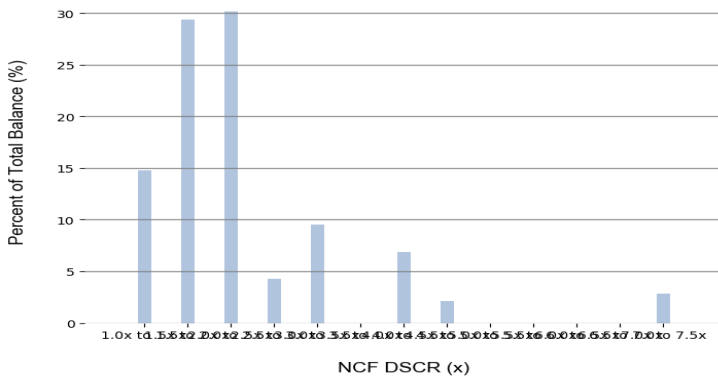
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 11.4%. NOI debt yield ranged from 6% to 21%. There were 2 assets (8% of total balance) with NOI debt yield between 6% and 8%, 8 assets (20% of total balance) with NOI debt yield between 8% and 10%, 10 assets (39% of total balance) with NOI debt yield between 10% and 12%, 6 assets (17% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16%, 2 assets (9% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20% and 2 assets (4% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

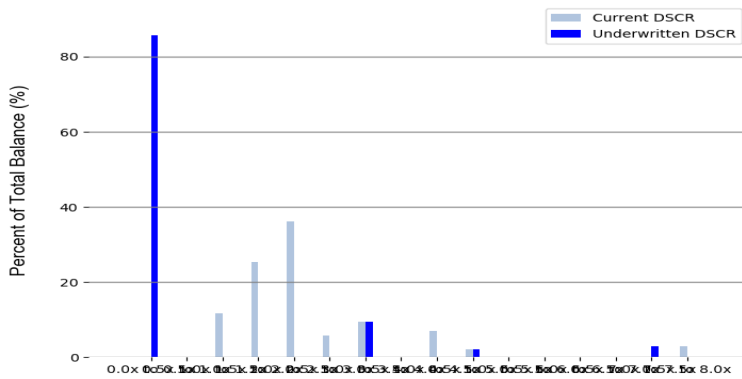


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 7.0x. There were 7 assets (14.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (29.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (30.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (4.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (9.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (6.9% of total balance) with NCF DSCR between 4.0x and 4.5x, 1 assets (2.1% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (2.9% of total balance) with NCF DSCR between 7.0x and 7.5x. 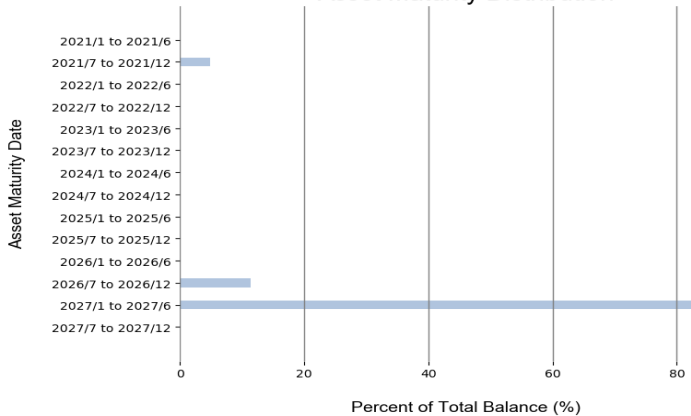
DSCR Distribution (x)



DSCRs ranged from 1.0x to 8.0x. There are 5 assets (11.7% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (25.2% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (36.1% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (5.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (6.9% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (2.1% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.9% of total balance) with DSCR between 7.5x and 8.0x. The most recent weighted average DSCR is 2.5x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
