Transaction Summary

The transaction closed on May 31 2017 and matures in May 2027. The pool's current aggregate principal balance is \$938.7 million compared to \$953.8 million at close.

The largest loan of the pool (10.2%) is secured by 1999 Avenue of the Stars - Trust located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included O'Melveny & Myers (7.95%) and Akin Gump Strauss Hauer & Feld LLP (5.91%). The second largest loan of the pool (8.5%) is secured by Lafayette Centre located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 82%. The major tenants included COMMODITY FUTURE TRADIN (36.43%) and MEDSTAR HEALTH (14.15%). The third largest loan of the pool (8.5%) is secured by Pentagon Center located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included GSA DoD Pentagon II Taylor (61.22%) and GSA DoD Pentagon I Polk (38.78%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 60 months as of 03/10/2022, respectively. There are a total of 32 loans and 70 properties in the portfolio. The appraisal LTV was approximately 56.3% compared to the Original loan to value (LTV), which was approximately 57.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.36x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.

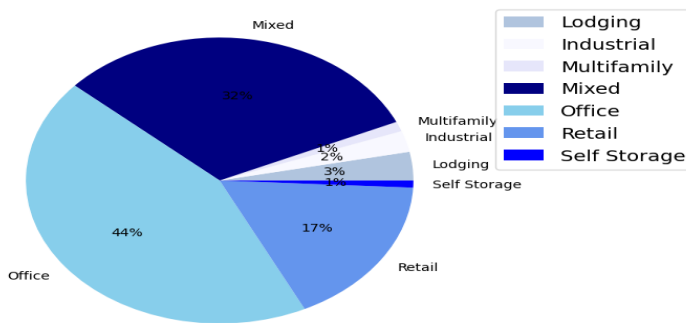

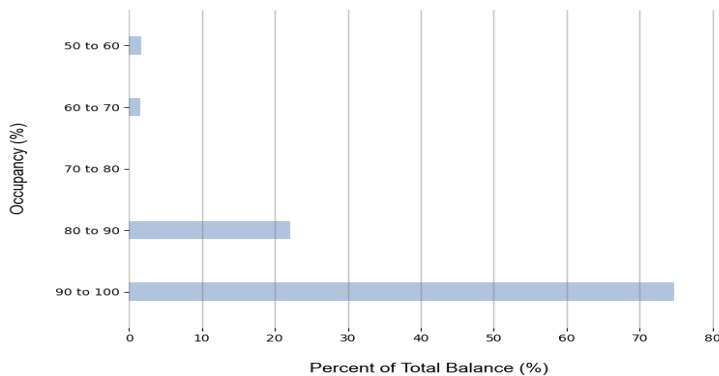

Occupancy Distribution (%)

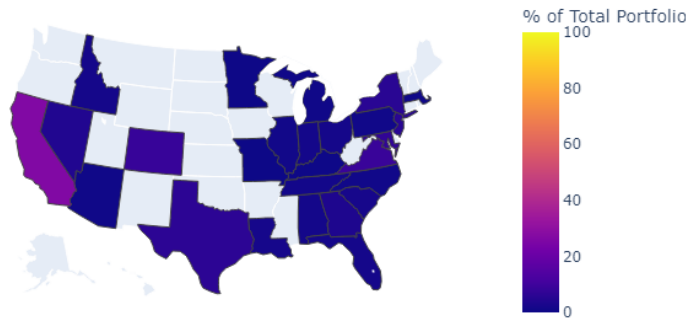

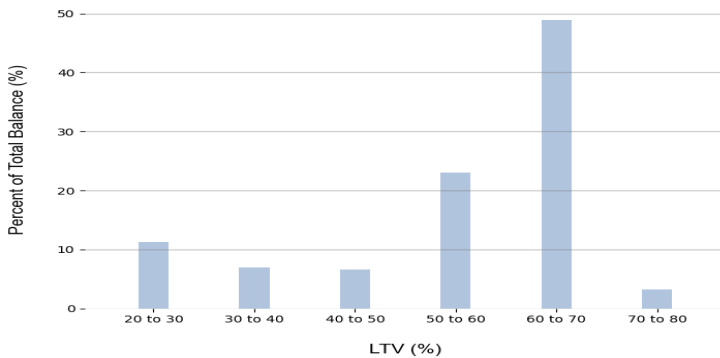
Local Distribution

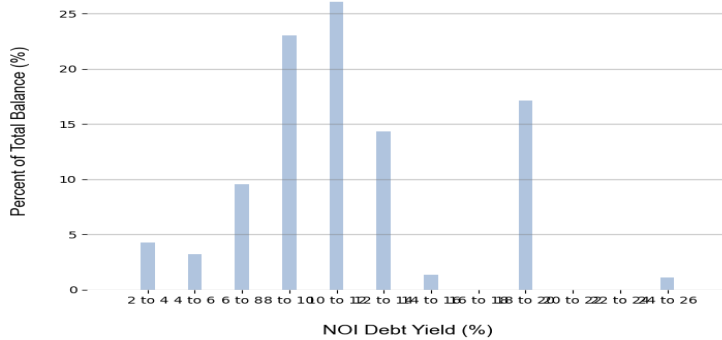

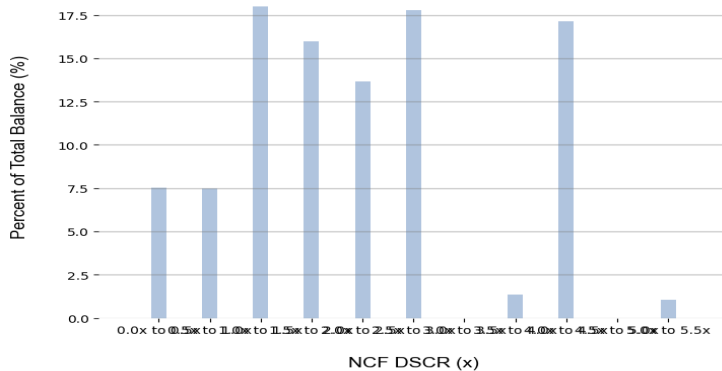
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

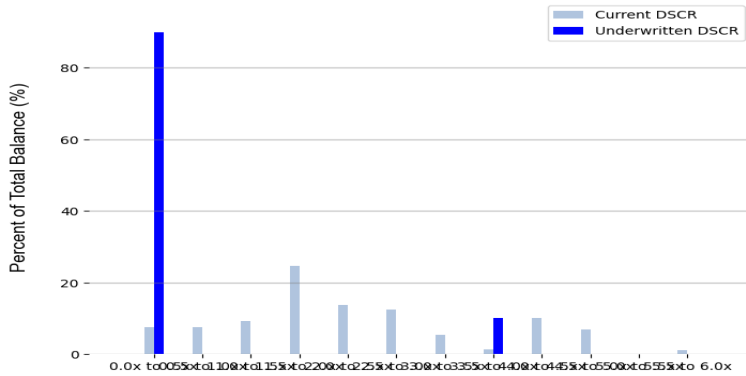

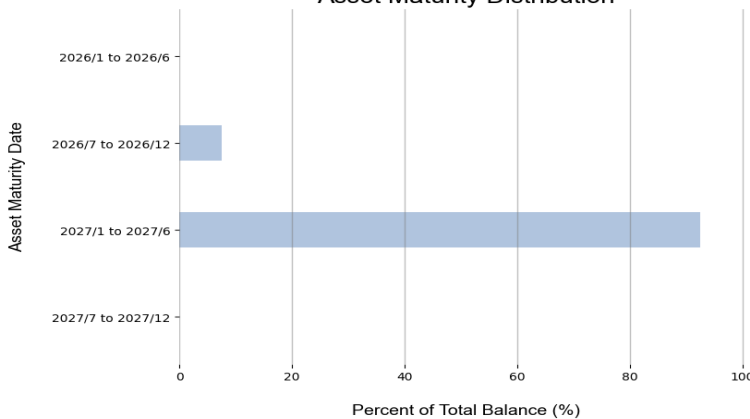
DSCR Distribution (x)

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
