# **Transaction Summary**

The transaction closed on Feb 27 2019 and matures in Jan 2034. The pool's current aggregate principal balance is \$753.5 million compared to \$756.7 million at close.

The largest loan of the pool (8.6%) is secured by 365 Bond located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The second largest loan of the pool (6.9%) is secured by Torrance Towne Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Kohl's Department Store (36.04%) and Smart & Final Stores (7.91%). The third largest loan of the pool (6.6%) is secured by Pace Gallery HQ located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was PACE (100.59%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.86% and 24 months as of 12/10/2020, respectively. There are a total of 36 loans and 53 properties in the portfolio. The appraisal LTV was approximately 55.7% compared to the Original loan to value (LTV), which was approximately 55.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.12x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 19% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 4% to 19%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 2 assets (1% of total balance) with NOI debt yield between 6% and 8%, 13 assets (32% of total balance) with NOI debt yield between 8% and 10%, 15 assets (45% of total balance) with NOI debt yield between 10% and 12%, 3 assets (9% of total balance) with NOI debt yield between 12% and 14%, 1 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (5% of total balance) with NOI debt yield between 18% and 20%

There were 4 assets (12.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (10.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (29.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (25.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (17.2% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (5.5% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 2.1x.







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
