Transaction Summary

The transaction closed on May 23 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$798.7 million compared to \$802.8 million at close.

The largest loan of the pool (9.7%) is secured by 101 California Street - Trust located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 97%. The major tenants included Merrill Lynch (9.75%) and Cooley LLP (8.97%). The second largest loan of the pool (9.4%) is secured by 59 Maiden Lane located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The major tenants included DCAS MASTER (31.40%) and DCAS DOF (29.17%). The third largest loan of the pool (8.1%) is secured by Moffett Towers II Building V - Trust located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Facebook (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.65% and 20 months as of 12/10/2020, respectively. There are a total of 36 loans and 64 properties in the portfolio. The appraisal LTV was approximately 56.4% compared to the Original loan to value (LTV), which was approximately 55.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.94x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 96%.

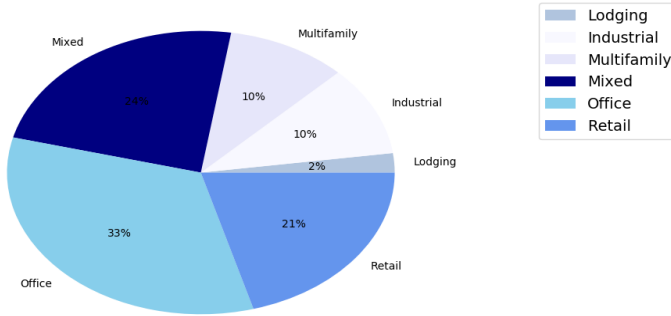

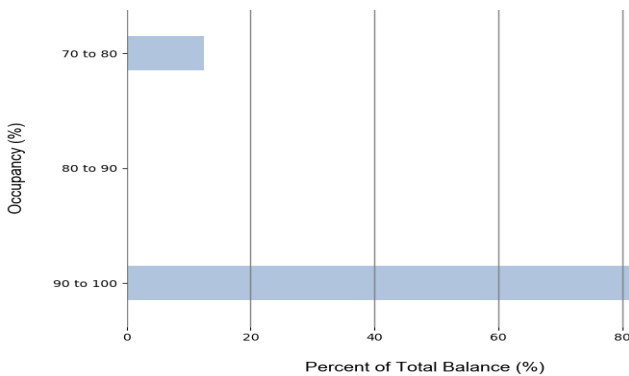

Occupancy Distribution (%)

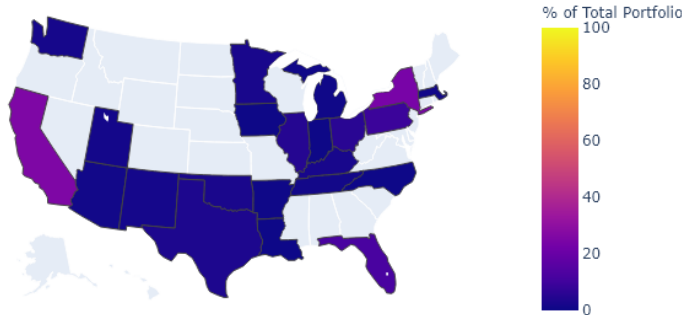

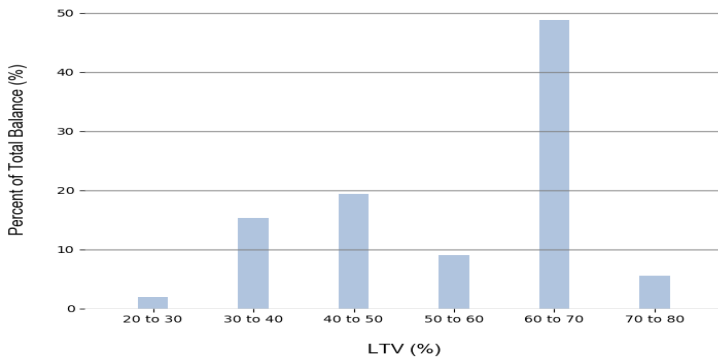
Local Distribution

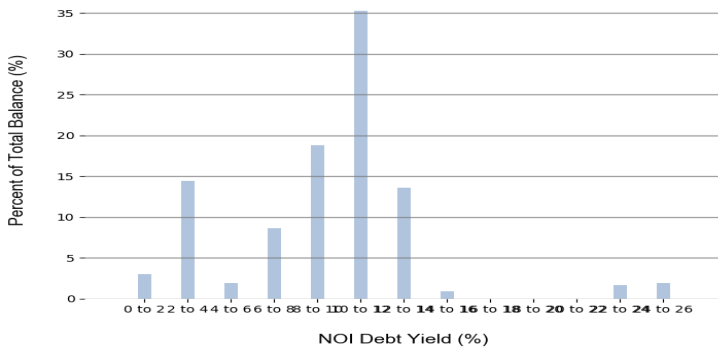

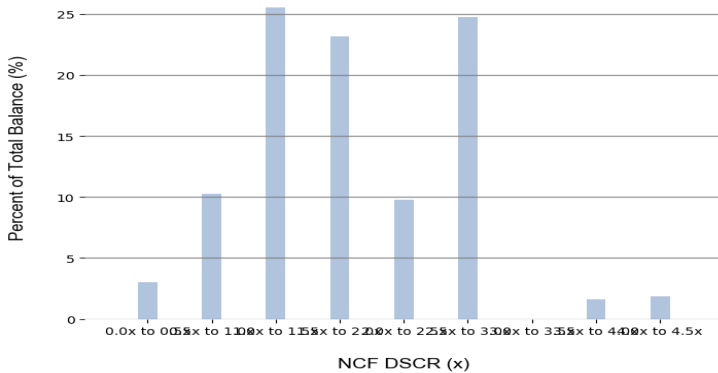
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

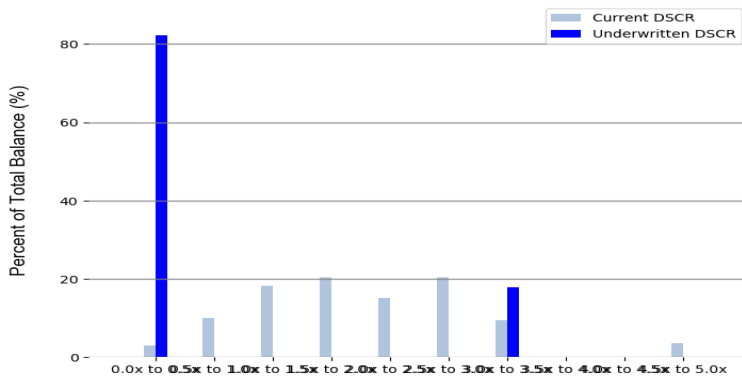

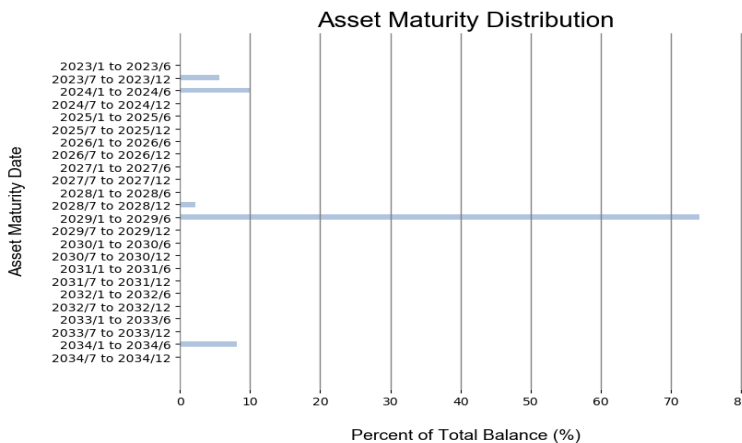

There are 1 assets (3.0% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (10.0% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (18.3% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (20.3% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (15.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (20.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (9.4% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (3.5% of total balance) with DSCR between 4.5x and 5.0x. There are 1 assets (5.6% of total balance) that have maturity dates between 2023/7 and 2023/12, 3 assets (10.0% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (2.2% of total balance) that have maturity dates between 2028/7 and 2028/12, 30 assets (74.0% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (8.1% of total balance) that have maturity dates between 2034/1 and 2034/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
