Transaction Summary

The transaction closed on Sep 27 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$1057.8 million compared to \$1060.4 million at close.

The largest loan of the pool (6.2%) is secured by Moffett Towers II Buildings 3 & 4 - Trust located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Facebook (100.00%). The second largest loan of the pool (6.2%) is secured by Northpoint Tower located in metropolitan area. Occupancy at the subject was 79%. The major tenants included Jones Day (39.23%) and United States Government (9.06%). The third largest loan of the pool (6.1%) is secured by 2 Cooper located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.76% and 16 months as of 12/10/2020, respectively. There are a total of 36 loans and 102 properties in the portfolio. The appraisal LTV was approximately 58.9% compared to the Original loan to value (LTV), which was approximately 58.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.83x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 96%.





Occupancy Distribution (%)




Local Distribution




NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from 2% to 19%. There were 1 assets (3% of total balance) with NOI debt yield between 2% and 4%, 7 assets (19% of total balance) with NOI debt yield between 6% and 8%, 14 assets (40% of total balance) with NOI debt yield between 8% and 10%, 6 assets (11% of total balance) with NOI debt yield between 10% and 12%, 6 assets (17% of total balance) with NOI debt yield between 15% and 14%, 1 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (5% of total balance) with NOI debt yield between 18% and 20%

NCF DSCR ranged from 0.0x to 7.0x. There were 14 assets (41.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (3.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 5 assets (7.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (22.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (9.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (11.5% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with NCF DSCR between 7.0x and 7.5x. The most recent weighted average NCF DSCR was 2.8x.




DSCR (Current / Underwritten)



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
