## **Transaction Summary**

The transaction closed on Nov 08 2019 and matures in Nov 2029. The pool's current aggregate principal balance is \$861.9 million compared to \$864.4 million at close.

The largest loan of the pool (5.8%) is secured by SoCal Retail Portfolio located in Los Angeles-Long Beach-Glendale, CA-60.66% metropolitan area. Occupancy at the subject was 99%. The major tenants included Home Depot (10.10%) and Target (9.05%). The second largest loan of the pool (5.8%) is secured by One and Olney Shopping Center located in Philadelphia, PA metropolitan area. Occupancy at the subject was 98%. The major tenants included Wakefern Food Corp #537 (19.76%) and OL Hair Buzz Inc. (8.60%). The third largest loan of the pool (5.8%) is secured by 1950-2000 Alameda de las Pulgas located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included County of San Mateo (60.07%) and Edgewood Partner insurance (11.25%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.82% and 15 months as of 12/10/2020, respectively. There are a total of 49 loans and 97 properties in the portfolio. The appraisal LTV was approximately 63.0% compared to the Original loan to value (LTV), which was approximately 61.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.31x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.



Type Concentration









Among assets in the portfolio, there are 20 properties (23% of total balance) located in California, 7 properties (14% of total balance) in New Jersey, 8 properties (12% of total balance) in Texas, 13 properties (9% of total balance) in New York, 5 properties (8% of total balance) in Pennsylvania, 5 properties (8% of total balance) in Pennsylvania, 5 properties (5% of total balance) in Florida and 1 property (4% of total balance) in Illinois. 



Most recent net operating income debt yield ranged from 2% to 19% with a weighted average NOI debt yield of 9.6%. NOI debt yield ranged from 2% to 19%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 2 assets (5% of total balance) with NOI debt yield between 4% and 6%, 14 assets (29% of total balance) with NOI debt yield between 6% and 8%, 17 assets (37% of total balance) with NOI debt yield between 8% and 10%, 6 assets (11% of total balance) with NOI debt yield between 10% and 12%, 3 assets (9% of total balance) with NOI debt yield between 12% and 14%, 4 assets (5% of total balance) with NOI debt yield between 14% and 16%, 2 assets (4% of total balance) with NOI debt yield between 18% and 20%



There were 23 assets (49.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (4.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (15.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (18.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (6.7% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (4.2% of total balance) with NCF DSCR between 3.5x and 1 assets (3.0% of total balance) with NCF DSCR between 3.5x and 4.0x. DSCR (Current / Underwritten)



DSCRs ranged from 3.0x to 4.5x. There are 1 assets (3.2% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (4.2% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (3.0% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.5x. Underwritten DSCR is not available.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
